Q. How soon after you arrived did he die?

DEFENDANT'S COUNSEL: I move to strike out "breathing his last".

THE COURT: Wait a moment. That time did you arrive there?

THE WITNESS: I could not exactly recollect, the exact time, but it was around half past seven; between half past seven and a quarter to eight.

THE COURT: The question is allowed.

DEFENDANT'S COUNSEL: The question, but he was asked the question and he made two answers.

(Question and answer repeated by the stenographer as follows: "Q. At the time you arrived there was he alive? A Yes sir, breathing his last".)

THE COURT: You may strike that out "he was breathing his last."

Q Well, did he die after you arrived or not? A Yes, sir, after I arrived he died.

Q How long after you arrived? A Well, I should imagine about five to ten minutes, not longer.

Q Did you make an examination of him at that time?

A I did, sir.

Q A little louder? A The man was in bed in a comatose condition. He was breathing stertorously and his pulse was almost gone. I examined his head and I saw a lump, but I cannot swear if it was on the left or right side, sir; I cannot swear to that.

Q You saw a lump? A A lump, but my memory escapes me whether it was on the right or laft side

Q I see. No matter whether it was on the right or left side, about what was the location? A It was between, I imagine, between the temples and the frontal bone, right here (indicating.)

Q Did you find anything else the matter with him?

A No, sir.

Q How large was that lump that you have referred to?

A I should imagine sir --

THE COURT: Not what you imagine.

A (Continued) Well about the size of a small orange.

I think the circumference of a small orange, but raised very slightly, about a quarter of an inch raise above the surface of the skin.

CROSS EXAMINATION BY DEFENDANT'S COUNSEL:

Q Doctor, if you please, tell me just where that lump

that you found was located. I do not mean what side of the head, but whereabouts on the head? A I cannot swear it was on the left or right side, but I know it was about right here (indicating) where the temple and frontal bone meet, up here.

BY THE COIRT:

Q Doctor, to the best of your recollection, tell us concerning which side it was? A Tt was, I think, your Honor, the right side, because he was lying this way (indicating) and I was on his right side, and in my imagination it was ---

Q You tell us why, but you are not giving us your recollection. A How can I give a recollection --

THE COURT: Strike that all out.

The Court thereupon admonished the jury in accordance with section 415 of the Code of criminal Procedure and adjourned until Friday, May 13th, at half past ten A. M. THE COURT: Bail continued.

TRIAL RESUMED.

TIMOTHY D. LEHANE, M.D., a witness recalled on behalf of the People, bestified as follows:

DIRECT EXAMINATION BY MR. BUCKNER:

Q Doctor, I want to know as a medical proposition, assuming that a man at the corner of 158th street and Ferrest avenue, in the Bronx, received a blow on the side of his head which fractured his skull, if it would be possible for him to go in that condition to East 117th street and die three hours after the injury was received?

MR. MURPHY: If the Court please, I object to the question, on the ground that it assumes facts absolutely which have not been proven at this trial.

THE COURT: Yes. There is no evidence that I know of that the man was struck on the side of the head.

MR. BUCKNER: Yes, if the court please.

THE COURT: Well, if you find that, all right; the hypothetical question must be asked, if asked at all, upon matters which were brought out in the evidence and then when they are brought out, the question is, assuming them to be true.

MR BUCKNER: Yes, simply assuming them to be true.

THE COURT: Now, if you find in the evidence enything

MR. BUCKNER: The witness Savino said he struck him on the head.

THE COURT: No. The evidence as I recall it was that this defendant held the decedent with his left hand back of his neck on his collar and with the right struck him.

MR. BUCKNER: But the witness --

THE COURT: He held him before him with his left hand and struck him with his right.

MR. BUCKNER: But the witness said that he saw him strick him on the head.

THE COURT? Well then, what right have you to assume that he struck him on the right of the head or on the left either?

MR. BUCKNER: Then the evidence of the barber, for what it is worth, as to the confusion on the side of the man's head, but this hypothetical question I am only interested in as a general proposition on the fracture of the skull.

THE COURT: Well, the Court will not allow it.

There is also too much speculation in it.

MR. BUCKNER: Well, I will modify the question.

Q noctor, is it possible for a man who has been struck

on the head with force enough to fracture his skull to walk or to go from 158th street and Forrest avenue to 117th street?

Objected to. Objection sustained.

MR. BUCKNER: That is all.

THE COURT: That is altogether too speculative.

MATTEO GIAMATASSEO, being called as a witness on behalf of the People, testified through official
interpreter Deville as follows:

on, there is not any evidence here that he walked from the place where he was struck to his home. Let that go in as part of the Court's ruling upon the question. There is some evidence that he went away, but that he walked or rode or how he went away, there is no evidence at all as to that.

DIRECT EXAMINATION BY MR. BUCKNER:

- Q Where do you live? A 445 Willis avenue, Bronx.
- Q Did you know in his lifetime Sabato Basso? A Yes, sir.
- Q How long had you known him before his death? A Six or seven years.
 - Q Did you see him on June 28, 1909? A Yes, sir.
 - Q Where did you see him? A At 158th street and Forrest

- Q In what place? A At the bowling alleys
- Q In what place of business? A It is a saloon and dancing hall and bowling alleys combined.
- Q What is the name of the proprietor of the saloon?

 A I don't know the name.
- Q Well, how long did Basso, or did Basso work in this saloon? A Yes sir.
- Q How long had he worked there, if you know?

 A Between eight and nine months.
 - Q How is that? A Between eight and nine months.
 - Q What did he do there? A He was cleaner.
 - Q What were you doing there on June 28, 1909?
- A I was there to help out Bassao, Sabato.
 - Q Did you help him out? A Yes, sir.
- Q Well, what happened there in the afternoon, if anything?

 A Sabato Basso, the decedent went downstairs to get two
 glasses of beer from the bartender. The bartender refused
 to give them to him.

MR. MURPHY: If the Court please I object to any questions or answers which may bring in any matters which occurred in this place prior to the appearance of the defendant.

THE COURT: Yes, as to that, objection sustained. You had better direct the attention of the witness to

Q Now, coming down to the time when you say the defendant Kelly --

MR. BUCKNER: Question withdrawn.

- Q Did you see this man Kelly that day? A Yes.

- Q All right. Now, beginning right there, where did he place the deceased under arrest? A We went up to the station to purchase tickets on our way home, and he arrested us at the station.
- Q What did he do with you after he arrested you?

 A He brought us back to the saloon.
- Q What then happened? A He broughtus back there and he asked some one, he asked the bartender to point out the man who had caused the disturbance.
- Q Then what happened? A They left me downstairs in the saloon proper and they took the deceased upstairs.
 - Q Who took him up? A One flight up.
- Q Who took him upstairs? A The officer, the bartender and the proprietor of the premises.

THE COURT: Objection overruled.

Q Answer the question. A The first thing I saw was the officer holding the deceased by the arm.

Q And where was he holding him by the arm? A Near the partition on the landing of the stairs. He was holding him against the partition in order to enable the ---

THE COURT: Strike that out. Beyond that you must not go.

Q Did you see the officer and Basso come down the first flight of stairs?

THE COURT: Objection sustained. Try and get your information without leading.

Q State what you saw if anything on the first flight of stairs, before you speak of the landing?

MR. MURPHY: If the Court please I object to that question, because he says the first thing he saw was on the landing.

THE COURT: Objection overruled. Proceed.

MR. MURPHY: Let us find out if it was --

THE COURT: There is no use arguing the question.

Q Where is the barber shop kept by Raffaele John Cristiana, if you know? A Yes, I know.

Q Where is it? A Adjoining the barroom premises

Q In what direction? A The barshop is on the avenue, and it is in the direction of Jackson avenue.

Q Do you know whether it is north, east, south or west?

MR. MURPHY: I object to the question, because he

THE COURT: Objection overruled.

Q Do you know if the barber shop is north, east, south or west of the saloon? A No.

Q If this is 158th street (indicating) if this is Forrest avenue, if this is the saloon on the corner, which side of the saloon is the barber shop? A On this side, next to the saloon (indicating).

Q Is it toward the direction of 157th street or away from it?

THE COURT: Or 158th.

Q (Continuing) Or 156th.

MR. BUCKNER: Yes, all right.

A Towards 157th street.

MR. BUCKNER: All right. Cross examine.

Q Mr Giamatasseo, when you left the saloon with the dedeased Basso, you and he walked together and talked together?

A Yes, sir.

Q You were employed by Basso, not by Mr Stillwager? A

Q Now, when you were left in the saloon by the police officer, just about where did you remain standing? A In the middle of the bar room.

Q Were you standing near the bar? A No, I was rather in the middle of the floor.

Q Were there any tables in that bar room at that time?

A Yes, there were tables on the floor.

Q How many were in the bar room, if you know? A I don't know.

Q Were you standing near a table? A I stood still tight in the middle of the floor.

Q And remained standing there all the time, still in the middle of the floor? A I was standing there up to the time they began assaulting the deceased.

MR MURPHY: I move to strike out the assault part .

MR BUCKNER: Consented to.

THE COURT: Strike it out.

Q Das you see the barber in the salcon? A Yes, he

Q Were you standing near the barber at the time these people went upstairs? A Yes, sir.

Q Now, who stood nearer to the door which led to the hall going upstairs, you or he barber? A We were both in almost the same spot.

Q And the first thing that you saw after the officer, the defendant Kelly here, the deceased Basso, the bar tender, and Mr Stillwagen left the salcon to go upsyairs, was what you have described as taking place on the landing, is that right?

A Yes, that is --

Q Yes or no? A Yes, but I had seen also -MR MURPHY: Now, one minute.

THE INTERPRETERP I think I have to give that.

MR BUCKNER: Yes.

A (Continuing) I have have seen something here which occurred previous to that, when the deceased was assaulted downstairs in the kitchen.

MR MURPHY: Now, we will strike that part out?

MR BUCKNER: Consented to.

BY THE COURT:

Q When you went out of the barber shop, I mean out of the saloon, had Basso gone out? A Yes, he had gone out through the other door.

Q When you left the saloon after the Basse per had left it, was the barber still in the saloon? A Yes, the barber.

Q You left the barber in the saloon? A The barber had

Q Now then, you say that you went with Passo some distance?

A Yes, up to 145th street.

- Q How far did you go? A To 145th street.
- Q From what street? A From Forrest avenue, where we started, up to 145th street and Willis avenue.
- Q What time elapsed between your going out of the saloon and your starting away with Basso to walk? A About 10 minutes or 15 minutes.
- Q Where did you spend the ten or fifteen minutes between the time you came out of the saloon and the starting away of the two of you, on your walk? A No, I did not make myself understood. THE DEFENSE.

Mr Murphy thereupon opened the case on behalf of the Defense.

LOUIS CALVOR, being called and duly sworn as a witness on behalf of the Defense, testified as follows:
DIRECT EXAMINATION BY MR MURPHY:

- Q Mr Calvor, where do you live? A 770 Tinton avenue.
- Q Mr Calvor, what is your business? A Bar tender.

- Q Now, Mr Calvor, have you visited the saloon of Mr Stillwagen very frequently? A Yes, sir.
- Q Addhad you done so prior to the 28th day of June, 1909? A I don't understand.
 - Q Had you visited these premises many times prior to the 28th day of June, 1909? A Yes, sir.
 - Q And have you visited those premises since? A Yes,

sir.

Q Do you know the location of, or whether or not there are doors leading from the bar room upsairs? A Yes, sir.

Q Would you give us a sort of description of the location of these doors? A Yes, sir.

Q Will you please do so? A The bar room is about, say 20 or 25 feet long, and to the best of my knowledge about 12 or 15 feet wide, and the end of this bar room, the house is divided, half on the right, standing with the back towards Forrest avenue, half of this leads to the rear of the building; the other half is closed with two doors into the hallumy on one side, and on the other side it leads down to the kitchen. That is another part altogether, though. There is two doors leading in from this open space into the hallway, one directly out of the bar room and one at the side part of the bar room, which is notexactly the bar room any more. It is only a passage from the bar room to the rear apartments, the dancing hall, the bowling alleys, and so forth.

Q Mr Calvor, a person standing near the bar, could be see the second door you have described, which leads from the part in the rear to this hall, going upstairs? A Standing near the bar?

- Q The second door? A No, sir.
- Q Now, what door could a person see standing in the bar room, near the bar? A The one that leads directly out of

Q Now, that door, which way does it swing, does it swing in the hall, or out towards the bar? A Into the bar room.

THE 5TH JUROR: Let him draw a diagram of that?

Your Honor, can I say a word? I cannot follow that witness. I would like thim to draw a diagram of hese doors and everything. I cannot follow that.

THE COURT: All right, if he can draw one. (The witness proceeds to mark on paper)

THE COURT: Now, Counselor, whatever suggestion you may have to make, or directions in the drawing, I wish you would come up here and supervise it.

(The witness makes a drawing)

BY MR MURPHY:

Q Now, Mr Calvor, you have drawn, as near as you can recollect a diagram of the bar, the wallway leading upstairs, the door entering the hallway to the stairs and the landing, is that right? A Yes, sir.

Q That is what you have on that paper there? A Yes, sir.

MR MURPHY: Now, if the jury wants to see it, we have no objections to that.

MR BUCKNER: The usual form is to offer it in evidence.

MR MURPHY? I will offer this in evidence, if the

Court please, as a sort of descriptive diagram of the lo-

nunging C

MR BUCKNER: No objection.

Marked in evidence as Defendant's Exhibit B.

MR MURPHY: Of course, with the understanding that it is not a correct diagram of the place.

THE COURT: You know what that diagram means. Try
and explain it to the jury now, that is, holding it in their
presence as much as possible, and you had better come
around to this table here and hold it before the jury as
well as possible.

MR MURPHY: (Indicating on Defendant's Exhibit B)

This is to represent 158th street; this is Forrest avenue, the compass pointing north this way. The entrance to the saloon, which is a corner building, at 158th street and Forrest avenue, is about over here, that is, on the southern end of the store.

THE COURT: Hold it at an angle so that the jury can see it.

MR MURPHY: (Continuing) The entrance to this, to the store on Forrest avenue, the south end of the store is here. This is the saloon proper. The bar is here, and the back bar. This is the bar where you stand and give your order for a drink. At the end of this bar here there is an opening going in back of the bar, and right in front of here is another door.
