A Jury is duly empanelled and sworn.

Mr. Adams opens to the Jury on behalf of the people.

VIOLET PERANO called as a witness on behalf of the people, being first duly sworn, testifies as follows: DIRECT EXAMINATION BY MR. ADAMS:

Q What is your address? A 50 Roosevelt Street.

- Q What are their names? A Joseph Peraneoand Clementina Perano.
 - Q Where were you born? A In Italy--- Europe.
- Q How long have you been in this country? A About eight or nine years.
 - Q How old are you? A Fourteen.
- AQ When were you fourteen? A April 13, 1896.
 BY THE COURT:
- Q 1896? He asked you when you were 13, when were you born? A I was born in 1896.
 - Q You were born April 13, 1896? A Yes sir.
- Q So you were fourteen last April---last month? A
 Yes sir.

BY MR. ADAMS:

- Q Then you were thirteen before last April? A Yes sir.
- Q When did you first see the defendant ? A In June first, the first time.
 - Q June first? A The first time I saw him.
 - Q What year was that --- last year? A In 1909.
 - Q Of course you are not married to him? A No sir.
- Q Where did you see him first? A First I saw him at 33 Roosevelt Street.
 - Q And did you go there with anybody then? A No sir.

BY THE COURT:

Q At 33 Roosevelt Street you first saw him, last June --- the first of June, about? A Yes sir.

BY MR. ADAMS:

- Q How did you happen to go there to Roosevelt Street.

 A I brought a pair of shoes to him?
- Q Did anything happen there then at that time? A No sir:
- Q When did you next see him? A In 80 Catharine Street.

BY THE COURT:

- Q You were asked when --- not where? A About August 5th.
- Q About the 5th of August at 80 Catharine Street? A Yes.

BY MRQ ADAMS:

- Q He had moved to 80 Catharine Street? A Yes sir.
- Q What did you go there for? A I brought.my brother's shoes.
 - Q About what date was that?

THE COURT: Do not repeat unnecessarily. SHe said August 5th. It takes time and you will only make the witness contradict herself. Stand over there please, and talk loud.

Q Who went with you? A When I brought the shoes no

one came with me, but when I went to get them there was my friend Lena Skenelli.

Q Did the defendant here say anything to you when you brought the shoes there? A No sir.

BY THE COURT:

- Q For what purpose did you bring the shoes? A For him to fix.
 - Q To repaired, to mended. A Yes sir.
- Q And you left them there and then you called back for them? A Yes sir.
- Q What happened, if anything, when you called back for them? Now speak out loud and tell the jury? A (No answer) BY MR. ADAMS:
- Q Just tell these gentlemen what happened? A When I went in to get the shoes I met Lena Skenelli first and I told her to come with me and she said "All right;" and we went down to his man shop, and then when I went to get them there was no one there.

BY THE COURT:

Q No one where? A' He was there but there was no company down in the shop.

BY MR. ADAMS:

Q No one but the defendant was there? A Yes sir. And then I told him to let me see the shoes and he said "You can't

- Q Where were you when he came on top of you? A On the couch.
 - Q You were on your back on a couch? A Yes sir.
 - Q And he lay on you? A Yes sir.
 - Q What did he do? A He moved himself up and down.
 - Q Did you feel anything? A Yes sir.
- Q What did you feel, and where? What did he do with his clothes? A When he came on top of me he opened the front part of the pants.
 - Q Did you see any part of his body? A Yes sir.
 - Q Which part? A His private part.
- Q What did he do with his private part? A He took it out and then he came on top of me.
- Q What did he do with his private parts when he came on top of you. A He put it by my private parts.
 - Q By them or into them? A Into them.
 - Q You felt it? A Yes sir.

BY MR. ADAMS:

- Q Did he go inside of you? A Yes sir.
- Q Did he move up and down? A Yes sir.

Q What did you do after that? A After I got up, he got up and I got up and then we went into the other part of the room and I told him to get me the shoes, and I had twenty five cents in my hand to give him for the shoes and I kept the 25 cents.

BY THE COURT:

Q He did give you the shoes? A Yes sir. He gave me the shoes.

BY MR. ADAMS:

Q Where was Lena Skenelli at that time? A When I was in the other part of the room she was sitting in the other part of the room.

BY THE COURT:

- Q That is the room was divided into two parts? A Yes
- Q With what? A With boards and then he had all papers on top of the boards.
- Q How did you get into that back room? Did you jump over the boards? A No sir, there was a space there, and by the space instead of being a door there was a green curtain.
- Q That room of his was divided into two parts, you say, by boards? A Yes sir.
 - Q And in that fence or partition there was a doorway?

A Yes sir.

- Q Or a space rather? A A space.
- Q But there were no boards in that --- there was a green curtain there? A Yes sir.
- And the way you got from the front part to the rear by
 of the shop was pulling aside that curtain and walking in?

 A Yes sir.
- Q In which part was this couch, in the front or rear part? A In the rear part.

BY MR. ADAMS:

- Q What was in this front part? Where was this meant store? Was it in the cellar er upstairs or where? A Down a basement.
- Q What was in the front part of the room? A There was his chair, a stove and his table where he worked at, and there was a window.
- Q Where was this chair that you speak of? A Right by the curtain.
- Q This partition, did it go up to the top of the ceiling or not? A No sir.
- Q What time of the day was this? A In the afternoon, about 3 o'clock.

BY THE COURT:

- Q Do you go to school? A Yes sir.
 - Q What school? A (No answer).

- Q What date was this? A In August 5th.
- Q There was no school at that time, was there? A No sir.

BY THE COURT:

- Q Do you go to school? A Yes sir.
- Q Where? A Public School #1. Corner of Henry and Catharine Street.
- Q How long have you been going to public school---do you know the number of years, days or weeks? A About two years.
- Q What class are you in? A Five A.
 BY MR. ADAMS:
- Q Where did you go to school before that? A Roosevelt Street, Public School, #112.
- Q You have been going to school ring along, have you?

 A Yes sir.
- Q And you were at school up to this time, were you? A Yes sir.

BY THE COURT:

- Q You are still at school? A Yes sir.
 BY MR. ADAMS:
 - Q Whom did you first tell about this?

 THE COURT: That question is entirely irrelevant. Any verdist that we got, if that question were

answered, would be reversed at once. Your case is now ended as far as this witness is concerned.

Q Did you ever have anything to do with anybody before this time? A Yes sir.

THE COURT: That is a question for cross examina-

Q How many times?

THE COURT: That is not a proper question.

A One time before this.

CROSS EXAMINATION BY MR. NOLAND

- Q Where did you say you were born? A I was born in Europe.
 - Q What part of Europe? A. In Italy.
- Q How old were you when you came to New York? A I was about six or seven years old.

THE COURT: You are not going to contest her age are you?

MR. NOLAN: I do not think we will let it go at her word that that is her age. In a case of this kind I certainly cannot concede anything.

THE COURT: All right.

Q Whom did you come to this country with? A My mother and father were here before I was, and there were some friends of my father coming over and he wrote a letter to him to take

us along.

Q You didn't come herewith your parents, is that it?

A No sir.

SHARE SELECTION OF THE SECOND SERVICE SERVICE SERVICES AND ASSESSED OF

Q When before you came to New York had you last seen your parents? A When they came over he re I was over there in Italy.

Q How many years was that before you came? A I don't remember.

- Q You don't remember that? A No sir.
- Q But you remember their leaving to some here, do you?

 A Yes sir.
- Q But you don't remember how long it was before you came? A No sir.
- Q You say you first saw this defendant at #35 Roose-velt Street on the first of June 1909 is that so? A Yes sir.
- Q Will you kindly state how you remember it was the first day of June 1909? A Yes sir. When we moved to Roosevelt Street we come from Cherry Street——we came to Roosevelt Street and when we moved from Roosevelt Street it was in, in May——about the first of May——we rented the rooms in Roosevelt Street, and a month after my mother told me to take a pair of shoes of her's to fix. I said where? She said right opposite the candy store there is a shoemaker, and that was 33 Roosevelt Street——and about a month later——

Q That was about a month after you say you moved to

Roosevelt Street? A Yes sir.

Q And just took the shoes there and left them, is that all you did on that occasion? A I told him to fix them, to repair them.

Q On how many other occasions did you take shoes to this man's shop? A No answer.

BY THE COURT:

- Q In your whole life? A About two or three times.
- Q Altogether? A Altogether.

BY MR. NALON:

Q And you took them there on the first of June? A Yes sir.

Q And then again about the first of August? or thereabouts? A No, one time after june I took them again---I took another pair after---I took one pair---I took another pair.

BY THE COURT:

Q That is between June and August you took another pair?

A Yes sir.

BY MR. NOLAN:

- Q Where did you take those, to Roosevelt Street or Catharine Street? A It was in Roosevelt Street too. ---I think it was in Catharine Street, in 80 Catharine Street.
 - Q That was between June and August? A Yes sir.
 - Q Was there any reason why you should have gone all the

way to Catharine Street to have shoes repaired, from Roosevelt Street? A No sir.

- Q Plenty of other shoemakers around the neighborhood there, weren't there? A Well, I don't know.
- Q You have seen plenty of shoe shops, haven't you, around there? A Yes sir.
- Q Do you remember what day of the week the 5th day of August last year was? A No sir.

THE COURT: If you don't remember just say so.

THE WITNESS: I don't remember what day it was.

BY THE COURT:

. Q You don't remember what day of the week this happened to you, do you? A No sir.

BY MR. NOLAN:

- Q Will you tell us then how you know it was the fifth day of August? A Yes sir. When we went to school we had a vacation, and he used to live in Roosevelt Street, and two months later he moved to Catharine Street, and it was only two months later that he moved from Roosevelt Street to Catharine Street.
- Q And that is the only way that you remember that it was the 5th day of August? A Yes sir.
- Q Bu reason of the fact that you got a vacation? A Yes sir.
 - Q And that two months after you got the vacation ---

me mix A No sir, not two months after the vacation. Two months in June and from June 1st, and two months later he moved---in August he was down in Gatharine Street.

Q Ypu say two months after June he moved? A June and two months after June.

BY THE COURT:

Q Did he move in June, you say? A No, not in June.

He stood there, not till the very last of june and then he moved to Catharine Street and sold that place in Roosevelt Street to a different man and two months later he went to get a new place down in the basement.

BY MR. NOLAN:

- Q And your only reason for saying it was the 5th day of August 1909 is that you had a vacation and that the defendant moved from Roosevelt Street to Catharine Street? A Two months later.
- Q After you got the vacation? A The last of June we get vacation from school, till September.
- Q Was it two months after that that he moved to Catharine Street? A From June, about till the last of June he moved to Catharine Street.

BY THE COURT:

- Q You mean about the last of June he moved to Catharine Street? A Yes sir, two months later.
 - Q Before or after vacation? A . That was before vaca-

- Q He moved before vacation? A Yes sir.
- Q And about two months after that you went to see him in Catharine Street? A Yes sir.
- Q And that is how you fix the fifth of August? A Yes sir.

BY MR. NOLANE

- Q Nothing happened since the time that as you have testified you committed this act of sexual intercourse with the defendant to cause you to particularly remember that day, did there? A (No answer)

 BY THE COURT:
 - Q Do you understand that question? A No sir.

 (Question repeated by the Stenographer)

THE WITNESS: Well, that was the last time I went there, and the last time I went there he told me about that.

- Q The last time you went there he told you about that?

 A Yes sir.
- Q Did you ever tell your parents anything about this?

 A No sir.
- Q And when for the first time did you tell it to anybody? A Well, when I went to school Mr. Cook and Mr. RESERVA
 Pizzaro came down there in the school and told me---and said "o
 "Do you know a man in Monroe Street"? And in school I didn't

(Question repeated by the Stenographer)

THE WITNESS: The first time I told it to anybody

was Mr. Cook.

BY THE COURT:

- Q Or Pizzaro, which? A Mr: Cook.
- Q When was that? After school opened? A No, it was in March. I was in school and then he took me away from school and brought me in 23rd Street and took my sentence down. I told him and he wrote it down.
- Q That was this March past? A Yes sir. BY MR. NOLAN:
- Q Up to that time you had never said anything to anybody about this occurrence? A No sir.
 - Q Sure of that? A Yes sir.
 - Q Ever talk to anybody about it in school? A No sir.
- Q Never told your parents or anybody at home? A No sir.
- Q Was it in March or about the 15th of April? A When I was taken from School?
 - Q Yes? A It was in March?
 - Q You are sure of that? A

THE COURT: She was taken from School in March.

Q And that was the time that you told Mr. Cook? A It was not in March; it was in April. I made a mistake.

- Q Do you remember what time in April? A About the 15th of April, I was taken from School.
- Q And did you tell Mr. Cook in just the same way that you have told the Jury here to-day of this occurrence? A I told the same thing, yes sir.
 - Q You told him just the same thing? A Yes sir.
- Q How long were you talking with Mr. Cook? A Well, I don't know how long I was talking to him, & don't remember.
- Q You don't remember how long you were talking to Mr. Cook on that day? A No sir.
- Q Well, you were talking to him for some time, were you? A Yes sir.
 - Q Was it an hour? A No sir.
- Q Was it more than an hour, A It was less than an hour.
 - Q Less than an hour? A Yes sir.
- Q And during that conversation with Mr. cook did he frequently interrupt you to ask you questions? A No sir.

 BY THE COURT:~
- Q Do you know what that means? Did he ask you any questions at all? A He asked me questions.
 - Q He did ask you some questions? A Yes sir.
- Q And wrote your answers down? Is that what you mean by saying he took your "Sentence" down? A Yes sir, while I was talking he was writing it down.

- Q Did Mr. Cook correct any of the statements you made by saying to you that you should use some other words? A No sir.
- Q Will you tell us when for the first time did you hear the expression "Private parts"? A I don't remember.
 - Q Did Mr. Cook tell you that, A No sir.
 - Q Did Mr. Pizzaro tell you that? A No sir.
 - Q Did Mr. Moore tell you that? A No sir.
 - Q Did Mr. Adams tell you that? A No sir.
 - Q Do you remember who did tell you that? A No sir.
- Q How many times have you talked over this case since the 15th of April with persons connected with the Gerry Society or the District Attorney's office? A About five times.

 BY THE COURT:
- Q You have talked it over whenever they have asked you about the case, haven't you. A Yes sir.

 BY MR. NOLAN:
- Q And want at these talks that you have had didn't they frequently cause you to use different words than those that you used yourself? A No sir, I used my own words.
- Q Well, when you first spoke with Mr. Cook did you use the words "Private parts"? A No sir.

BY THE COURT:

Q Well, what words did you use? A I told him --- I

- Q What did you use? A I used ---
- Q What words or word? A Fuck.
- Q Did you describe that, A No sir.
- Q Didn't you say anything about this man's private parts? A I says that he took his privates parts out.

THE COURT: Proceed.

BY MR NOLAN:

Q Prior to the 5th day of August 1909 had you ever committed an act of sexual intercourse with anybody else? A Before that time---

BY THE COURT:

- Q Do you know what sexual intercourse means? A If I had anything to do with anybody else.
- Q The same as you say you had with him? (The defendant)

 A Yes sir. Before he ever did anything to me another man

 did something to me.
- Q Did the same thing? A Yes sir.
 BY MR. NOLAN:

ASE AT 1170

- Q You understood what I meant by an act of sexual intercourse? A Yes sir.
- Q You have heard those words before, have youlf A Yes sir.
 - Q When for the first time did you hear those words?

 THE COURT: How is that material?

MRL NOLAN: It may be very material to the Jury.

They are entitled to know just what has taken place
in this case. I want to show that the language has been
put into the mouth of the witness.

THE COURT: Well, proceed.

A I was down---I heard it down in this---I don't know what the name of the place is---I think it was in general sessions.

BY MR. ADAMS:

- Q You heard it in General Sessions? A Yes sir.
 BY MR. NOLAN:
- Q Do you know who ke you heard say it? A I don't know.
 - Q Was it Mr. Cook? A No sir.
 - Q Or Mr Pizzaro? A No sir.
 - Q Or Mr. Moore? A No sir.
- Q Or Mr. Adams here? A I don't know. It was a man who was asking me questions.

BUUREE COUT

A man was asking you to tell what happened? A Yes

Q And he used that language during that time? A Yes sir.

BY MR. NOLAN:

- Q He asked you to tell what happened? A Yes sir.
- Q And after you had stated something to him he corrected you by telling you to say "An act of sexual intercourse"? A No sir. When I first went in there he said "Did you have any private intercourse with Francesco Purpura?" And I said "Yes sir, " and I knew what that meant.
- Q Where was that? A In General sessions.
 BY THE COURT:
- Q What language did this man speak to you when you went into his place there (Referring to defendant) --- in English or Italian? A English.
- Q Can you speak Italian? A We don't speak the way they speak. We are Genoese, and they are different than us, but I understand some words they speak.
- Q He spoke English to you? A Yes sir.
 BY MR. NOLAN:
- Q Was that after you had been taken to the Gerry Society and talked with Mr. Cook.

THE COURT: Was what after?

Q (Continuing) That you used the expression "private"

RENTE intercourse?" Was that fafter you had been taken to

I knew when I was up there in 23rd Street---the girls told me
---they told me about it and said "Tell me your case", and
everything, and the teachers said "You should not tell no
one your case;" and then she said "Did the man in general sessions tell you what private intercourse meant? " I said "No,
he didn't ask me that? When I went in General Sessions the
man told me that. " And she says "You know what it means?"
And I said "No, " and then she told me about it. Then when
I went to general sessions I knew what it meant, what the words
meant.

- Q Who was it that told you about it? A It was the girls that were telling me about it.
- Q But you say that when the man in general sessions asked you if you had ever had private intersourse with Frances-co Purpura, you said yes, that you knew what that meant? A Yes sir.
- Q And that was before the time that the girl had told you? A No, the first day I went up there and then the girls were telling me "why you are here?" And everything.

 And then---

BY THE COURT:

Q What did they say? A The girls were telling me to tell them my case and I wouldn't and the teacher said "Don't tell no were your case."

- Q What teacher was it that told you that? A The teacher we have up there.
 - Q Up in the Gerry Society? A Yes sir.
- Q You hadn't told anybody about your case up to the time that Mr. Cook came and took you from the school, ax is that right? A Yes sir.
- Q No one at all? A No sir. The first one I told it to --- I told it to Mr. Cook.
- Q Do you know how Mr. Cook came to take you from the school? A No sir.

BY THE COURT:

- Q Did you ever hear how Mr. Cook came to take you from the school? Did Mr. Cook tell you why he took you from the school? A Well, after, I knew it.
- Q He asked you waw Mr. Cook took you from the school

 A Because he told me if I knew this man and I said No, and
 then when whe he took me from school I told him all about it.
 - Q All about what? A All about this man.
- Q What do you mean all about him? A I told him what happened on the 5th day of August.
- Q Didn't Mr. Cook know that before you told him? A Well when I was saying---
- Q Didn't Mr. Cook know it before you told him? A No sir, he didn't know it.

- Q You didn't state to Mr. Pizzaro on the 5th day of April that this defendant committed an act of sexual intercourse, on or about the first day of March 1910, did you? A No sir, not with this man.
 - Q Did you ever tell that to Mr. Pizzaro? A No sir.
- Q Did you ever tell Mr. Cook that this defendant had committed an act of sexual intercourse with you on the first day of March 1910. A Not with this man, but another man.

 BY THE COURT:
- Q Another man, you say, had intercourse with you on the first of March? A Yes sir.
- Q Then you did not mean that you had only had intercourse twice in your life? A Twice.
- Q You said you had it before August too? A Well, the same man.
 - Q What? A This is the same man.
- Q You say you had some one else on the first of March 1910? A Yes sir.
 - Q This year, the March just mank past? A Yes sir.
- Q Do I understand you rightly or not, that some one had done this to you for this man (Indicating)? A Yes sir. Before this man.
 - Q Before that man (Indicating Defendant) Some one else

- Q And then that man did it once in August? A No sir.
- Q This man (The defendant) did it in August. A Yes
 - Q That is the only time he ever did it? A Yes sir.
- Q But this other man who had done it before did it afterward s? A Yes sir.
- Q And you did say that some one had intercourse with you on the first of March of this year? A Yes sir.

 BY MR. NOLAN:
- Q But you did not tell Mr. Pizzaro that the defendant
 Francesco Purpura had on the first day of March 1910, in the
 County of New York, at the premises 82 Catharine Street,
 unlawfully perpertrated an act of sexual intercourse with you?

THE COURT: She cannot understand all that phraseology.

BY THE COURT:

- Q The question is did you tell Mr. Pizzaro that this man Purpura did it to you in March off this year? A No sir, not in March.
- Q At 82 Catharine Street or any other place? A No sir.
 BY MR. NOLAN:
- Q Did you talk with Mr. Pizzaro on that day in the police court, downstairs? A No to Mr. Pizzaro, but to Mr. Cook.

Q You are sure of that? A Yes sir.
BY THE COURT:

- Q Did you ever talk to Mr. Pizzaro that you can recollect? Would you know Mr. Pizzaro if he came in here now? A Yes sir.
 - Q You have seen him? A Yes sir.
 - Q He wasn't you teacher, was he? A No sir.
 - Q Did you ever talk to him? A Yes sir.
- Q But you don't know whether you talked to him downstairs or not? A No sir.

BY MR. NOLAN:

- Q Was it after the day on which you had been brought to the police court down stairs---after the first day that you had been brought there that you talked with Mr. Pizzaro?

 A When I was taken from School the next day Mr. cook told me a few questions and then Mr. Pizzaro told me a few questions.

 BY THE COURT:
- Q You mean asked you a few questions? A Asked me a few questions.
- Q But you have not answered the question yet --- when Mr. Cook took you from School win you knew ---

(Question withdrawn)

- Q Who is Mr. cook, do you know? A Yes sir, he is a detective.
 - Q And he came down to the school and took you out of

HHT.

your class room, is that it? Were you in your class room when he came there? A Yes sir.

Q He came to your class room and took you out? A He did not. He brought the clerk---

Q What? A The clerk, the one that is in there, Miss Davis.

Q The clerk of the achool? A Yes sir. She called me to the office and I went with her and when I went down I saw Mr Pizzaro and Mr. Cook there.

Q In the principals office? A Yes sir, in the principal's office.

Q Now the question that Mr. Nolan asked you was why did that? A Well, when they called me from school I didn't know why it was but after I knew it.

Q No, but how did they know it if you never had told a soul. A I told them the first.

Q How did they pick you out? There are two thousand girls in that school, aren't there? A Yes sir.

Q Are they all the same as you? A I don't know.

Q Well why did they pick you out of the two thousand?

A Well, there was another girl and she says that I knew this man too, so then Mr. Cook---

Q That is the point I want to get at. The other girl told about, is that it? A Yes sir.

- Q Is that the girl that was in this place when this thing happeneds, A No sir, but she told Mr. Cook I know a man in Monroe Street.
- Q This is not in Monroe Street? A No sir, this is another man?
 - Q She didn't tell about this man? A No sir.
- Q Mr. Cook came to see about a different man? A Yes sir.
- Q And then when you were in there you told him the story about this man, (The defendant), is that it? A Yes sir. BY MR. NOLAN:
- Q Who was it that first mentioned the name of this defendant Francesco Purpura --- was it Mr. Cook or Mr. Pizzaro.

 A Mr. Pizzaro.
- Q That was before you had stated anything at all about what happened ast August? A Yes sir. He told me---he says do you know a man---do you know anything about the shoe maker in 80 Catharine Street? And I told him "Yes".
 - Q Mr: Pizzaro asked you that? A Yes sir.
 - Q You told him "Yes"? A Yes sir.
- Q Was that all that was said at that time? A At that time, then he took me---I was in the room down stairs.
- Q That was in the school building? A No sir, in this building.

BY THE COURT:

Q Down stairs in this building you mean? A Yes sir.

BY MR. NOLAN:

- Q Did you tell Mr. Pizzaro at that time that it was on the first of March of this year? A No sir.
 - Q You didn't tell him that? A No sir.
- Q When you were brought to the office of the principal of the school on or about the 15th of April of this year who did at first mention the name of this defendant Francesco

 Purpura? Was it Mr. Cook or Mr. Pizzaro or was it you? A

- Q When did they first speak to you about this defendant?

- Q They said to you --- whom do you mean by "they"? A Mr. Pizzaro told me "Do you know the shoemaker"? And I said "Yes sir.".
- Q You had not said anything to the defendant about Purpura up to that time? A No sir.
- Q Do you know how Mr. Pizzaro came to ask you that question, if you knew about the shoemaker? A No sir.

Q And what was the name of the girl that you said told about the other man that you had had relations with? A Lucy Decabia.

Q Where does she live? A She lives in Madison Street-I don't know the number.

Q So it was in connection with another man that you were first taken from the school, is that so? A Yes sir.

Q Was it on the fifth day of August 1909 that you took the shoes, as you have testified to this defendant's shop?

A It wasn't on the 5th day of August, but it was on the third day.

BY THE COURT:

Q You took the shoes and called back for them on the 5th, is that it? A Yes sir.

BY MR. NOLAN: Do you remember what day of the week the 3rd day of August was? A No sir.

Q Will you tell us how you remember it was the 3rd day of August? A It was on the 3rd day of August, and two days later---

Q Did you make any memorandum at the time, that it was the third day of Augusto A (No answer)

BY THE COURT:

Q Do you know what "Memorandum" is? A No sir.

- Q Did you write it down any place? A No sir.
 BY MR. NOLAN:
 - Q Nothing took place there at that time? A No sir.
- Q And you went there all alone on that occasion? A Yes sir.
- Q What time of the say was it on the third of August that you went there? A This was in the morning.
- Q What time in the morning, if you remember? A I don't remember the time.
 - Q You don't remember the time? A No sir.
- Q But you went there all alone? A Yes sir. When I took the shoes I went there all alone.
- Q Where did this Skenelli girl live? A 54 New Chamber Street.
- Q Is that on your way to 80 Catharine Street? A No sir.
 - Q You didn't go that way? A No sir.
- Q Which way did you go from 50 Roosevelt Street? A I don't know where she was going, I met her and I says "You want to come with me?" And she said "Where?" I said "I am going to get my brother's shoes." Then she said "All right" and she come with me.
- Q You told her, did you, where you were going? A Yes sir.

- Q How far was that shoemaker's shop from where you lived--- How many blocks did you have to go to get to 80 Catharine Street? A About two blocks and a half.
- Q What blocks were they? Where did you live? A Roosevelt Street?
- Q Near what street? A Roosevelt near ---it is Roose-velt Street and on the right side is Bowery and on the other part is Roosevelt Street, going down the street, and New Chambers.
- Q You lived on Roosevelt Street between Bowery and New Chambers? A Yes sir. Here is Bowery and here is New Chambers and here is where I lived, in the middle, (Indicating) and pointing).
- Q Between Bowery and New Chambers? A Yes sir.

 Our block is in the middle---
- Q New Chambers Street is a continuation of the Bowerty, isn't it? A New Bowery.

 Street at all? A No sir.
- Q You walked down Roosevelt Street to Oak Street? A Down Roosevelt Street to Oak Street.
- Q Then you aid not meet this little girl on New Chambers Street? A Well, I don't know where I met her---I

- Q Then you walked along Oak Street to James Street, to Oliver Street, to Catharine Street --- A Yes sir.
 - Q And then you turned down? A Yes sir.
- Q Will you tell the Jury why you took all that long trip to go and get a pair of shoes mended? You had never seen this man but once in your life? A Twice.
 - Q He never had done anything to you? A No sir.
 - Q He made no special inducements to you? A No sir.
- Q But this day you went out with these shoes and you passed how many Italian cobblers on the way? He is what you call a cobbler isn't he? A Yes sir.
 - Q He is not a shoe dealer? A No sir.
- Q He has a little bench, as you said, and he woks there all day long? A Yes sir.
- Q He does not sell any shoes, but he only repairs shoes? A Yes sir.
- Q How many such places do you know of between 80

 Catharine Street and where you live? Aren't there two

 or three of them on every black? A Well, not on Roose
 velt Street there aint so many shoemakers. He was there and
 then he moved and there was another one in his place but I

 didn't go to that one.
 - Q Then that was one you passed --- the one that took his

- Q What number is that? A It is not on Roosevelt Street, it is on New Bowery.
 - 'Q Right near you? A Yes sir.
- Q On Oak Street didn't you pass a lot of them? A No sir, there aint none on Oak Street.
 - Q Not one? A No sir.
- Q You are sure of that? A I don't know any shoemaker's on Oak Street.
 - Q You don't know any? A No sir.
- Q And on Catharine Street until you came to his place there was none? A Yes sir.
- Q Were you ever in 80 Catharine Street before that day?

 A Yes sir, once before.

- Q You were once before this day there? A Yes sir.
- Q I mean before the first time you brought the shoes to him? A I was there a second time.
- Q How many times altogether were you in there? A Three times.
- Q What did you go there for the first time? A The first time---well he lived in Roosevelt Street---I brought a pair of shoes for him to repair, and then I brought another pair down in Catharine Street and then I brought a third pair.
- Q But the only time you were ever in there was when you brought shoes to his room, or when you went for them? A Yes sir.
 - Q What kind of a building is it? A About six flights
 - Q You mean it is a tenement house? A Yes sir.
 - Q A tenement house of six floors? A Yes sir.
- Q You are not sure of that? It might be five? A (No answer).
 - Q It is a big house, is it? A Yes sir.
- Q What is there on the ground floor? A On top of him (Indicating the defendant) there is a barber shop and next him is a butcher store.
 - Q On the ground floor there are two stores? A Yes sir.
 - Q And the hallway is between them? A Yes sir.

- Q Were you ever upstairs? A No sir.
- Q So when you say six flights, there might be five or seven---you are not sure? A Well, next to that is 82 Catharine Street.
- Q Well, this is number 80 you are speaking about? A Yes sir, and the next building to that is just as hugh, the same; and one time I went in to buy candy and I looked up and I saw it was six flights.
- Q You went to bun candy? A Well, whe time I was was walking down and I went in the candy store.
- Q Walked down Catharine Street? A Yes sir, and I went in the candy store and I bought a candy and while the man was waiting on another person I looked up at the building and counted the flights --- counted how many floors there is.
- Q You were in the building and you looked up and counted how many floors? A I wasn't in the building; I was buying the candy across the street.
- Q So that was number 80 and 82? A Well, it was 82 and e then comes 80.
- Q How did the number get impressed on your mind? How are you so sure it was 80. A When I went there with Mr. Cook and Mr. Pizzaro and another man.
- Q Then you looked at the number when you went there?

 A Yes sir.
 - Q And you took them to this building? A Yes sir.

- Q And then you saw the number? A Yes sir.
- Q And then you took a good look at the building? A Wes sir.
- Q And you say on the ground floor of the building right off the street there was a barber and butcher shop? A Yes sir.
- Q And this man (The defendant) was down in the basement?

 A Yes sir.
- Q How did you get down to that basement? Where was the entrance to this basement. A He had a sign outside, and then there was about --- there was the stairs to go down.
- Q Where were the stairs --- in front of the building or in the hallway or where? A Where the sidewalk is and then there is steps going down.
- Q There is a stairway leading down from the street, is that it? A Yes sir.
- Q You do not have to go in that building at all to go into his shop? A No sir.
 - Q There are stairs from the sidewalk? A Yes.
- Q In front of the barbershop or butcher shop? A It is under the barber shop.

(The Court now directs an adjournment until 2 P.M., first duly admonishing the jury as usual)

After recess.

TRIAL RESUMED.

VIOLET PERANO, the complainant herein, resumes the stand and further testifies.

BY MR. NOLAND:

Q How many steps down from the street was the shop occupied by the defendant, if you know? A About ten. BY THE COURT:

- Q You didn't count them? Did you? A Well, I didn't count them.
- Q It was a flight of stairs going down from the street? A Yes sir.

THE COURT: Do not say anything now unless you are sure of it, do you understand.

THE WITNESS: Yes sir.

BY MR. NOLAN:

- Q Is there a large window in front of his shop? A Yes sir.
- Q Are there any windows to the rear that you noticed?

 A No sir.
- Q No windows at all at the rear of the shop? A No windows.
- Q And how far, if you remember, from the front door where you enter is to the rear wall?

THE COURT: Do you mean to the end of the shop,

MR. NOLAN: No, the full length of the place, including the both rooms.

THE COURT: Do you understand what he means?

THE WITNESS. Yes sir. About how big is it?

BY THE COURT:

Q How deep is it from the street in? Could you point out here in the court room? A Well, about from there where that thing is down to there.

Q Go over and point to the thing you mean? A The stairs, come down to about here (Indicating).

BY MR. ADAMS:

Q That is where the stairs go down? A Yes sir.

MR. NOLAN: I move to strike that out as not responsive.

THE COURT: Motion granted.

BY THE COURT:

Q You go man down to the shop, and there is the door leading in from this basement? A Yes sir.

Q How far back does the store run---not to the partition but to the rear wall? A I don't know.

Q Now, you had been in this place altogether how many times? A Three times.

BY MR. NOLAND That was on the 3rd of August, or the 5th of August and on one other occasion? A Yes sir.

- Q Whose shoes were they , A My brother's shoes.
- Q How long before the third of August was that? A This was the third of August.
- Q That was the third of August? A First I brought my mother's shoes, then I brought my brather own during from June to August and then August the 3rd I brought my brother's.
- Q You were there with your own shoes at 80 Catharine Street? A Yes sir.
- Q How long before the third of August? A I don't know how long it was.
- AQ You don't remember how long? A No sir.
 BY THE COURT:
- Q Was it before or after? A Before.
 BY MR. NOLAN:
- Q Are you sure it was 80 Catharine Street you went? A Yes sir.
- Q And you had been once to his place in Roosevelt Street.

 A Yes sir.
- Q Did you go after your own shoess after they had been mended? A I took them there and when I went to get them.
 - Q That was twice you were there? A Yes sir.

- Q And then again twice---onee on the third and once on the 5th of August? A I brought the shoes on the third and I went to get them on the 5th.
- Q On either of the two occasions, the two times that you went there, once with your own shoes and again to get your own shoes, did you go there alone? A Yes sir, I was all alone.
- Q Was anybody in the shop at the time that you went there? A Well, the last time when I brought my---
- Q I mean the time when you brought your own shoes and again when you went to get them? A No sir, no one was there.
 - Q Only the defendant? A Yes sir.
- Q And that was some time prior to the third of August?

 Before the third of August? A Yes sir.
- Q And you say you went there alone on the third of August? A Yes sir.
- Q When you brought your brother's shoes there? A Yes
- Q You say you visited his shop at 33 Roosevelt Street about June first 1909 that time you say you took your mother's shoes? A Yes sir.
- Q And did you go again and bring them back when they were mended? A Yes sir.
 - Q And did you go there alone at that time? A Yes sir.

- Q Nobody there but the defendant himself? A Yes sir.
- Q And de you remember what time of the day it was on the first of June or about the first of June when you went there? A No sir.
- Q. Do you remember what time of the day it was when you went to bring your mother's shoes home after they had been mended? Was it in the morning or the evening? A I don't remember when it was?
 - Q You don't remember that either? A No sir.
- Q Now at the time you took your own shoes there prior to the third of August, do you remember when that was---whether it was in the morning or afternoon or evening? A No sir, I don't remember when it was.
- Q Do you remember what time of the day it was when you went to get your own shoes after they had been mended?

 A No sir.
- Q Now after the 5th day of August you have stated that you never talked with any one what took place there, is that right? A I don't know what you mean.
- Q You didn't tell anybody about what took place there?

 A No sir.
 - Q Never talked about it to anybody at all? A No sir.

- Q The thing just left your memory altogether, did it?

 A Yes sir.
- Q And it never occurred to you---you didn't have occasion to remember it or recall it until you were spoken to by Mr. Cook or Mr. Pizzaro is that right? A Yes sir.
- Q So that there was nothing that causses you to particular larly remember the 6th day of August ---

MR. NOLAN: Question withdrawn.

- Q Is there any particular reason why you recall the 5th day of August 1909? A No sir.
- Q You don't remember whether that was a sunshiney day or a rainy day---you have no recollection of it at all? A No sir.
- Q What time of the day was it on the 5th day of August that you went back as you have testified to get your brother's shoes.

THE COURT: Morning, afternoon, or avening?

A Afternoon.

- Q What time? A About three o'clock.
- Q About three o'clock in the afternoon? A Yes sir.
- Q Can you tell us why you remember it was about three o'clock in the afternoon? A When I brought the shoes on August third, I brought them in the morning. Then August 5th---I says "When will you have them done?" And he said

"I have a lot of work," and then I went back for them in two days, and then when I come home from school and then after I went to school and after three o'clock I come home and instead of going---I went home and then I brought my books up and then I met Lena and I went--
BY THE COURT:

Q You went to school on August 5th? A No, not when I went to school.

Were you in school on the 5th of August? A No sir.

Q Why did you say you went after school? He asked
you how do you know it was 3 o'clock in the afternoon on
August 5th when you went there? A After when I had my
dinner, and I took my brother out, and after when I took

Q Did you see any children playing around there?

A I don't remember.

Q You don't remember? A No, sir.

THE COURT: If you don't remember say so always .

BY MR. NOLAN:

Q You are familiar with Catharine Street, are you?
That is, you know it pretty well? A Yes, sir.

Q You have been on Catharine street many times?

A Yes, sir.

Q And Catharine street leads into the Bowery, doesn't it? A Yes, sir.

Q And there is always a lot of people passing up and down there? A Yes, sir.

Q Isn't there a moving picture show there near this place? A Yes, sir. It is not on this block but the

 - Q Does the other girl speak Italian? A Yes, sir.
 - Q You spoke in English? A Yes, sir.
 - Q Who spoke first, you or he? A I did.
 - Q You did? A Yes, sir.
- Q What did you say to him? A I said, "Is my shoes done?" He said, "Yes." I said, "Let me see them," and he said, "No," and he said, "no."
- Q What did you say when he said no? A Then he says
 "I won't let you see your shoes." Before this he said,
 "No," and then he told me he says he told me, "Do you

want to give me a fuck?" And I stood there a little
while, and I didn't answer, and then after, I told him;

THE COURT: Well, there are two questions there.

A I don't remember.

Q Well, who spoke after he said, "No, you cannot see them?" Who spoke next? A Then he went on, he was saying, "No, you cannot see them." He said "First give me a fuck," and then I didn!t say nothing.

Q He said that right away, did he? A Yes, sir.

When I went in I went down the stairs with my friend, and

then I said, "Is my shoes done?" And he says, "Yes, your shoes are done." And then I said, "Let me see them."

And he said, "No, you cannot see them. First give me a fuck," he said.

Q How far was the other girl away from where you were standing at the time that you say the defendant said that? A She was standing by the door.

Q How far is that from where you were standing?
Will you show us in this court room here?

A She was standing there (indicating front rail of jury box).

Q Now how far did you walk in? A And I was standing about up to here (indicating).

Q Now you are clear about that? A Yes, sir BY MR. NOLAN:

Q Was the defendant sitting down at his bench when you went in there? A Yes, sir.

Q And when you spoke to him what did he do? Did he get up? A Yes, sir.

Q Suppose you tell us, if you can, imagine that that little place in here (indicating space in front of the Judge's bench and between the Judge's bench and the desk of the Clerk of the court) was his shop, just show us where the bench was and the chair and the partition? Do you think that is too much trouble for you? Step down there. Suppose you are in the shop now, that that place there is the shop, how far in from the street was this partition that you speak of? Do you know what the partition is? A Yes, sir.

- Q The boards? A Yes, sir.
- Q How far back from the street were they? Now remember there is the street where the gentlemen are sitting (front rail of jury box), and you walk right in front the street; now, how far in would you have to go before you came to that partition?

MR. ADAMS: She would walk down the area first.

THE COURT: But she is in the shop now.

A To go from where he divided his room?

- Q Go on, walk in now. A You walked in the place this way (witness illustrating).
- Q Point out from where you stand where the sofa was. A There (indicating straight ahead.)
- Q Against the wall facing you as you went in there?

 A Yes, sir.

Q After he said what you have testified to, before you went into the rear of the shop, how long did you stand there in the outside part of the shop? A (No answer.)

BY THE COURT:

Q After he asked you for what you have said how long did you stand there without saying that anything?

THE COURT: Isn't that your question?

MR. NOLAN: Yes, sir.

BY MR. NOLAN:

- Q You didn't say RHEK "Yes" right away, did you?

 A No, sir.
- Q You just waited how long? A I just waited a little while.
 - Q Without saying anything? A Yes, sir.
- Q And then what did you say? A Then I said, "All right."

THE COURT: She could not recognize the diagram and there is no evidence here that you could make a diagram on.

Q Did you at any time bring her case to the attention of the Gerry Society?

Objected to: objection sustained.

Q Did you in consequence of anything that this girl did, to your own knowledge, or anything that came to your

knowledge, take any action in regard to her?

MR. NOLAN: Objected to as immaterial.

BY MR. ADAMS:

o what did he do there? what was his business?

- O Haven't you been in his place? A Yes, once in awhile .
 - O A little place or big? A A small place.
- o was it one room or two rooms or three? A One room.
- O Anything divided ? A No.
 BY THE COURT:
- Q Is there a partition in it, separating the back from the fram front. A No, I rent one room.
- Q You rent one room, you rent him one room, but wasn't there some boards dividing it into two rooms?

 A No.
- O No division at all in it? A No. BY MR. ADAMS:
- o whendid you go down there? A wehn I go after the rent.
- $\mathfrak o$ Do you know what a division means? A I know what division means .
- Q what does it mean? A An apartment, to make from one room two rooms.
 - O where was only one room?there? A Yes.
 - Q All the time? A All the time.

BY THE COURT:

Q Wasn't there a curtain there or something?

A Every time we do it without anything in it--one room.

- O No bed? A I don't go in there to look. I stand by the door and he gives the rent and I go out.
 - Q what did you see there? A Nothing.
 - Q well, you saw shoes? A well, shoes.
 - Q You saw the man? A The man.
- o And a little bench? A The little bench which he was working on.
- O Did he sleep there and cook there? A I don't know.
- Q You don't know what he did there? A I don't know.
 - o And you never went inside the door there? A No.
- Q And you didn't pay much attention to what was in there if you did go inside? A No. When he don't bring--
 - Q You only went there for the rent? A Yes.
 - Q You weren't one of his customers? A No, sir.
- O You never visited him except to get the rent?
- O How much was the rent? A \$5.00 a month.

 BY MR. ADAMS:
- You won't swear there was any partition between this room or not?

MR. NOLAN: Objected to on the ground that he is

cross-examining his own witness.

THE COURT: The jury understand her testimony,
I think. She says she was never in the room and
never paid any especial attention to it.

- o can you tell us whether the ceiling is on a level with the sidewalk or below the sidewalk or above it?

- Q po you know what the ceiling is? A I don't know what he means now.
