- Q Did Edward say it? A Yes, sir; he said that to him by the restaurant.
  - Q Did Edward say what I have read. I will read to you

THE REAL PROPERTY.

MR. BROWN: I object to that.

Q Did Edward say this --

MR. BROWN: I object to that. If those are the minutes you are reading from, I would like to know it.

M. MANIEY: I am reading from page 163 of the minutes of this trial.

THE COURT: From the officer's testimony. He is merely reading the testimony to him and asking him if it was true.

- Q Now did Edward speak up and say he left his house to go out on an errand, and got into a muss with some boys in the neighborhood? A He did not say exactly that to the officer.
  - Q He did not say that? A No, sir.
- Q Now, did Roberts say anything to the officer of what took place? A Not a word.
- Q Now, why was it you gave that false name in the Police Court? A I didn't give no false name, I gave my right name.
- Q You gave your right name as Charles Samuels in the Police Court? A Not at the Police Court, but at the station house.
  - Q I am talking about the Police Court? A I refused

to answer --

Q Did you give a false name in the Police Court? A No, sir, I did not; I refused to answer to the name of Charles Brown.

- Q Who was it first used the name Charles Brown? A Officer Callanan.
  - Q Officer Kilgallen? A No, sir; Callanan.
- Q Was it in the Police Court he first used that name? A Yes, sir, in the Police Court.
- Q What did he say when he suggested the name of CharlesBrown? A He says, "You got to go under the name you are down on the station house." I said my name was Charles Samuels from the station house.
- Q That is what you gave the station house Charles Samuels, and the officer told you when you got to the Police Court to say your name was Charles grown? A Yes, sir; he told the man he set it down by that name -- "You got to go by that name".
- Q You had given the name of Charles Samuels in the station house? A Yes, sir, I did.
  - Q No doubt about that? A No. sir.
- Q Then when you got to the Police Court the officer told you to use the name of Charles Brown? A Yes, sir.
- Q Did he tell you why he wanted you to use that name? A No, sir; I didn,t ask him why.

- Q What part of the station house were you in when the officer said to use the name of Charles Brown?

  A Right in front of the desk.
  - Q Right where the clerk is? A Right where --
- Q Right where the clerk is writing? A In the Police Court?
- Q Where the clerk is writing? A Yes, sir; where the clerk is writing.
- Q What did the Judge say when you came before him?

  A At the examination I was called Charles Brown, and I refused to answer, and the Judge told me you have got to go under that name because that is the name you are down here by.
- Q Did you tell the Judge that was not your name?

  A Told the Judge my name was Charles Samuels.
  - Q Do you remember the name of that Judge? A No, sir.
- Q Wasn't it Keyran J. O'Connor a former Deputy District Attorney? A I don't know his name.
- Q Whoever it was you told him your name was Samuels? A Yes, sir.
- Q He told you you had to go under the name of Brown?

  A Yes, sir; that is the name I was under.

  BY THE COURT:
  - Q Sure the Judge told you that too as well as the

Q The Judge told you that you had to go under the name of Brown? A Yes, sir; because they had got me down by the name of Brown.

Q And said he could not change it? A Well, I never asked him that; he said I got to answer by that name.

#### BY MR. MANLEY:

- Q Did you see Roberts out there on the street draw a stick from his sleeve? A No, sir, I didn't see him draw no stick from his sleeve.
  - Q Holding it in his hand? A Yes, sir.
  - Q All the time on the street? A Yes, sir.
- Q Now did you hear an Italian up there in the house, 329, at the time that you were taken away, did you hear an Italian say that you were the man that had the razor and did some cutting? A No, sir, I did not hear him.
- Q Did you hear an Italian over there at the station house say that you were the man that did the cutting?

  A No, sir.
- Q Were you put in line with a lot of colored men?

  A Yes, sir in a line.
  - Q Did somebody pick you out? A Somebody did.
- What did he say when he picked you out? A Well, the policeman, Mr. Callanan--

THE CHIEF

- Q What is that? A Mr. Callanan picked me out of the crowd.
  - Q Mr. Callanan packed you out? A Yes, sir.
- Q Did anybody pick you out of the crowd besides Callanan? A No, sir; him alone.
  - Q No Italian picked you out at all in the station house?

    A No, sir.
  - Q Callananpicked you out as the man that done the cutting? A Yes, sir.
  - Q Did anybody pick you out Monday in the Police Court or Sunday rather in the Police Court? A He picked me out on Sunday.
    - Q Who did? A Callanan.
  - Q No Italian picked you out either on Sunday morning or Monday morning? A No, sir.
    - Q At any time? A No, sir.
  - Q It was always Callanan that picked you out?

    A Yes, sir; it was always Callanan that picked me out.
  - Q Now what did you think you were arrested for when placed under arrest that night in your house? A Well,

    I knew they had some fighting, according to what my brother told the officer on the street, and I thought maybe they came to arrest a whole bunch to get the right out of it.

THE CHIEF

Q Did you tell him about your brother right away, that your brother had some trouble in the street? A My brother told him it was him.

Q When the officers came to arrest you, different officers from Kilgallen, Officer Callanan and Officer Leonard, did you tell either of them that it was your brother that had the trouble in the street? A Why, I didn't tell them that -- Sunday morning at the station house.

- Q Why didn't you tell them that? A I told them that in the Police Court.
- Q Waited until you got to the Police Court before you told them that? A Yes, sir.
- Q When you got to the station house that night, why didn't you tell them it was your brother, not you? A I didn't know what I was held for.
  - Q Didn't know what you were held for? A No, sir.
- Q Nothing said about you being charged with using a razor or a knife? A No, sir; never charged me until Sunday morning.
- Q Nothing said about it at all? A No, sir; only the officer held me -- he said I done the cutting Sunday morning before I left the station house and I told him I didn't know anything about it.
  - Q That is the firstbtime you knew anything about it?

A Yes, sir.

Q What is that? A They put me apart from the rest of them.

Q You did not hear anything said by Roberts at all?

A No, sir.

Q Didn't you hear Roberts say when they got him to the and you station house that he had gone out to get some beer that night, and that you and he had some trouble with somebody?

A No, sir; he did not.

Q Did he say anything about it? A No, sir. I didn't hear him say that.

Q At the same time you went out to get a guitar or some musical instrument, and somebody tried to hold you up for beer money? A I didn,t say it to nobody because it wasn't me.

Q You did not say that at all in the station house?

A No, sir.

Q Didnit you see an Italian up there in the house at the time when they arrested everybody in the house?

A I seen an Italian there.

Q That is the man that they call Citrone, an Italian, wasn't it?

- Q Well did not Citrone identify you, point you out as the man that had the razor and also the instrument either a banjo or a guitar? A If he did point to me I didn't see him; I didn't know him.
  - Q You didn't see him at all? A No, sir.
- Q Didn't that same man pick you out at the station house? A The man that picked me out from the crowd was Callanan.
- Q How could he pick you out if he hadn't seen the cutting? A Well, I don't know; I didn't see the Italian man.
- Q Now you are positive you didnot know what charge was against you until next morning? A No, sir; I did not know what the charge was.
- Q Didn't you hear Roberts say this in the station house-didn't Officer Callanan say, "What do you know about this", say that to Roberts, and didn't Roberts say, "There was a little fuss up the street and some boys went to take a can of beer out of my hand"? A No, sir; I didn't hear him.
  - Q Nothing of thekind? A Nothing of the kind.
- Q. Didn't he also say, "Wasn't that the man cut with the razor, and didn't Roberts then say in your presence, "There was nobody cut with any razor at all, there was no razor

around, I don,t know anything about anybody being cut with a razor. We went out to get some beer, we had a can of beer, the boys went to take it from us", did you hear that?

A No. sir.

Q. Didn't you then say: "the boys held us up wanting the price of a can of beer"? A I didn't say a word like that because they did not hold me up.

Q Now, didn,t you say after they got you to the station house, to both Officers Leonard and Callanan, that the three of you went out together to get some beer? A No, sir; therewas the three of us went out--

Q I am asking you if you said that to the officer?

A No, sir; I did not.

Q Did you tell him the name of the third man that went out to get the beer-- to the officer? A No, sir; I did not.

- Q You did not give him any name at all? A No, sir.
- Q You did not at any time in the station house tell the name of the third man to the officer? A No, sir, I did not.
- Q Do you claim to this jury that you were locked up all night and didn't know at all what you were locked up for?. A Well, I didn't know what they arrested me for.
  - Q Now you say you were placed in a line in the station

house? A Yes, sir.

- Q About how many colored people in the line? A About ten or eleven.
  - Q All lined up right side by side? A Yes, sir.

- Q Now, when you got to the hospital in company with Edward, who, if anybody, did the talking while this Mc-Carthy was identifying you as the man that cut him?

  A Which one of the officers did the talking?
  - Q Which one of you? A Roberts done the talking.
- Q Did he attempt to say anything? A Yes, sir; he attempted to ask "Boy did I hit you?" But he didn.t get out the words and the officer stopped him.
- Q Didn:t allow him to answer? A No, sir; didn:t allow him to answer.
- Q You didn't say anything? A No, sir; I didn't say a word; I didn't try to.



- Q The officer went over there? A I heard so.
- Q To where he worked? A Yes, sir.
- Q To look for him? A Yes, sir.
- Q He did work in Brooklyn at the time? A Yes, sir; he did work in Brooklyn at the time.
- Q Did he come home every night? A Came home every night.
- Q What time did he leave home in the morning to go to work? A He left home at 6 o'clock or a quarter past 6, supposed to be over there at 7 o'clock.
- Q But he was at the house that night when you returned to the house that night when they were having the party at 11 o'clock as you say, -- where did you come from?

  A Well down to my cousins that is 223 West 61st street.

  A Yes, sir.
- Q They had refreshments there? A Yes, sir, refreshments yes, sir.
- Q There was no occasion for any of you to go out to get refreshments? A No, sir.

- Q You didn,t send out for beer that night at all?

  A No, sir; we had a case of beer in the house.

Q Will you tell me of that party that you had upthere that night, where they lived, did they live in the house, in your room? A No, sir; some lived uptown and some downtown, the party we had.

- Q It was your room? A Yes, sir., my own room.
- Q They were all in yourroom ? A Yes, sir.
- Q Did you have a party there at any time before that?
- A We had a party before, but there was no fighting.
- Q How long ago before that did you have a party?

  A Well about 1908.

## BY MR. BROWN:

- Q You had been living in that house for three months?

  A Yes, sir; three months.
  - Q This was the first party you had in that house?

Q There didn.t any of these persons except ou three live in your rooms, did they? A Nobody but my brother, myself and Joseph Jackson.

Q Some of these people lived all over the city?

A Yes, sir.

#### BY A JUROR:

- Q Do you shaveyourself? A No, sir, I don't.
- Q Where do you get shaved? A Sixty-second street,



Q Any of your friends have razors that night? A I couldn't tell you.

Q When the officer came down at the time you claim that the woman on the ground floor told you-- was that a woman in 209? A Yes, sir; 329.

Q You said the officer came down the south side of the street? A He came from the--

Q West End avenue? A Yes, sir; the south side of the street.

Q Dad you cross over to him or did he come over ?

A We crossed over to him.

Q You gathered under a lamppost on the other side?

A Yes, sir.

- Q You didn't chase him into 308 or any other house that night? A No sir.

to your Honor's sense of right not to permit this witness
to be cross questioned unless it is on matters material

THE COURT: 'I don't see why it should affect him at all. All he is to do is to tell the truth and then tell the truth when his trial comes up.

- Q One of these ordinary plain clothes policemen?

  A Yes sir. They refused to let him in.
  - Q Who was it refused to let him in? A Well --
- That was Brown here, it was his house and he was probably the man? A I think it was Brown, either Brown or Samuels refused to let him in because --
- C This defendant's name is Samuels, of course? A Yes
  - Q It was Samuels refused to let him in? A Yes sir.
  - Q It was his house there? A Yes sir.
- Q Now, what did Samuels say when he refused to let him in? A He said, there was not any row here.
- O Nobody in there that was wanted, is that what he said?

  A Yes sir.
- What did the officer say? A The officer said, he wanted to come in. There was some fighting done downstairs and to let him in.
- Q Didn't he out there at the door say he was an officer?

  A Yes sir.
- Then, what did Samuels say when the man said he was an officer? (No answer).

What did Samuels say, the owner of the house? A He didn't say anything but let him in.

Q Did anybody else come but the plain clothes man besides that one at the door? A The cop I think was there, one cop.

Q At the start out, Mr. Thompson, right at the beginning? A Yes sir, there was.

Q About how many were there at the beginning? A I didn't see anybody who was there at the beginning because I was sitting down at a table in the room. I was playing.

Q About how many were there there afterwards? A I couldn't say.

Q' How many officers came there after a while? A About two, I think.

Q About two? A Yes sir.

Q Did you see any more at any time? A Well, we was taken out of the house after. Then, I seen about three or four of them.

Were they upstairs there on the same landing, some of them? A Yes sir.

Q Did you hear the officers say anything to this defendant? A If I heard the officer say anything to this defendant?

- Q To this man here, Samuels? A No sir. I heard the officer say when he came downstairs, he said, "Let us arrest the bunch" he said, calling us names.
- Q Did you hear the officers say anything to Samuels?
  - Q You didn't hear him say anything to him? A No sir.

  - Q None whatever? A No sir.

- Q Was Ed taken to the station house? A No sir.
- Q He was there when the officers came? A Yes sir.

HENRY DON PIERRE; a witness called on behalf of the defendant being duly sworn testifies as follows: DIRECT EXAMINATION BY MR. BROWN:

Q Where do you live? A 213 West 63rd Street.

- Q Your name is Henry DonPierre? A Henry DonPierre.
- Q Where do you live? A 213 West 63rd Street.

- Q What position does he hold in that hotel? A When
  I first came there he was an elevator boy then he was transferred to the laundry as washing boy.
- Q Down in the laundry how many years? A Since the laundry opened about two or three years as near as I can remember.

- Q Do you know his reputation for peace and quiteness?
  - Q What is that reputation? A The best that I can say.
  - MR. MANLEY: I object to that as incompetent and immaterial.

BY MR. BROWN:

- Q As you know of? A As I know of him in the hotel, as far as I know.
- Q Has he fulfilled his duties there in the hotel every day? A Yes sir, every day, always there. I always saw him.

- Q Never saw any signs of liquor on him? A No sir, never.

#### BY MR. BROWN:

BY A JUROR:

Q Did the manager ask you to come down here?
Objected to.

JOSEPH SPROVE; a witness called on behalf of the defendant being duly sworn testifies as follows:

DIRECT EXAMINATION BY MR. BROWN:

- Q Where do you live? A I live at 16 West 134th Street.
- Q Do you remember the 15th of last May? A Yes sir, I
- Q Do you recall where you were on the evening of the 15th of last May? A I do.
  - Q Where were you? A At a party, 62md or 63rd Street --

- Q What street was it? You remember what street it was? (No answer).

- Q With fifteen others? A Yes sir, I was arrested with the others that was in the party.

  - Q All were arrested? A Yes sir.
- Q Do you remember what street that was? A I think it is 62nd Street.
- Q 62nd Street? A Yes sir, I don't know that is the first time I had been there that night.
- Q Was it the home of this boy Samuels? A Yes sir of Brown.
  - Q Ever been there before? A No sir.
  - Q Was Samuels there? A Yes sir, he was.
- Q Was it 69th Street? A Yes sir. This residence was on 69th Street -- I don't know. I was just taken there being a stranger in that neighborhood completely.
  - Q You were a stranger there? A Yes sir.
- Q Did you go there with anyone? A A friend took me there.
  - Q With a friend? A Yes sir.

- Q Now, do you remember seeing Samuels there? A Oh, sure he was there.
- Q Do you know his brother? A Well, I met him that night for the first time.
- Q What was his name? A Samuels, that is the name was given to him.
- Q Do, you remember the first name? A Well, I don't remember his first name.
- Q You only met him as you said that night? A Yes sir, for the first.
- Q Do you know Charlie Roberts? A Sure I do. I met him for the second time.
- Q What time did you get to that party that night? A I got there about eleven or a little later.
  - Q Eleven or a little later? A Yes sir.
- Q What friend was it that you went there with? A Mr. Legar called at my home and took me down there.
- Q Mr. Legar? A That is to the surprise party I went with him.
  - Q He called at your home? A Yes sir.
- Q How long have you been in New York? A It is in the third year now.
  - Q The third year? A Yes sir.

THE COURSE

- Q Do you live at the same address now as you did then?

  A I live at 173 West 126th Street.
  - Q West 126th Street? A Yes sir.
  - Q You went from there to this place? A Yes sir.
  - Q Got there at eleven o'clock? A Yes sir.
- Q Do you remember Charles and Edward Samuels going out at any time that night? A We were all sitting down and talking that it was too cold for a storm and just then this boy said, he would get a guitar and that fellow met some friend whom he knew and then he left.
  - Q Who left? A Samuels.
  - Q Left for the guitar? A Yes sir.
- Q What time was that? A It was around one o'clock or so. I didn't know the correct time.
- Q Did anyone leave with him? A No sir, he is alone. He left the balance of the company in the house.
- Q Do you remember how long it was before he returned?

  A Well. I didn't take any notice of the time but he was a long time gone.
- Q Did he finally return? A Yes sir, with a guitar; he returned with a guitar.
  - Q Did he have a guitar? A Yes sir, in his hand.
  - Q Did you see a guitar? A I saw the guitar.

SHARCHING

- Q Did you see Ed Samuels? A I seen Edward Samuels.
- Q When he returned? A Yes sir.
- Q What did you observe about his appearance? A That there was blood somewhere about his person.
  - Q What part of his person? A His face.
  - Q His face? A Yes sir.
- Q Was there any blood on his clothing? A Well, I didn't minutely look at his clothes because he only presented his head from the distance where he was. I saw his face and on his face there was blood.
- Q Did he sit down in that place? A No sir, he didn't sit there. Just spoke to his brother. There was some dispute and his brother left with him and he left the guitar and went right out.
- Q Who else went out with his brother? A His brother and Charlie Roberts.
- Q Did anybody else leave besides those three? A No sir. only those three.
- Q Where was the guitar in that room? A They put the guitar down. It was left in the same house,
- Q How long after Roberts and the two Samuels left there -- how long were they gone before they returned? A What was that question?

AND CHAIL

- A How long after Roberts and the two Samuels went out -how long were they out before they returned? A I don't know
  how long they were out before they returned. When they did
  not
  come back only Roberts and that Brown came back. I have seen
  the other Brown whom I met for the first time that night until now.
- Q The third man, Ed Samuels? A I haven't seen him until now.
- Q But this Samuels and Charles Roberts returned?

  A Yes sir.
- Q Can you give this jury any idea how long Charles
  Samuels and Charles Roberts were out of that house with Ed
  Samuels? A Well, it wasn't any considerable time. We all
  got together quite soon again.
- Q Can you give me any idea if he was out an hour or half an hour or fifteen minutes? A Well, I can't accurately say what time it was till they came back, but I know they came back again. I didn't see what time they came back.
- Q I ask you if you could tell me how long they were out of the house, Charles Samuels and Charles Roberts? A I don't remember the time.
  - Q You can't remember that? A No sir.

THE CHES

- Q When they both returned, got back into the house, did Charles Samuels and Charles Roberts go out again?

  A They didn't go out again until we was arrested.
- Q How long after they came back into the house was it that they were arrested? Can you give us any idea how long that was -- was that an hour or half an hour or within an hour? A Within half an hour.
- Q Before you were arrested? A Yes sir, before they were arrested.
- A How long was it do you think before he came to the house or the time that Charles returned until you all got to the station house? A What time it was?
- Q Yes? How much time elapsed from the time that Charles
  Roberts and Charles Samuels returned to the house? Do you
  understand? A Yes sir.
- Q And you were all arrested, was it before you got to the station house? A It was around about the morning positively but I do not know the time. I didn't keep any tract of the time on that night. I don't know when Samuels returned with the guitar. He was gone -- these two fellows; but as to the time I kept no tab of it.
- Q That is your best recollection as to the time? A Yes sir.

- Q When you were arrested? A Yes sir.
- Q How many women were there? A Well, as I said I was a stranger to the entire folks nearly, and I can hardly can memorize how many women.
  - Q How many? A Well about four or five women.
- Q Were those women and men carried to the station house that night? A Yes sir.
- Q Were you arraigned before the magistrate next morning? A Before the magistrate?
- Q Before the magistrate in court the next morning?

  A Yes sir.
- Q How long did you remain in the magistrate's court locked up there? A Locked up?
- Q When were you discharged, were you discharged Monday morning? A (No answer).

THE COURT: Haven't we been all through that part of it? There seems to be no dispute that they were all locked up and they were discharged later, or most of them discharged. Do you think it is necessary to go over that again? Go right ahead.

MR. BROWN: I want to get this clear.

THE COURT: I don't think it is necessary, we have all that here. I do not think it necessary to ask

of this witness. It is not necessary to have him testify to something that is not disputed. All of them were arrested and you may put that in the record that they were taken to the police station and were taken before the City Magistrate next day. It seems to me that if you put fifteen witnesses on the stand it wouldn't be of any greater importance than if you called one. For my part I do not see the good of it.

MR. MANLEY: I admit that all those that were in the house at 329 were taken to the station house.

- Q You say you were a stranger to everybody there that night, Mr. Sprove? A Yes sir.
- Q You simply got an invitation from Mr. Legar? A Yes

- Q You met this man, this defendant here for the first time, didn't you? A No sir, I met him about the second time.
- Q It was Roberts that you met the second time? A That was the first time and his brother for the first time.

- Q His brother for the first time? A Yes sir.
- Q You got there at what time? A Well, I actually don't remember what time.
  - Q About? A About eleven o'clock.

  - Q Were you in Samuels house? A Yes sir.
- Q From what time were you in there? A From about a quarter after one.
  - Q A quarter after one? A Yes sir.
- Were you there in that room -- do you know Ed Samuels?

  A Yes sir, I do.
- Q How long have you known him? A Well, I have known him quite a while.

THE REAL PROPERTY.

- Q Do you know him one day or one week or one year or what? A Well, about twelve years, twelve or thirteen years.
  - Q Do you know Charles Samuels? A Yes sir.
- Q How long have you known him? A Just about the same time.

- Q What time was it when you saw him there? A A quarter before one like that.

- Q Did you notice the condition of Samuels face? A Yes sir, I noticed the condition of his face.
- Q What was the condition of Samuels's face? A His lip was all swollen and he had a cut over his eye.
- Q Did you see any blood? A Yes sir, I saw it on his clothes, on his coat.
- Q Did you see any blood on his face? A Yes sir, over his eye one cut was.
  - Q Did you observe that yourself? A Yes sir.
- Q How far away were you when you saw it? A About as far as I am standing or sitting here to you.
- Q Did Samuels sit down in that house at all if you remember? A No sir, he didn't sit down there.
  - Q Did he go out? A He went out.
- Q Did anybody leave with him? A Yes sir, his brother left with him and Charles Roberts.

THE CHIEF

- Q Who? A His brother.
- Q His brother? A Yes sir, his brother Charles.left with him.
- Q The three left the house? A Yes sir, the three left the house.
- Q Do you know how long the three were out of the house or out of that apartment before they returned? A Well, I don't know exactly what time it was.
- Q How long were they out of that apartment? How long were they away from the house before they returned? A They were out about four minutes or longer than that.
  - Q Were you in the house when they returned? A Yes sir.
- Q Who returned? A Well, that man returned and Roberts too.
- Q Did Ed Samuels return to? A I didn't see him. I haven't seen him from that time until now.
  - Q Have you seen him since? A No sir.
  - 2 Do you know where he is? A No sir.
- Q You say you knew Ed Samuels before that, twelve years ago? A Yes sir.
- Have you seen Ed Samuels frequently before this night?

  A Yes sir.
- Q Do you know where he worked? A He used to work at the church on 73rd Street, the Rutgers Church.

THE RESERVE

- Q Do you know where he worked at that time? A No sir.
- Q When you had seen him before this night? A I had seen him --
- Immediately before this night? A I seen him that night because he came to me just about the same time I got home from work.
- Q He lived in the same house that you lived in? A Yes sir, he lived two flights above me..
- Q Well, Mr. Henry, if Charles Roberts and Charles
  Samuels came back to that house, how long were you there before the officers came in? A For an hour before the officers
  came in.
  - 2 Before the arrest was made? A Yes sir.
  - Q That was about how long? A About half an hour.
- Q What time was it when you got to the station house?

  Q I don't know the time. It was morning when I,got to the station house, it was daylight.
  - Q When you got to the station house? A Yes sir.
- Q You say Samuels left there about a quarter past one for that guitar? A Yes sir.
- Q And he returned it about what time? A He was gone fully an hour.
  - ? What is that? A He was gone fully an hour.

SHARCEDEST

- Q That would be twenty-five minutes after two when he returned? A Something about that time. There wasn't any clock in the house. I am just guessing at the time, twenty-five minutes after two.
- Q You say after that Charles Samuels and Charles Roberts went out with Ed Samuels? A Yes sir.
- Q How long was it before they returned? A About half an hour.
  - Q They returned in half an hour's time? A Yes sir.
- Q Now, the question I am asking you is: How long was Charles Samuels and Charles Roberts in the house before the officer came and arrested all of you? A I don't know how long they were in the house, before they were arrested because they came there ahead of me. I came in at a quarter of one as I, said before.
- Well, I am asking you about when Charles Samuels came back when you were arrested in the morning? A Yes sir.
- Q How long had Charles Roberts and Charles Samuels got back from the street before you were all arrested? A Well, they got back about half an hour,
  - Q About half an hour? A Yes sir.
  - That is the best of your judgment? A Yes sir.

Q Now, was there anything to drink in that house?

A Yes sir.

- Q Was anybody intoxicated? A No sir, nobody at all -- not that I know of.
  - Q Did you partake of any drinks? A I did.
- Q What did you drink, whiskey, beer or what? A I had some beer.
- Q You say that the people were not intoxicated? A No sir, nobody sir.
  - Q Were they disorderly in any way? A No sir.
- Q Do you know what happened when the officers came to the door and demanded admission there? Did you see the officers? A I seen them when they came in.
- Q Were they dressed in uniform? A Well, two of them were not.
- A Well, somebody said -- he said he was an officer and they said, "Show me your badge," and he said, it wasn't necessary.
  - Q Did you see his badge? A No sir.
- Q Did you the badge on these two officers at any time that evening? A No sir.

# CROSS EXAMINATION BY MR. MANLEY:

Q Can you tell us about what time it was when they seen

to get at a little beer? A They didn't send out for any beer at all.

C Pretty positive as to that? A Everything was in the house.

Q How much beer was in the house? A They had a couple of crates of beer, about two and a half crates of beer.

Q Positive there was two and a half crates there?

A Yes sir.

Q One crate and a little more? A No sir, one crate wasn't there.

Q I don't suppose you said a word to Samuels here about this case since n as it happened? A No sir, I haven't said anything to him about it.

- Q Haven't said anything to his friend? A No sir.
- Q Haven't said anything to any witness? A No sir.
- Q Haven't talked to anybody about it? A No sir, I have not.
- Q Had Edward lived there for some time before the 15th of May? A Yes sir.
- Q About how long? A He lived there about two months or three months.
- Q Don't you talk to him? A Yes sir, I lived up the street then, and then I moved a little lower down.

RESIDELL!

- Q Then, there was no disturbance of any kind in the house that night? A No sir, no disturbance at all.
- Q Nobody made any resistance when the officers came in there? A No sir, nobody made any resistance.
  - Q Neither man nor woman? A No sir.
- Q Did you see Roberts take a stick or a club when he went out? A No sir, I didn't observe anything.
- Q Didn't take anything at all? A No sir, cidn't hit him with anything.
- Q You saw him when he went out? A Yes sir, but I didn't see him have any stick.
- When you got to the station house did they have you in a line there? A Yes sir, sitting down.
  - Q Weren't you picked out? A No sir.
  - Q You were discharged? A Yes sir.
- C Did they pick them out of the line? A They were all sitting there.
- Q How far away were you when the officer did that? A I was sitting down in the line.
  - About seven or eight feet away? A Yes sir.
- Q Nothing took place when the officer picked somebody out? A There was some foreign -- there were three other fellows there.

- Q Italian fellows, weren't they? A Yes sir, I think they were.
- Q They spoke right up to the officer? A Yes sir, he was looking at the fellows for quite a while. He was looking at them and he pulled that fellow out.
- Q That is after the Italian fellow had said something to the officer? A I didn't hear them speaking to him.
- Q I wont ask you what he said? A They said something to him.
  - Q They were talking to the officer? A Yes sir.

### REBUTTAL

JOSEPH A. LEONARD; a witness for the people being called in rebuttal testifies as follows:

DIRECT EXAMINATION BY MR. MANLEY:

- Q I show you this paper and ask you what it is? A It is a record of the police blotter in the station house, giving the record of this arrest, May 15th, 1911.
  - Q Also the names of those arrested? A Yes sir.
  - The names they gave? A Yes sir.
  - Objected to. Objection overruled. Exception.

THE WITNESS: No sir, it does not.

MR. BROWN: I object to this. It is not in evidence and I haven't seen it.

MR. MANLEY: I am not offering it in evidence.

MR. BROWN: I accept your Honor's suggestion.

#### BY MR. MANLEY:

- Q Use it to refresh your memory. When the man was arrested he gave the name of James Smith? A There was no man gave the name of James Smith.

  - Q You were in citizens' clothes? A Yes sir.
- Q You were one of the officers that went there and arrested these people? A Yes sir.

- Weren't you in uniform? A No sir, citizens' clothes, your Honor.

ARREST DE LES

JOHN MESSO; a witness for the people being called in rebuttal tratifies as follows:

### DIRECT EXAMINATION BY MR. MANLEY:

Now, you are John Messo. At the time when you were being chased by this defendant Brown and at the time when you saw Roberts running up the street while going into this house or stable you staid on the other side of the block?

How many colored people did you see there on the street?

A About six.

## BY MR. BROWN:

- Q You are the man who went into the water closet and staid in there one hour? A Yes sir.
- Q Is that why you went into the water closet and staid an hour? A Yes sir.
- It wasn't because you attempted to hold up the defendant and his brother and you were trying to keep away from the police? A No sir, I didn't have anything to do with the police.
  - Q Why did you go over the roof?

MR. MANLEY: I object to that as not being proper rebuttal.

CHARLES KOSTER; a witness called for the people in rebuttal testifies as follows:

DIRECT EXAMINATION BY MR. MANLEY:

Q Mr. Koster, at the time when you were running down the street towards 316 on the corner of 69th Street, did you see a man named Citrone? A Citrone? I did not.

Q When was it you did see Citrone?

Objected to as not being in rebuttal.

THE COURT: I don't know what the object is. I can't guess at it.

  - Q That is your house? A Yes sir.
  - Q You lived at that time where? A 311 West 69th Street. (TESTIMONY CLOSED)
