Q And the doorway is about two feet wide, isn't it, or about three feet wide? A About three feet, I guess.

Q It took you ten seconds to walk four feet and the three feet width of the door, it took ten seconds to walk four feet?

MR. WELLER: I object to it, he says he does not know.

THE COURT: The jury cand raw whatever inferences they wish.

- Q Did you stoop down and watch him lock that door?

 A No.
 - Q Just walking by you saw him lock it? A Yes sir.
 - Q And he got about seven feet, you say? A Yes sir.
- Q Passed his door. By that time you were entirely.—
 past his store, were you not? A Right by the shoemaker's,
 there.
- Q The shoemaker's place is only separated from Goodmark
 by a little iron partition that wide, about six inches?

 A Yes, sir.
- Q Separates Goodmark's from the other fellow's place; is that right? A Yes, sir.
 - Q You always mind your own business? A Yes, sir.
- Q You never want to get in trouble with anybody?
 - And you walked by and there was nothing the matter

with Goodmark's place at that time? A No, sir.

- Q Then you turned around? A Yes, sir.
- Q What made you turn around? A Just happened to turn, that is all.
- Q It was a purely accidental matter that you turned around and you saw smoke coming out of Goodmark, s place?

 A Yes, sir.
 - Q And you ran up after @ odmark? A Yes, sir.
 - Q He had a package in his arms? A Yes, sir.
 - Q You said, "Goodmark" -- what did you say?
- A I said, "Grankmark, your store is on fire.
 - Q Did you call him by his name? A No.
- Q You tapped him on the shoulder and said, "your store is on fire", and did he think -- after, what did you do?

 A After, I toki him the first time he would not listen to me.
 - Q You didn't go on away? A No, sir.
 - Q You kept right next to Goodmark? A yes, sir.
 - Q All the time? A Yes, sir.
- Q And when he got fifty feet away you said, "your store is on fire", again, is that right? A Yes, sir.
- Q You were next to him all the time; you were not going to let Goodmark away, were you? A No.
 - Q You got up to the corner? A Yes, sir.
 - Q You were next to Goodmark then? A Yes sir.

- Q Had Goodmark turned the corner? A Yes, sir.
- Q And when he didn't come back after he turned the corner, you grabbed him by the shoulders and pushed him back?

 A Yes, sir.
 - Q He had his bundle when he left the store? A Yes.
- Q You were right behind Goodmark all the time?

 A Yes, sir.
 - Q What happened to the bundle? A I do not know.
- Q You were within two feet of Goodmark all the time and you didn't know what happened to the bundle?

MR. WELLER: I object.

(No ruling)

RE DIRECT EXAMINATION BY MR. WELLER:

Q After Goodmark left the store and you told him the first time, your store is on fire, did you walk alongside of Goodmark all the time? A Back of him the first time.

MR. JOSPPHS: I object to that on the ground it is leading.

THE COURT: Objection overruled.

MR. JOSEPHS: Exception.

- Q He continued to walk towards Lexington Avenue, were you walking alongside of him all the time? A Yes, sir, pretty near alongside of him.
- Q Did you see whether or not he went into a saloon on the corner? A No, sir.

Q Did you see him all the time until the second time you spoke to him? A Yes, sir.

Q You never took your eyes off him at all?
No. sir.

Q So you don't know what became of the package?

A No sir.

MR. WELLER: That is all.

BY MR. JOSEPHS:

- Q Did he go into any saloon? A I didn't notice.
- Q You would have noticed him if he had?

 MR. WELTER: I object to that.

THE COURT: Sustained.

- Q There are a lot of boys around that neighborhood?

 A Yes, sir.
 - Q A good many boys? A yes, sir.
 - Q And like all young boys they play around the street?
- Q They are good boys around there, they are not bad ones?

MR. WELLER: I object to that.

THE COURT: Sustained.

- Q Did you ever see these men annoy Goodmark in his store in any way? A No, sir, I never seen them in his store.
- Q Have you ever heard of his being annoyed?

 A No, sir.
 - Do you ever play around that neighborhood?

- Q You have friends in that neighborhood? A Yes sir.
- Q And is that what you call your hangout, that is where you hang out on that block? A Yes, sir.
- Q Have you ever been chased away from hanging around that street? A No, sir.
- Q Anyway, you hang out on that block? A Right at the corner of 75th Street and Third Avenue, on the northwest corner.
- Q What kind of a place of business is there?

 A Liquor store on the corner.
- Q You hang around the liquor store? A I don't hang out there. I am on the side of 75th Street.
- Q That is right by the liquor store, by the private entrance? A Yes, sir.
- Q And other boys of your age hang around there, this liquor store? A yes, sir.
- Q Have you ever been arrested? A No, sir, never have BY THE COURT:
 - Q How old are you? A Seventeen years.

BY MR. JOSEPHS:

- Q You live with your father and mother? A Yes, sir.
- Q How long have you been working for Esche, for about a week? A Yes, sir.

Q And you worked for Mr. Gittermann --

MR. WELLER: I object to this as not proper recross examination.

GERALD GRIFFIN, called as a witness and being first duly sworn, testified as follows:(I reside at 212 East 72nd Street)

DIRECT EXAMINATION BY MR. WELLER:

- Q Mr. Griffin, what is your business? A I am a barkeeper.
 - Q Where abouts? A 1057 Lexington Avenue.
- Q Is that at the corner of 75th Street and Lexington Avenue? A Yes, sir.
 - Q Northeast corner? A Northeast corner.
 - Q Do you know the defendant, Mr. Griffin? A Yes sir.
- Q How long have you known him? A Since I have been working there.
 - Q How long? A Almost four years.
- Q He came into your place occasionally, did he?

 A Occasionally, yes, sir.
- Q Now on July 5th of this year, about half past six in the evening where were you?

MR. JOSEPHS: 5th of July?

MR. WELLER: Thank you. The 5th of July.

THE WITNESS: I was behind the bar working.

- Q And did you see the defendant at that time? A Yes.
- Q Do you know what time he came in? A Well, it was about half past six, somewheres in that neighborhood, the exact time I could not state.
- Q And what, if anything did he say to you?

 A Why, he had a bundle with him, he put it on the bar and asked me to keep it for him.
- Q Is this the bundle (showing)? A I think that is the bundle; I could not be positive; I think it is.
 - Q Step down.

(The witness steps down)

THE WITNESS: It is a bundle such as that (indicatiing)

- Q Similar to that? A Yes, sir.
- Q A large bundle? A A bundle I could see, like a suit case, wrapped up.
 - Q And what did he say to you when he came in?
- A He asked me to take care of the package for him.
 - Q Anything else? A No, that was all.
 - Q Just asked you to take care of the package?
- A Put it on the bar and me to leave it for you.
 - Q Then what did he do? A He walked out.
- Q Which entrance, do you remember? A Yes, sir, on the Lexington Avenue entrance.
 - Q This is what occurred when he came in first, he put

at the door and they hollered "chase him out", and as I saw he brought in the bundle, he gave it to me, and he walked out.

I could hear noises. He said, "I didn't know there was a fire. I could hear noises, excitement, so I walked to the front door, on 75th Street and I looked around and Isaw the engine there and a big crowd of people.

- Q The engines were already in front of the premises?

 A Yes, sir.
- Q That was after he left the package on the bar?

 A Aminute or two.
- Q You took the package and put it under the bar and walked out the 75th Street side and the engines were there at that time? A Yes, sir.
- Q And he went out of the Lexington Avenue side again?

 A Yes, sir.
- CROSS EXAMINATION BY MR. JOSEPHS:
- Q He brought this package in to you, you say at half past six, it might have been twenty to seven? A I could not say the exact time.
 - Q It was around that time? A Yes, sir.
- Q When he brought that package in to you, at the time he brought it in there was a lot of excitement? A Not at all
 - Q At the time he brought it in? A Not at all.
 - Q How long after he brought it in there was there

Q Yes. A I did not know there was any excitement when he brought it in. I didn't hear a word or a noise of any kind. These youngsters chased him in, but they hollered, "chase him out".

BY THE COURT:

- Q In other words, the moment he had entered your place with the package, there were youngsters after him calling out to you, "chase him out"? A Yes, sir.

 BY MR. JOSEPHS:
- Q They were all after him at that time when he brought it in, you are sure of it? A As he came to the bar and put it in I could hear these boys outside the door, yes, sir.
- Q And he went out Lexington Avenue? A He came in right in that door and went out that door immediately.
 - Q The Lexington Avenue side? A Yes, sir.
- Q Now, Mr. Griffin, do you know whether the fire had already started when he brought that package into your store?

 A It must have been, because I went to the side door.

MR. WELLER: This is speculative, if your Honor please.

BY THE COURT:

- Q You went immediately to the door? A Yes sir.
- Q And looked out? A And the engines were already there.

BY MR. JOSE PHS:

- Q And the engines were already there? A Yes sir.
- Q It was only the time it took you to walk to the door to see the engines was the time it took you to walk from your bar out of the side entrance to look? A Just about that time.
- Q How long a distance is that?

 BY THE COURT:
- Q How far did you walk to your door? A About thirty-five or forty feet.

BY MR. JOSE PHS:

- Q All you walked from was where you are sitting to that tailing (indicating)? A About that distance.
- Q And the fire engines were already there?

 A Yes, sir.

MR. JOSEPHS: That is all.

MR. WELLER: Just one more question, Mr. Griffin.
BY MR. WELLER:

- Q I neglected to ask you if he came back for that bundle? A Yes, sir.
- About what time? A About five or ten minutes after he first brought it in. When I went to the side door and saw the excitement and I came in and stood behind the bar.

 I was there only afew minutes more when he came back and asked me for the bundle. I turned it over. He went out, came

in the Lexington Avenue side.

Q Anything else said? A I said, "What is the matter? Is your place on fire?" He practically made no answer. He was excited.

BY MR. JOSEPHS:

Q He was very much excited.

MR. WELLER: One moment. BY MR. WELLER:

Q Then he took the package and went away? A Then he took the package and went out again.

HARRY GORDON, called as a witness on behalf of the people, being first duly sworn, testified as follows:(I reside at 329 East 77th Street)

DIRECT EXAMINATION BY MR. WELLER:

- Q Where do you live? A 329 East 77th Street.
- Q Mr. Gordon, you live in East 77th Street? A Yes sir.
- Q Between what Avenues? A Between First and Second.
- Q And do you know the defendant Jacob Goodmark?
- A Yes, sir.
 - Q How long have you known him? A About eight years.
 - Q. Were you and he friends or just acquaintances?
- A . No, sir, he was about three years a tailor in the same building where I have my business.
- You had business relations with him and you were also friendly with him? A' No business relations, no

- Q On the 5th of July of this year did you see Jacob Goodmark? A Yes, sir.
- Q And what time was it when you saw him? A I didn't pay attention what time, I knew it was late in the afternoon, very late.
- Q About what time was it? A Because I was, I have a retail business, I was in my store, the boy was off, and I was waiting for customers; I didn't pay any attention to what time it was.
- Q About what time was it? A I know it was very late,
 I could not tell you exactly.
- Q I didn't ask you to tell me exactly, about what time? A I don't remember; I didn't take notice, if any-body asks me what time it is I have to look around to see the clock.
- Q I understand. But can't you tell me about what time it was? A It was after -- that is later, it was pretty near to supper time.
- And what did he say when he came to your store?

 A He brought in a suit case and he said, "Mr. Gordon, if I can leave it for a while, this suit case here."

THE COURT: Mr. Witness, those jurors there find it very difficult to hear what you have to say. Can you speak a little louder?

THE WITNESS: (Continuing) He brought in a suit case and he asked me if he could leave the suit case here. Iwas there with customers and I said all right, put it there.

- Q Now, Mr. Gordon will you step down here? A Yes sir.
 (Witness steps down)
- Q Is that the suit case he brought in that night?

 A It was closed.
- Q You didn't open it up to see what it had inside; does that look like the outside of the package, about that size? A It was about that size, just a suit case.
 - Q Was it about that size? A Yes, sir.
- Q Did it look like that -- did you see him come back to get this package, Jacob Goodmark? A No, he came around a certain time you understand, and he told me there is a fire in his store.
- Q What is that? A He came back in a short time and he heard it is a fire in his store.
- Q Now the first time did he tell you there was a fire in the store when he left it, did he tell you there was a fire in the store when he left it? A I don't remember.
- Q When he left this suit case in your place, did he tell you there was a fire at his store? A. I don't remember that, because I was doing my trade, tending my customers.
 - Q Now how long after was it when he came back to

- Q How many minutes or hours? A Maybe about fifteen minutes.
 - Q Fifteen or fifty minutes? A Fifteen minutes.
- Q And he came back after fifteen minutes, was anybody with you or him? A Nol only himself.
- Q What did he say to you then at that time?

 A There is a fire in the store.
- Q What did he tell you? A He said there is a fire in his store.
- Q What else did he say? A I said you should go back to the store and see what the trouble was.
- Q You told him to go back and see what the trouble.
 was? A Yes, sir.
 - Q What did he say? A He went back to the store.
- Q Did he leave that with you? A That was still left in the store.
 - Q Did you see him again that night? A No, sir.
- Q Did the detective come to your store? A The next morning.
 - Q And did you give the bundle to the detectives?

 A My boy gave it to them.

THE COURT: No, no.

Q Your boy?

MR. JOSEPHS: Your Honor, I withdraw my objection.

CROSS EXAMINATION BY MR. JOSEPHS:

Q Now Jacob Goodmark brought that bundle around to your place, it was after half past six, wasn't it; it was nearer to meven o'clock? A It was about that time.

MR. WELLER: Mr. Witness I would like you to talk loud so that we who are down here could hear you.

- Q Now you were busy with customers the first time he came in? A Yes, sir, I was serving customers.
- Q And he didn't have much of an opportunity to talk to you, did he? A No, sir.
- Q And he may have said that there was a fire in his place the first time, did he? A I don't remember that.
- Q But you would not swear that he did not? A I can not swear yes or no.
- Q But a few minutes later and he came back to you and said, "there is a fire in my store", and you said, "you had better go back and look after your property; is that the idea?
 A Yes, sir.
- Q And he went back to look at this property?

 A Yes, sir.
- Q That is all you know about this? A Yes, sir.

MR. JOSEPHS: That is all.

MR. WELLER: You also know about this bundle--addressing the defendant.

(No response)

THE COURT: I think we will take a recess now until a quarter past two.

Gentlemen of the Jury you are admonished not to converse amongst yourselves on any subject connected with this trial, form or express no opinion until the case is finally submitted to you.

Whereupon the Court adjourned at one o'clock until a quarter after two P. M.

AFTER RECESS.

WILLIAM J. McCAEERTY, called as a witness on behalf of the people, being first duly sworm, testifies as follows:- (Fourth Branch Detective Bureau)

DIRECT EXAMINATION BY MR. WELLER:

- Q What is your name? A William J. McCafferty.
- Q You are assigned to the detective bureau of the police department of the City of New York? A I am.
- O And were you so assigned on the 5th of July of this year? A I was on duty.
 - Q Were you assigned to this case? A I was.
 - Q Did you go to premises 155 East 75th Street?

No, I did not.

- Q Where did you see the defendant? A At the fire department, East 67th Street.
 - Q Did you have a talk with the defendant at that time?

A Yes, sir.

MR. JOSEPHS: I object on the ground that the law strictly prohibits testimony as to an investigation whether done by fire insurance companies or other bodies as strictly a subterfuge to overcome that law.

THE COURT: It appears on decisions that the conversation is receivable. In other words if there is not some objection other than the one you name, the evidence is receivable.

MR. JOSEPHS: Exception.

- Q Was the defendant then under arrest? A No.
- Q What did you say to him and what did he say to you?

 A I said, "Mr. Goodmark, do you know of the fire occurring there?" He said, "No." I said, "Did you have any business difficulties?" He said, "No business was good here, but I intended to open up a place in Asbury Park". I said, "Did you owe any money?" He said, "No, only for the help", and afterwards he said that he owed several gas bills.
- What is that? A That he owed for several gas bills. I asked if he had any business in the premises recently. He said, "no". He didn't do any for two weeks previous. I asked if he was had a bundle, did he take a bundle out of the store with him." He said, "Yes, that he took that bundle over." I said "What did it contain?" He said, "One suit of clothes". The following morning--

Q Wait a moment. Did you go to the defendant's house?

- A No, I did not.
- Q Do you know if one of the other detectives went there?

MR. JOSEPHS: I object to that. He was not there himself.

THE COURT: Sustained.

- Q Where did you go the following morning? A I went to premises, I believe 1101, at 72nd Street and Lexington Avenue, northeast corner, a stationary store, conducted by a man named Gordon.
- Q That is the one that testified here a short while ago? A He was not there at the time, his son was there.
 - Q What did you get there? A I got a bundle.
- Q Is this the bundle (showing) a paste board box?

 A I believe that is the box.

MR. WELLER: I offer it in evidence.

MR. JOSEPHS: It was not in that condition: then.

THE WITNESS: No, it didn't have the paper on.

- Q What do you mean? A Just the gardxgm.card paper box.
- Q Now where has this been ever since that time?
- A In the fire marshal's office, I believe.
 - Q Did you open the bundle at that time? A I did.
 - Q Will you state what the bundle contained? _
- A The bundle contained three suits of clothes and I believe thirteen ties and an insurance policy on his house in 77th

Street, the Germania Insurance Company, I believe.

MR. JOSEPHS: I object to that. I want to know what that bundle looked like when he got it.

- Q Will you set down here-(The witness does so)
- Q Is this paste board box the one you refer to?

 A Yes, sir.
- Q Was it in that condition, detective, when you got it, was it torn or whole? A I am not positive whether it was torn or whole; it was tied up. I opened up the package and in the brown coat, inside pocket I found an insurance company policy of the Germania Fire Insurance Company.
 - Q Is that the policy (showing)? A Yes, sir.
 - Q Now, where are the neckties?

(Producing)

MR. WELLER: Now I offer the bag, the paste board box, three suits of clothes and the meckties and fire insurance policy in evidence.

MR. JOSEPHS: Were these pieces of cord around when you found it, or did you put them around?

THE WITNESS: I don't think they were around at that time.

(The above enumerated articles were received as one exhibit and marked people 's exhibit No. 11 in evidence.)

MR. WELLER: The policy, three suits of clothes and a quantity of neckties, the insurance policy on the

Germania Insurance Company of New York, Jacob Goodmark for \$1,000. for three years on all household furniture bed and bedding, carpets, wearing apparel, etc., situated at 243 East 78th Street.

MR. WELLER: I think you will concede that.

MR. JOSEPHS: That is where he lives?

MR. WELLFR: Yes.

MR. JOSEPHS: Not the policy on his store?

MR. WELLER: Of course not.

MR. JOSEPHS: \$1,000. on his house and home.

Q You say that this was found in the package in the pocket of the brown coat? A The inside pocket.

Q Now, did you later have a talk with the defendant?

A Yes, sir, I brought that bundle down to fire headquarters and in the presence of the defendant and I believe the fire Marshals Finn and Cashman, I said--

MR. JOSEPHS: One moment. I object.

THE COURT: Something said to the defendant?

THE WITNESS: To the defendant.

MR. JOSEPHS: In the presence of the fire marshal?

MR. WELLER: Was it an examination by the fire

marshal under oath?

THE WITNESS: No, I don't believe it was.

A It is just a question I asked the defendant.

- Q It was not a question that the firem rshal asked the defendant? A No, sir.
- Q Well was the defendant at the time being examined by the fire marshal? A No, not at that time.
- Q Had the examination of thed efendant by that time by the fire marshal been begun? A Yes, sir, but not under oath.

THE COURT: I think there is some doubt.

A Very well, I was not asked a question.

CROSS EXAMINATION BY MR. JOSEPHS:

- Q Now Mr. McCafferty, those suits were in a nice hand package, weren't they, when you saw it? A Yes, sir, a neat package.
 - And they fitted in the box nicely? A Yes sir.
- And the box was not in such a condition as it is now?

 I don't think it was as far as I remember.
 - Q Now you asked the witnesses -- I will withdraw that.
- Q The witness told you he was going to open a place in Asbury Park? A He did.
 - Q Did he tell you that he was going to settle there?
- A He said the following day -- I am not positive of that.
 - Q The defendant said he was going the following day?
- A Yes, sir, I believe that was what he said in the near future
- Q He said the following day? A I am pretty sure that is what he said.

Q Did he tell you that he was going? A I believe he said the following day; I am not positive of that.

THE COURT: You used the word Witness in place of defendant.

- Q The defendant said he was going the following day?

 A Yes, sir, I believe that was what he said in the near future.
- Q He said the following day? A I am pretty sure that is what he said.
- And he said the clothes were in his own room?

 A He told me he took one suit home and hung it up.
- Q And that is all he told you? A He said the bundle to contained one suit. He had taken that home and hung it up.
 - Q Did he eventually tell you that the bundle was in Gordon's place? A No, sir, he didn't. He said he took it home.
 - Q What is that you said? A I said he took it home and hung the suit up. I don't --
 - Q You started to say something about "don't you remember", what were you going to say --
 - A It is a mistake on my part.
 - Q When you said you don't remember there was nothing to that remark at all? A No.
 - Q And you found a package yourself, did you?

 A I did.

- Q You didn't find the policy of insurance? A No sir
- Q You didn't find any other policies there?
- A No, sir.
- Q He told you he had owed some gas bills, did he?

 A Yes, sir.
- Q You went into great details about his business conditions? A I just asked him a few questions.
 - Q You said about business? A Yes, sir.
- Q He said business was good? A He said business was good.
- Q But that he owed a few gas bills? A A few gas bills and his help.

 - Q He admitted they were his suits at once? A Yes sir.

 MR. JOSEPHS: That is all.

THOMAS CONLON, called as a witness on behalf of the People (not sworn), testifies as follows:

EXAMINED BY THE COURT:

- Q What is your name? A Thomas Conlon.
- Q Where do you live? A 1542 Second Avenue.
- Q When was your birthday? A 12th of October; the coming October I will be 12 years old.
 - Q The coming October you will be 13 years old? A Yes sir.
 - Q Who do you live with? A With my mother and aunt:
 - Q Do you go to school? A Yes sir.
 - Q What school do you go to? A 85th Street.
 - Q It is a public school? A Yes sir.
 - Q And what grade are you in? A 6-A.
- Q Who is your teacher? A I have got my leg injured, and for the last week or so could not go to school.
 - Q You have not been to school for how long? A Two weeks.
 - Q Do you go to Sunday school? A I go to church.
 - Q. What school? A 76th and Lexington Avenue, St. Jean's.
 - Q You go to a Catholic church? A Yes, your Honor.
- Q You are a witness in this case and will tell the truth and nothing but the truth? A Yes, your Honor.
- A Yes, your Honor.
- Q If you were askeda question and cannot answer it, and you do not know how to do so, you will say so? A Yes, your Honor.
 - Q You understand what it means to take an outle A yes, your

Honor.

Q To swear? A Yes, your Honor.

THE COURT: I believe after examining this boy he is possessed of sufficient intelligence to justify the reception of his evidence. I think that he understands the nature of an oath sufficiently to enable him to give the evidence under oath.

(The witness was now sworn).

THE WITNESS: I reside at 1542 Second Avenue.

DIRECT EXAMINATION BY MR. WELLER:

- Q Now, I want you to speak up so all the gentlemen over there can hear you. A Yes sir.
 - Q How old are you? A Twelve.
 - Q Go to school? A Yes sir.
- Q What school do you go to? A 85th Street and 86th Street and First Avenue.
- Q Keep your voice up so we can hear you. Now, whereabouts do you live? A I live in No.80.
 - Q Whereabouts, between what avenues? A Second Avenue 1542.
 - Q Did you live there at the time of this fire? A No sir.
- Q Where did you live then? A 314 82nd Street between First and Second Avenues.

MR. WELLER: Your Honor, one of the jurors would like to ask a question.

THE COURT: He may.

JUROR NO.4: I understand Mr. Weller to say the Germania

Life Insurance Company.

MR. WELLER: It is the Germania Fire Insurance Company.

I made a mistake.

Q Now, were you down around 75th Street at the time of this fire, do you remember what time it was? A Yes sir; I know when it was, for it was about half past six.

Q What were you doing down there at that time? A Just standing across the street by myself.

THE COURT: Talk a little louder. We would all like to hear you. Don't be afraid.

- Q You remember there was a fire down there? A Yes sir.
- Q What do you know about it. Tell the jury what you know about it. A I was standing across the street, while this man came out in the street. He locked the store. Then he went up towards Lexington Avenue on the north side of the street, and then vafter he went up a fellow went by after him by the name of Joseph Connolly, and he told him to come back, and he went brank like this, (illustrating). Then he went around the corner. I didnot see him any more. So when he came back I saw him open two locks on the door and that is all I saw.
 - Q That is all you saw? A Yes sir.
 - Q Did you know Connolly at that time? A Yes sir.
 - Q You know it was Connolly that ran after him? A Yes sir.
 - Q Did they come back together? A Yes sir.
- Q You gave your name to the policeman that night, or the fire marshal? A I gave it to the fire marshal, the man with the

Q The fire marshal? A Yes sir. CROSS-EXAMINATION: BY MR. JOSEPHS:

- Q Now, Thomas, you are twelve years old, are you? A Yes sir.
 - Q What class are you in/that school? A 6-A.
 - Q Do you go to school regularly? A Yes sir.
 - Q Have you had any trouble in school lately? A No sir.
 - Q Never had any trouble? A yes sir, once in a while.
 - Q What? A Once in a while.
- Q You have trouble in the school once in a while? A Last year I had trouble.
 - Q You had considerable trouble last year? A Yes sir.
- Q What was that trouble in school? A I didn't obey the teachers.
 - Q You didn't obey he teachers? A No.
- Q And then what happened to you? A And then I played truant.

I was afraid of the teacher.

- Q You played truant because you were afraid of the teacher; you were a boy of eleven years old. And what happened to you after you played truant? A I got put away.
 - Q You were put away? A yes sir.
- Q And how long were you away? A About seven and a half months.
- Q You were in custody for seven and a half months for being a bad boy? A Yes sir.

Q Now, you lived at that time on 82nd Street between First and Second Avenues; is that right? A Before I got up where I was I lived at 1298 Third Avenue.

- Q You lived on 82nd Street between First and Second Avenues?

 A Yes sir.
- Q And this fire occurred on Lexington Avenue -- withdrawn.

 On 75th Street, I mean, at the corner of Lexington Avenue?

 A Yes sir.
- Q Did you play with the bossaround that neighborhood?

 A Yes sir.
- Q And that is what you -- that was what had brought you all 82nd Street
 the way from the xatation down to 75th Street? A yes sir.
 - 4 You used to come down there every day? A Not every day.
- Q But pretty nearly every day? A I went down on July 5th; a couple of days there, on the Fourth of July I went down there.
- Q You went down there on the 4th of July, the boys down there were having a pretty good time, were they? A I do not know.
- Q Well, you were with the boys all afternoon? A No, I was by myself sitting over at 168th Street.
- Q And how long had you been sitting there by yourself?

 A An hour or an hour and a half.
- Q You were sitting by yourself for an hour or an hour and a half? A yes sir.
 - Q All by yourself? A Yes sir.
 - Q You didn t talk to anybody for an hour and a half? A No sir.

- Q And you were a very good boy that day? A Yes sir.
- Q And didn't you play with the other boys that day at all?
 - Q What time did you come around the block?
- MR. WELLER: He has not finished testifying; give him a chance.

THE WITNESS: I don't know what time it was.

MR. WELLER: Do you want to say anything else?

MR. JOSE RIS: No. Would you like to have me say some-

MR. WELLER: I only want to tell you what is true.

- Q Did you come right around after lunch, after dinner?

 A No sir.
- Q What time did you have your dinner that day? A Around 12 o'clock.
- Q And where did you go after you ate your dinner? A I sat in the house, and then I came down.
- Q How long did you stay in the house? A A pretty long time.
- A I do not know what time it was; I could not actually tell you.
- Q When you came around to 75th Street did you go right to that stoop and sit down? A Yes sir.
- Q That is the only thing you did? A. I had a headache and sat down by myself.

- Q You didn't go home? A I was home before.
- Q You came out, you had a headache and you sat down all by yourself? A Yes sir.
- Q Now, Thomas, were there other boys around there that day?

 A Yes sir.
 - Q Lots of boys, weren't there? A Only a few fellows.
 - Q You hang out there, don't you? A Yes sir.
 - Q There is a pretty nice gang around there, isn't there?
- A There are not many fellows around there.
 - Q There is nice goings on? A What do you mean?
 - Q The 75th Street corner that gang hung around --

MR. WEILER: Objected to.

THE COURT: Sustained.

- Q Is there a crowd of boys called the 75th Street gang?

 A No sir.
- Q What do the yeall them? A They don't call them nothing at all.
- Q And did you watch these other boys playing that afternoon?

 A No sir, I had my head down like this, (indicating).
- And the whole time you sat on the stoop you sat with your head down like this, (indicating)? A 7t was not a stoop, it was a little step.
- You sat there all the time holding, your head in your hands that way? A After a while I sat up straight.

W.R.

- Q How long did you stay with your hands this way?

 A For about fifteen minutes.
- Q You stayed for an hour and a quarter sitting by the street? A Yes, sir.
- Q Did you and other boys play together? A Yes sir down by the garage.
- Q The garage is right opposite the store? A No, the last garage.
- Q What were they playing? A They were standing there talking.
 - Q For a whole hour and a half there talking? A yes sir.
- Q Boys all as old as you are? A I don't know how old they are.
- Q You know the boys around that block, don't you?

 A Yes, sir.
 - Q They are all about your size? A Yes, sir.
- Q And do you remember one of the boys' fathers being to a picnic that afternoon? A No, sir.
- Q And what were they playing that afternoon?

 A They were just talking around there.
- Q They stayed there the whole hour and a quarter talking, that you noticed them? A Yes, sir.
- Q Didn't you notice the boys having any torpedoes or fire crackers, being the 4th of July? A No sir.
- Q No boys had any torpedoes all afternoon?

 A I didn't notice them.

- Q Did they have any fireworks or caps for the 4th of July celebration? A I noticed no caps or fireworks
- Q Did you notice them having tiny batches of fire crackers that the boys father brought from the picnic, brought to him? A No, sir.
- Q These little tiny Chinese fire crackers?

 A No, sir.
 - Q You didn't see them? A No, sir.
- Q You would have noticed them if they ere there?

 A Yes, sir.
- Q Now let us see: You saw Connockly come on the block, didn't you, Joe, come down the block? A All that I saw of him was when he came out of the store, he went after them.

MR. JOSEPHS: I am talking about Joe.

MR. WELLER: we is telling you of them.

- Q Did you see this man (indicating thedefendant) locking his store? A Yes, sir.
- Q You saw Jon then, didn't you? A No, I didn't see him yet. I saw Joe going after him telling him the first time, but he didn't come back; he went like this way (illustrating); I didn't hear him say anything to any one around Lexington Avenue.
 - Q When he saw Joe--

MR. WELLER: He is only a little fellow this wit-

MR. JOSEPHS: I will try to control the examination, and get it out of him as I want.

- Q You saw Jacob Goodmark the tailor looking in the store? A Yes, sir.
 - Q Did you see him turning two locks? A Yes sir.
- 0 Now which lock, Thomas, did he turn first, the upper or lower lock? A I think it was the upper lock.
- Q You saw him close the upper lock first? A I know he closed the two locks; I don't know which one he closed first.

MR. WELLER: But--

MR. JASEPHS: I will ask your Honor to suggest to

Mr. Weller that it is advisable when a witness is about to commit

some slight or immaterial error, he interrupts-MR. WELLER: I object.
THE COURT: Sustained.

MR. WELLER: Read the record and you will find, sir, you are in error.

- Q Now you saw him lock these locks, both of them?

 A Yes, sir.
 - Q You are sure of that? A Yes sir.
- Q And when you saw him lock them up you noticed you had to look across in his direction? A Yes sir.
 - Q You were sitting on the other side of the street?

 A Yes, sir.
 - Q Up against the building? A Yes, sir.
 - Q In front of the garage, was it? A No, sir, right

where the saloon is.

- Q Then that must have been, as you looked at the store, as you see Jacob Goodmark looking, the store, it was nearer to go to Lexington Avenue than to Goodmark, s store?

 A No, it is right opposite it.
- Q Is there a garage right opposite, is there, sir?

 A Yes, sir.
- Q Well, you were next to the garage? A I was up in the garage.
 - Q You were nearer to Lexington Avenue? A Yes sir.
- Q Now the garage is right opposite the Jacob Goodmark's store? A Yes, sir.
- Q And therefore you were a little nearer Lexington Avenue than Jacob Goodmark's store? A Yes, sir.
- Q You were about opposite the saloon, weren't you?

 A No. sir.
 - Q Opposite the saloon across to where --
- A No, sir.
- Q Is that where the private house is? A It is just about.

BY THE COURT:

- Now, my boy, if you had looked right across the street from where you were sitting, what would have been directly opposite you? A His store.
 - Jacob Goodnark, s store? A Yes, sir.

- Q Opposite the window of the store? A Yes, your Honor BY M JOSEPHS:
 - Q Thomas, you could not look right in the door of this store from where you sat? A No, sir.
 - Q. The lock was at the extreme left hand of the store to the door way? A Yes, sir.

THE COURT: Gentlemen of the jury you are admonished not to converse among yourselves on any subject connected with this trial, form or express any opinion thereon until the case is finally submitted to you.

We will meet on Monday at a quarter past ten instead of half past ten.

Whereupon an adjournment was taken until Monday September 27th, 1915, at 10:15.

THOMAS CONLON resumes the stand.

CROSS-EXAMINATION (continued) BY MR. JOSEPHS:

- Q Now, Thomas, since you left this court room on Friday did you talk about this case to anybody? A No sir.
 - Q Not a word to anybody? A No sir.
- Q Now, did you talk before you came in this court at any time to anybody about this case? A No sir.
- Q You never heard Joe Connolly describe what he saw, did you?

 A No sir.
- Q You never heard Joe Connolly tell the story when I asked him if he saw a fire, he made this gesture (indicating by expending the arms)? A No sir.
- Q And the first time you ever told your story was in court to-day? A Yes sir.
- Q Last Friday, I mean? A Yes sir.
- Q Now, you say that you were sitting on a little low step?

 A Yes sir.
- Q Now, where is that low step, Thomas, in front of what building? A 168.
 - Q What kind of a building is 168? A A garage.
 - Q It is a garage? A Yes sir.
- Q And then next to the saloon is the garage? A yes sir,

Q And then there is another garage after that, isn't there?

A Yes sir.

- Q And the other garage in front of Goodmark's place?

 MR. WELLER: Which way?
- Q The second garage from the saloon is in front of Good-mark's place? A No sir.
 - Q It isn't? A No sir.
- Q Which garage is in front of Goodmark's, the first one?

 A The first one.
 - Q That is the one you sat in front of? A Yes sir.
- Q Now, first comes the saloon on the corner on the opposite side of Goodmark's place? A Yes sir.
- Q And then comes the garage that you are talking about?

 A Yes sir.
- Q Now, you said on Friday you could not look right in the door of this store from where you sat, that was right, wasn't it?

 A Yes sir.
- Q On which side of the garage did you sit at, the side nearest the saloon, or the side nearer Goodmark's place? A The side nearer to the saloon.
- Q Now, what kind of a step is that? A It is a little piece of cement like.
- Q And you sat on that cement for an hour and a half? A Yes
 - Q. Now, right next to the salcon, right next to the garage is

9

the saloon and that is a sort of family entrance and extends out?

A Yes sir.

- Q And you sat back against the wall? A No, I sat against the wall of the saloon. There is a door coming out like this (indicating), and here (indicating) is the garage, while I sat up against the family entrance (indicating).
- Q Then you did sit up against the saloon? A Yes sir.
 - Q And you didn't sit up against the garage? A No sir.
- Q Because there is nothing to sit down in front of the garage?

 A No sir.
- Q Then when you said you sat in front of the garage you were mistaken? A I was in front of the garage when I was sitting there.
- Q And in front of the saloon also. Now, as a matter of fact, Thomas, did you sit out in front of the door of the saloon or up against the back wall of the garage? A Here (indicating) is the garage, and here (indicating) is the saloon. I sat down there (indicating).
- Q Right next to that private entrance to the saloon that comes out about four or five feet, out on the street, doesn't it?

 A The door is on the other side.
- Q But that private entrance you know, and the swing door is by the private entrance to that saloon? A Yes sir.
- Q That private entrance comes out about five feet into the saloon, out further to the wall than the garage? A Yes sir.
 - Q And you sat right in the corner where this private entrance

meets the garage? A Yes sir-

- Q Now, you saw Joe Connolly come out with this manthe first time? A Yes sir.
 - Q And then you saw him walk up towards the corner? A Yes sir.
 - Q And you saw Goodmark turn the corner with Connolly? A Yes.
- Q Don't you know, Thomas, from the position you sat, sitting away up against the wall and the salcon extension comes out, that you could not seethe corner? A I stand up.
- Q Even if you stood up, that private entrance is 10 or 12 feet high. A I stood up and looked like that, (indicating).
 - Q Did you walk out then? A Yes sir.
- Q Then you were not sitting still all the time, /you said?

 A No sir.
- Q Then we have got you, walking out to the sidewalk and then looking to the corner? A I just went out to the edge of that place.
- Q. That is about five feet out from the wall and you got up?

 A yes sir.
- Q When you said you kept sitting there all the time and you saw all this exhibition without getting up, you were mistaken?

MR. WELLER: I object.

THE COURT: Sustained.

- Q Have you been around that neighborhood sincethe 5th of July? A Yes sir.
 - Q How many times? A I could not exactly tell you.
 - Q A good many times? A Yes sir.

- Q And you looked at Goodmark's store? A Yes sir.
- Q You looked at the door he opened? A Yes sir.
- Q Now, Thomas, pay close attention; you were sitting over in that corner when you looked over to see Goodmark lock the door, you had to look through the main window, the side show window? A Yes sir.
- Q Did you take the trouble to look at that side show window lately? A No sir.
- Q. Did you take the trouble to look at that side show window at the time of the fire? A. I don't understand what you mean.
- O That side show window when you looked through to see him look the door? A I don't understand what the side show window is.

THE COURT: If you don't understand the question, just say

- Q You understand me so far? A. No sir.
- Q If you don't, say so right away and I will try to make it clear to you. I said, Thomas, when you looked over to see Good-mark look the stere for the first time you could not look directly at the store, you had to look sideways? A Yes sir.
- Q In order to look sideways, assuming this (indicating) to be the store, here (indicating) he was looking the door, you were over there? A Yes sir.
- Q You had to look through the window, this say (indicating)? A Yes sir.
 - Q You looked through the main window of the store and then

the side window of the store, didn't pou; you had to look through both windows?

THE COURT: What store are you speaking of?

MR. JOSEPH: The store where the man locked the door.

THE COURT: What you mean is he had to look through the front pane of glass and also the pane of glass forming the side of the show window.

- Q You understand that, Thomas? A Yes sir.
- A No sir.
- O Did you ever notice it before the fire? A Before the fire I seen it many a time, before the fire.

THE COURT: A little louder.

- Q You saw it many times? A Yes sir.
- Q Did you ever take special notice of it? A No sir.
- Q You don't know what is in that window? A I cannot remember what was in it.
- Q Now, wasn't there a sign in that window? A I cannot remember what was in the window.
- Q TS it not a fact, Thomas, that there is a sign in the window on that side of the pane of class which reaches as high as the extension, as high as the partition?

MR. WELLER: I object.

THE COURT: Sustained.

MR. JOSEPH: I have not finished my question.

Q (Continued) -- which says, has Goodmark's name on, and all

his price list, that he charges?

MR. WELLER: Objected to as incompetent. '

THE COURT: Sustained. It is competent if you contend that I that was the condition at the time of the fire.

. MR. WELLER: He said he saw it before, not since.

- Q Do you remember seeing that sign, now think? A No sir.
- fact that you could not look through that side window, that side pane of glass because there is a great big sign there, "Jacob Goodmark", and says, "Guits pressed 40 cents".

MR. WELLER: I take it that downsel says there was a sign there at the time of the fire.

**R. JOSEPH: Yes, and was there four years before and is still there to-day. Just one of those broad signs, setting forth "Suits 40 cents", and the prices, and that sign has been there for four years.

MR. WELLER: I object to that.

THE COURT: Custained.

- Q You don't remember that sign? A No sir.

THE COURT: Meep your voice up.

- 0 Why have you not been to school? A I got my leg operated on.

- Q You know it would be wrong to say anything that is not true? If you were asked a question you have to answer truthfully, you understand that? A Yes sir.
- Q You know if you say what is not true you will be punished for it? A Yes sir.
 - O You know what it means to swear, to testify? A Yes sir.
 THE COURT: We can be sworn.

(Whereupon the witness was sworn).

- Q Joh, how old are your A Gaing on 13.
- Q. Look at the jury here and speak so that this gentleman over here can hear you. Going on 132xx A Yes sir.

 - Q Now, you so to school, do you? A Yes sir.

 - Q And where were you with reference to Goodnark's store?
- A I was like that, on a curve (indicating).
- O A curve, you were not straight in frot of the store? A No sir.
- Q And were you towards Lexington Avenue or Third Avenue?

 A Towards Third Avenue.
- Q What were you doing there at that time? A We were play-
- O Do you know there is a garage in front of this store?

 A Yes sir.
- Q. Where were you with reference to that garage? A I was down below it.
- Q. Towards Third Avenue? A Yes sir

- Q And how far down that way? A About two houses.
- Q Were you with any other boys at that time? A Yes sir.
- Q Were you with Thomas Conlon who was just in here? A No sir.
- Q Were not with him? A No sir.
- Q How many boys were there there at that time? A About eight or ten.

 - Q . And where did he come from, did you notice? A No sir.

 - o The fifth? A Yes sir.

- O That is the fifth building from Lexington Avenue? A Yes
- o Now, which parace building, the first or second building is opposite Goodmarkse store, it is the second, isn't it? A No sir.
 - Q Which one? A The third ..

A Yes sir.

- . Q Then you were down at the fifth store, the fifth building?
 - Q Which was four buildings away from Coodmark's place? A Yes

- Q And you saw Connolly touch him on the shoulder? A Yes sir.
- Q Which shoulder did he touch, the right or left shoulder?
- A. I do not know.

- Q And you saw Goodmark do this. (indicating)? A Yes sir.
- Q Show me exactly, like that? A (The witness illustrated).
- Q And you are sure of that, you saw Joe Connolly follow him up to the corner? A Yes sir.
 - Q You watched it carefully? A Yes sir.
- Q Then you saw Goodmark turn the corner with JoeConnolly after him? A Yes sir.
 - Q Are you sure of that? A Yes sir.
 - Q Did you talk to anybody about this case at all? A Mo sir.
 - Q Did you discuss it with Joe Connolly? A No sir.
 - Q Did you discuss it with Thomas Conlono A No sir.
 - Q Did you discuss it with the Fire Warshal? A Yes sir.
 - Q You did discuss it with the Fire Marshal? A Yes sir.
- . Q Which Fire Marshal did you discuss it with A I do not know.
- Q Well, the fellow with the glasses. (At this point on the request of Mr. Joseph Fire Marshals Wade and Cashman were brought into the court room). "as it either of those gentlemen, (indicating Fire Marshals Wade and Cashman) A The first one. (Indicating Mr. Wade).
 - Q You told him whit you knew about the case? A Yes sir.
 - Q Did he go into details about this package with you? A Sir?
 - Q Did he ask you any questions about this package? A Yes sir.
- Q And how long did he talk to you about this case? A About half an hour.
 - Q Where did he talk to you? A've talked to me down in his

office.

- Q And did you see him since? A Yes sir.
- Q And how many times since did you see Wade? A About three times.
- O And each time he talked about this case? A No sir.
- Q What did he say about it when he saw you all these times?
 A Nothing.
 - Q Just looked at you and didn't say a word? A Wo sir.
- Q You are sure of that' A Yes sir.

BY THE COURT: . .

- Q Did you see Thomas Conlon there that night? A No sir.
- Q Did you see him on the night of the fire? A I saw him before the fire.
- About how long before the fire did you see Thomas? A About half an hour.
- Q And at that time where was Thomas? A we was sitting by the first garage.
- Q When you say the first garage, boy, which one do you mean?

 A Across the street from Goodmark's.

MR. WELLER: That is where Thomas Conlon was sitting.
THE WITHESS: Yes sir.

BY THE COURT:

Q was he sitting there alone or with anybody? A we was sitting alone.

MR. JOSEPH: That is all.

MR. WELLER: That is all.

JOSEPH WARREN, (recalled)

BY MR. WELLER:

- Q Now, Tr. Warren, you have already testified? A Yes.
- Q You were duly sworn? A Yes, sir.
- Q Now, on the 6th of July, the day after the fire, did you relieve patrolman Bolek? A Bolek
 - Q. What time? A Five fifty.
- Q Five fifty P. M. on July 6th? A Bolek relieved me at five fifty that evening.
- Q Bolek has testified that he was there at five fifty on the evening of July 6th. Now, when did you go there afterward? A I left the house-- I left the quarters to go there, I watch at night.
 - Q What time did you get to the premises where the fire was? A Five fifty.
 - Q On July 6th? A Yes, sir.
 - Q How long did you remain there the second night?
 - A Until 7:45 next morning.
 - Q Did you see anybody disturb the premises?
 - A No, sir.
 - Q Or change things about? A No, sir.

MR. WELLER: That is all.

MR. JOSEPH: No cross examination.

(Witness excused)

MR. JOSEPH: I would like to ask the last witness one question.

THE COURT: He may come back.

JOSEPH WARREN, resumes the stand.

BY MR. JOSOPH:

- Q Mr. Warren, did you notice the ceiling of that store?

 A No, sir.
 - Q You didn't take the trouble to look up at all?
- A I didn't take much notice of it to give you any description.

MR. WELLER: I object to it, if your Honor please.

The witness has already testified that he never went inside the premises.

MR. JOSEPH: He was there another day.

WILLIAM SCHAEFER, called as a witness on behalf of the people, being first duly sworn, testified as follows:-

(I reside at 1496 Vyse Avenue, Bronx)

DIRECT EXAMINATION BY MR. WELLER:

- Q You are a patrolman of the New York Board of Fire Underwriters? A Yes, sir.
- Q Did you go to premises 155 East 75th Street?
- Q When die you go there? A On the evening of July 5th, last.
- Q Did you go there after that, did you relieve patrolman Warren? A I did.

- Q When did you go there? A Why I relieved Patrolman Warren about 7:45.
 - Q When? A On the 8th of July, 7th, I believe.
- Q Two days after the fire? A Two days after the fire.
 - Q And what time did you go on duty? A That morning?
 - Q Yes. A To relieve Patrolman Warren at that time.
 - Q Whatt time? A Seven forty-five.
 - Q In the morning? A Yes, sir.
- Q And how long were you there? A Until three P. M. that afternoon.
- Q Did anybody disturb any part of the premises while you were there? A While I was -- Patrolman Warren told me not to let anybody disturb anything at the time.
- Q Just answer. Did anybody disturb any part of the premises while you were there? A Yes, sir, the appraisers from the fire marshalts office.
 - Q What was his name? A Mr. Gaynor.
- Q Patrick Gaynor made an appraisal of this property?

 A Yes, sir.
- Q Did any body else disturb anything besides the appraiser? A No, the fire marshals later--
- Q. What do you mean by the fire marshls later?"

 A. They had been there and taken some of the things away

 from there.



Q When did they do that; when did they take the property away? A About lunch time.

Q And what time did Mr. Gaynor come? A I judge about 9:30. A. M.

- Q Then nobody disturbed anything except the appraisers who handled the property up to the time that the appraiser made the examination? A Yes, sir.
- Q After the appraiser made the examination then the fire marshal came? A Yes, sir.
 - Q And that was about what time?

MR. JOSEPH: I don't mind his leading on this kind of testimony, but he has just got so far I cannot stand it. All this witness has done is "yes", and Mr. Weller is testifying through the whole trial and the witness is saying "yes".

THE COURT: Pardon me. That comment is all uncalled for.

(The stenographer read the last question)

Q What time? A 11:30.

MR. WELLER: That is all.

CROSS EXAMINATION BY MR. JOSEPH:

Q Mr. Schaefer, did you look at the ceiling?

MR. WELLER: Which ceiling?

MR. JOSEPH: There is only one ceiling. You don't think I am talking about the Metropolitan Opera House ceiling?

MR. WELLER: What part of the store?

MR. JOSEPH: The store is so small he could not help but see it.

MR. WELLER: Ask a question.

- "Q Did you look at the ceiling? A I didn't pay any attention to the ceiling.
 - Q Can you describe the condition of the ceiling?
- A No, I didn't pay any attention to the ceiling.
 - Q Did you walk into the store? A Yes, sir.
- Q Walked all of the way back? A I sat at the door most of the time.
- Q I mean any time you walked to the rear of the store?

 A At the time the appraiser was present I did, yes, sir.
- Q Did you walk there when you first came there to look around and see the place? A I didn't really step back there.
- Q Did you walk around the partition when you first came? A No.
- A From 7:45 to about 9:30.
 - Q Well, approximately two hours? A Yes, sir.
- Q And how far from the front door is the partition, about how many feet?

agree with you -

MR. WELLER: I object to that, if your Honor please.

We have it in evidence a number of times; we have a diagram.

IR. JOSEPH: Tell me the number offeet and I will

MR. WELLER: About sevenfeet seven inches from the show window of the store to the partition.

- Q And how far into the store did you go that morning when you first arrived? A Well, I should judge about it might have been ten feet or so.
- Q Then you did go behind the partition when you first arrived? A I didn't.
- Q Well, the partition is only sevenfeet from the door?

 A I am not exact about the length from the door to the partition.
- Q You went about half way into the partition?

 A Yes, sir.
 - Q About three and a half or four feet? A Yes sir.
- Q You waked about four feet, turned around and walked right backagain? A Towards the door.

 BY WR. WELLER:
- Q. Your duty is to stand at the door and prevent people, not officials of the fire department from going in there and disturbing things? A Yes, sir.

 BY MR. JOSEPH:
- Q Your duty is to visit the premies and see it is not disturbed?

(No ruling)

BERTHA BLANK, called as a witness on behalf of the people, being first duly sworn, testified as follows:
(I reside at 155 East 75th street)

DIRECT EXAMINATION BY MR. WELLER:

- Q Mrs. Blank, what is your business? A I am janitress of 155 East 75th Street.
- Q Keep up your voice. You are janitress of these premises? A Yes, sir.
 - Q You know Jacob Goodmark? A Yes, sir.
 - Q Know his wife and family? A Yes, sir.
 - Q How long have you been janitress of these rooms?
- A Fourteen years.
- Q What kind of a building is it? A A flat house with eight families and three stores.
 - O, These families, do they live in those apartments?
- A Living altogether there.
 - Q They sleep there? A Yes, sir.
 - Q Do they? A Yes, sir.
 - Q Cook there? A Yes, sir.
 - Q Mat there? A Yes, sir.
 - Q Did you live there on the 5th of July of this year?
- A Yes, sir.
- Q Those premises are in the County of New York, are ______ they not? A Yes, six-
 - Q And she as people lived there at that time? A Yes wir.

Q How many families axe there on the 5th of July?

A Seven.

- Q Now about half past six that evening where were you that evening? A I was on the corner of Lexington Avenue on 75th Street on the other side of the corner, the southwest corner.
- The southwest corner of Lexington A venue and 75th street? A Yes, sir.
- Q And the flat is on what corner? A That is the south-
 - Q You mean the northeast, don't you? A Northeast.
- Q What were you doing there? A Iwas speaking to a gentleman there.
 - Q Who? A Mr. O'Rourke.
 - Q This man who has been a witness here? A Yes sir.
- Q. What did you notice? A Iwas speaking to r. O'Rougke and we noticed the smoke coming from the house.
- Q Whereabouts from the house? A I do not know if it came from the basement where I lived or came from the store so when Mr. O'Rourke called my attention to it I went over quick to see where the smoke came from, from the other basement or the store.
- Q When you were over there on the corner, did you notice the smoke when you were over on the southwest corner, did you see Goodmark? A No, sir, I did not see him right

- Q When you came over to your steps, down into the basement where you lived? A Yes, sir.
 - Q How close is that to Goodmark's store? A yes sir.
- Q How close? A Well, like I never measured it, about fifteen or some feet.
- Q It is right next door? A No, there is the main door and the middle between.
- Q The main door of the house is between Goodmark's store and this area way where you have to go to your house?

 A Yes, sir.
- Q Now where were you when you first saw Goodmark?

 A Just wanted to go down in the basement to turn around and saw Mr. Good mark.
- Q In other words, your areaway, the steps, you can go down nearer to Lexington Avenue than Goodmark, s store?
- A Yes, sir.

BY THE COURT:

(At this point the Jury examined a photograph handed to them by Mr. Weller)

- you saw Goodmark? A Yes, sir.
- A I saw smoke and I went down and it smoked all along.
- Q Before you went down did you see any smoke?

 A I saw the smok when I came from Lexington Avenue, so it

smoked all along until I went down.

- Q Did you see the smoke before you went down the stairway? A I saw it on Lexington Avenue already.
- Q Did you see it before you went down the stairway?

 A Yes, sir.
- Q Goodmark, how close was he to you at that time?

 A Just behind me on the sidewalk.
 - Q That was the first time you saw Goodmark? A Yes.
- Q What did you say to him? A Is wore-- excuse me-I said, "Damn it; go and see what is the matter with your
 place."
- Q What did he say? A He said, "I don't think it is much".
- Q He said, "I don't think it is much!" What did you do? A I went down. I was anxious to go down and see if it was in my place.
- Q You were in a hurry to get downstairs? A Yes sir. CROSS EXAMINATION BY MR. JOSEPH:
- Q Now Mrs. Blank, as a matter of fact you came running over from where you had been talking to Mr. O'Rourke?
- A Yes, sir.
 - Q Didn't you see Goodmark near the corner, now think?
- A I didn't see around he corner.
 - Q Not around the corner, near the corner?
- A It is not so far away where the store is.

Q You saw him before you reached the store?

A I was just on the sidewalk going down-- excuse me-- I had my dog with me.-- I went to see if he came with me-- I turned around and looked for the dog-- I saw Mr. Goodmark coming along. I was so excited I didn't know whether he was near to me or behind me.

- Q You saw Goodmark? A Yes, sir.
- Q Did you see anybody grab Good mark or push him?
- A No. I didn't see him; nobody around me.
 - Q He came along by himself? A Yes, sir.
- Q You are sure of that? A I am quite sure of that-- what I have seen.
 - Q Did you see a boy that day? A No, sir.
- Q. Did you see Joseph Connolly have him by the shoulders?

 A I have not seen that boy at all.
- Q You swear positively? A I didn't see him. I cans wear I didn't see anybody around him; he was alone when I saw him.
- Q. That was quite a distance from his store?

 A The distance between his store and my basement.

 BY THE COURT:
- Q You ran from the southwest corner over towards the stairs going down into your basement? A Yes, sir.
 - Q You ran? A Yes, sir.
 - Q While you were running, as I understand you, while

you were running you didn't see Goodmark? A No.

- When you got to your stairs you turned to go down? A Yes, sir.
 - You had with you a dog? A Yes, sir-- two.
- . . Q You turned around to see whether the animals, both of the dogs -- you had two dogs, -- were following you?
- A Yes, sir.
- Q And as you turned around you saw Goodmark, is that so? A Yes, sir.
- Q Goodmark then was on the sidewalk, is that so? A Yes, sir.
- Q He was facing in what way? A Towards his store from the Avenue, going to the store, the same way as me.
- Q In other words, Goodmark was walking towards his store? A Yes, sir.
 - Q. He faced towards the store? A Going to the store.
- Q His back was towards what street? A Towards Lexington Avenue.
- Q Goodmark,s back was towards Lexington Avenue? A Yes, sir.
- Q He was facing towards his store? A Yes, sir, to go down to his store.
- Q Did you notice whether he had anything in his hand? A I cannot say; I have not seen nothing; I cannot remember; I was excited.

You went right down the stairs? A Yes, sir.
THE COURT: Go ahead, counsel.

BY MR. JOSEPH:

- Q You got a good clear view of Goodmark and spoke to him? A I saw Mr. Goodmark. I even swore; I was so excited.
- Q If anybody had been pushing him this way (indicating) you would have seen it?

MR. WELLER: I object.

THE COURT: Allowed.

- Q You would have seen it? A I was so excited I didn't see anybody with him.
- Q But if somebody had been pushing him you would have seen him. You would have seen it? A I suppose so.
- Q You saw Mr. Goodmark? A Just as I turned around Is aw Mr. Goodmark.
 - Q You didn't see Joe Connolly with him? A I did not.
- Q Was he walking? A When I turned around I saw him there.
- Q He was going pretty fast? A He would have gone without me telling him.
 - Q You are the janitress of this house? A Yes sir.
 - Q You collect the rent, don't you? A Yes, sir.
 - Q How many years has Goodmark lived in that house?

 Four years.
 - Q He paid the rent? A Yes, sir.
 - Q Does he pay his rent promptly? A' Yes sir.

- Q He has paid his rent promptly all those four years?
- A All the time.
 - Q He has been a pretty good tenant in that house?
- A Yes, sir, nothing to complain about him.
- Q Did he owe you any money at the time of the fire?

 A Excuse me --it was my fault. Last month's money he gave over
 me nine dollars, and far that he wanted to give me a check
 \$35.00. I had no money to change it after that accident.
 - Q Since then he has paid? A Yes, sir.
 - Q And he paid his rent for the month after? A Yes sir.

 MR. JOSEPH: That is all.

HARRY GOLDNER, called as a witness on behalf of

the People, having been duly sworn, through Mr. Fisher, one of the Official Interpreters, testified as follows:-

(The witness states that he resides at 185 Chrystie street).
DIRECT EXAMINATION BY MR. WELLER:

- Q We will talk in English as far as you can. Then if there is anything you don't understand you ask Mr. Fisher. How long have you been in this country, Goldner? A Two tears.
- Q What is your trade, what is your business? A A tailor.
- Q You are now confined to the House of Detention, are you? A (Through Interpreter) Yes, sir.
- Q You have been up there in the House of Detention since the day of the fire? A Yes, sir.
 - Q When you were arrested? A Yes, sir.
- Q Now, do you know the defendant Goodmark? A I worked there.
 - Q How long did you work for Goodmark? A Three months.
- Q You will have to keep up your voice or we will have to repeat everything that is said. What did you do there? A I worked there as a tailor.
- Q Were you the only employee that he had? A Yes, sir. (Through Interpreter).
- Q And did you work there on the 5th of July on the day of the fire? A Yes, sir.
- Q Were you on a salary or piece work? A By the week (through interpreter).

- Q How much? A Nine dollars.
- Q Now, before the fire had the defendant ever said anything to you about going to Asbury Park? A Yes, sir.
 - Q When did he say that? A Two weeks ago.
 - Q Two weeks before the fire? A Yes, sir.
- Q And what did he say to you about Asbury Park? A He was to go to Asbury Park and I was there and I take care of the store.
 - Q He wanted you to take care of the store? A Yes, sir.
- Q And what was he going to do in Asbury Park? A For business.
 - Q Tailoring business? A Yes, sir.
 - Q What were you to do in the store? A I was working there.
- Q Yes; but if he went to Asbury Park what would you do?

 A I was to take care of the store.
 - Q For you or for him? A For him.
- Q And you agreed about this? A (Through Interpreter)
 Yes,sir.
- Q Have him state what was the agreement, Mr. Interpreter?

 A (In English) He told me he was going to Asbury Park and he leaves me the store and I take careof the store partner.
 - Q You were to be partners? A Yes, sir.
- Q Did he from time to time go down to Asbury Park before the fire? A (Through Interpreter) Yes.sir.
 - Q To make the arrangements? A Yes, sir (Through Interpreter)
 - Q This was all within about two weeks of the fire? A Yes,

sir (through the Interpreter).

Q Now, do you remember any benzine or gasoline being in the store? A Yes, sir.

Q When was that purchased? A He sent the colored fellow, Thursday or Friday for half a gallon of Benzine to clean the clothes, Thursday or Friday; I don't remember the right date.

- Q You don't remember which day? A Thursday or Friday.
- Q You don't remember which day? A No.
- Q But you know it was one of those days? A Yes, sir.
- Q And did he get the benzine? A Yes, sir.
- Q Did he get it in this demijohn? A Yes, sir.
- Q And did Goodmark say anything about the benzine that the negro purchased? A He told him benzine no good for the clothes. He can't take out spots from the clothes.
 - Q When did he tell you that? A He told me Friday.
 - Q Did you work on Friday of that week? A No, sir.
- Q What did he do with the benzine that he said was no good? A He put it in three milk bottles.
 - Q What were they, regular milk bottles? A Yes, sir.
 - Q Where did he put the milk bottles? A Under the sink.
- Q What did he do with the demijohn? A What demijohn? (Through the Interpreter) He put them down through the sink and together.
- Q Wow, did he say anything to you on Saturday about coming to work on Monday? A Yes, sir.
 - Q pid he pay you off on saturday, A no : pay day was Worlday.

- Q Pay day was Monday? A Yes.sir.
- Q What did he say on Saturday, come Monday? A He told me come Monday seven o'clock in the morning cause he wanted to go in the country, to Asbury Park.
- Q Now, in the morning of the 5th of July what was the weather? A I came Monday at eleven o'clock.
 - Q What was the weather? A It rained.
 - Q Rained hard? A Rained hard.
 - Q What time did you get to the shop? A Eleven o'clock.
- Q I say what time did you get to the shop on Monday?

 A Eleven o'clock on Monday.
- Q And what did the defendant say when you got to the shop?

 A What for I came so late. I bring my dinner there and I

 was ted to go back with the dinner; I wait there until twelve

 o'clock; I eat dinner in the store.
- Q You brought your dinner up there so you wouldn't have to go back up there to get it? A Yes, sir.
 - Q You didn't work during dinnerhour? A No.
 - Q What did he say? A Go home, no work for me two o'clock.
 - Q What time did he tell you to go home? A Two o'clock.
- Q Now, as amatter of fact was he doing very much business that day?
 - MR. JOSEPH: I object to that as calling for a con-

THE COURT: It is objectionable, but not as a conclusion

what did why do that day? A Go nome.

- 8 I I I
- Q Were you busy that morning after you got there? A A little work.
 - Q Now, did he go home at two o'clock? A Who?
 - Q Goodmark. A No.
 - Q Did you leave him in the store? A Yes, sir.
 - Q And anything said about gasoline that day? A No, sir.
 - Q Did you have any cleaning that day? A. Have a little.
 - Q Did you use the gasoline that was in the bottle? A Yes.
- Q And you went away about two o'clock? A Yes, sir; about two o'clock.
 - Q Did he pay you before you went? A No, sir.
 - Q Now, he didn't pay you on Monday? A No.
 - Q Anything said about paying you on Monday? A I asked him for pay. He said I will give it to you tomorrow.
 - Q That would be Tuesday? A Yes, sir.
 - Q Now, when did you next come back to the premises? A Through Interpreter) Wednesday in the morning.
 - Q Wednesday morning? A No, I mean Tuesday morning.
- Q And you saw that there had been a fire there, I suppose?

 . A Yes, sir.

BY THE COURT:

- Q What time did you get there Tuesday morning? A Half Past seven.
 - Q Half past ten? A Half past seven.

BY MA. VALLER:

Q That is the time you usually got there? A (Through Interpreter) Yes, sir.

Q Now, how many suits of clothes did the defendant have in the place on Monday? A I don't know how many but there was a couple of suits there.

Q And was there any clothing in the place? Any rolls of cloth? A Yes, sir.

Q How many rolls of cloth were there in the place? A I don't know how many. I know there was a couple of pieces of goods.

Q Only a couple of pieces of goods? A Yes, sir.

Q Now, did the defendant ever have any canary birds in the places? A Yes, sir.

Q How many canary birds did he have in there? A He had 10 or 12 young ones.

Q He is a bird fancier in a measure, he likes birds? A Yes.

Q He takes care of birds for people and sells them? A ...
Yes, sir; all the time.

Q And how many birds has he owned at any one time? A About 10 or 12. He would take them home because the young ones was too hard in the store and he took them home.

Q And when did he take the last birds home? A Two weeks

Q And was there any birds in the store? A One.

Q And what was the matter with that? A He had a broken

foot.

- .Q A broken leg? A Yes, sir.
- Q Now, did he ever keep any insurance policies in the drawer of his table? A Yes, sir.
- Q Do you know what policies he kept there? A I don't know what policies he did tell me that he got no money for the business and he would take the \$125. from the policy.
- Q And what policy was that? A I don't know what, I forgot - on Twenty-third street.
 - Q Metropolitan Life Insurance Company? A Yes, sir.
- Q Did he say what he had to have the money for? A For business.
- Q Did he explain to you what kind of business? A For businessin Asbury Park.
- Q That was a life insurance policy? A I don't know; I cannot tell you.
- Q Don't tell then, if you can't remember. Now, step down here! (The witness steps down) Did you ever see that wooden box before (indicating)? A Yes, sir.
 - Q Where did you see that? A In the corner in the store.
 - Q Did you ever see this pasteboard box? A Yes, sir.

THE COURT: Referring now to People's Exhibit No. 11?

- Q Now, did you ever see that bundle of neckties in there?

 A Yes.sir.
 - Q Whose neckties were those? A Goldmark's.
 - Q Did you ever see those two suits of clothes before?

- A Yes, sir.
- Q Whose suits of clothes were they? A Goodmark's.
- Q Now, were these suits of Goodmark's old clothes, the clothes he wore, o r customer's? A No, his clothes.
 - Q His clothes? A Yes, sir.
 - Q That suit, too? A Yes, sir.
 - Q The milk bottles, you saw those before, did you? A Yes.
- Q Now, stand right here (the witness did so). Did you have clippings there in the store? Do you know what I mean by clippings? A Yes, sir.
 - Q Of pieces of goods like this? A Yes, sir, clippings.
 - Q Clippings like this here? A Yes, sir.
 - Q Rags? A Yes, sir.
 - Q Did you ever see a woman's white skirt in there? A Yes.
 - ' Q Whose was that? A A customer's.
 - Q Cleaning? A Yes, sir.

MR. WELLER: All right. Step down.

(The witness now resumes the stand.)

- Q Now, the next morning when you got to the store for work, that is Tuesday morning? A Yes, sir.
 - Q Did you see a fire marshal? A Yes, sir.

MR. WELLER: Is Mr. Cashman in court?

(Mr. Cashman came in.)

- Q Did you see Mr. Cashman there, the Fire Marshal? A Yes.
- Q Did you see the defendant Goodmark there, was he talking

to.

with Goodmark? A The janitress?

- Q The Fire Marshal. A Next morning?

- Q What is your business? A. An appraiser.
- Q And how many years have you been appraiser in the City of New York? A Over ten years.
- Q And are you familiar with the clothing business? A Yes

MR. JOSEPH: I object to that as calling for a conclusion.

- Q What has been your experience in the clothing business?

 A I have made a great number of appraisals along those lines,
 large clothing places, both for fire insurance and for burglary
 insurance.
- Q Are you familiar with the prices of woolen garments in the City of New York? A Yes sir.

MR. JOSEPH: I object and move to strike out the answer.

THE COURT: Sustained. You may ask him what his experience has been.

- Q What has been your experience in investigating the price of woolen garments and fabrics in the City of New York? A I have investigated several large concerns here in the city and various losses, seen their purchases, the amounts paid for them and their retail prices.
 - Q Are you familiar with the market value -MR. JOSEPH: I object. we has not as yet proven that he is

an expert.

BY THE COURT:

Q Have you ever bought woolen goods? Have you ever yourself, Mr. Appraiser, purchased woolen goods? A No, I have never purchased or sold any woolens.

Q Have you ever been present at sales? A Frequently.

BY MR. WELLER:

Q And do you know the market value of goods in the County of New York?

MR. JOSEPH: I renew my objection. A man can be at sales and not be an expert; never sold, never was in the business.

BY THE COURT:

Q When you were present at those sales did you hear the prices at which the articles were sold?

MR. JOSEPH: I renew my objection that he is not qualified as an expert unlesshe is shown the fabric, examines the fabric and knows the nature of the fabric.

MR. WELLER: I cannot qualify him in one question,

MR. JOSEPH: You asked the question, did you know the value. You are trying to qualify him in one question.

THE COURT: I will let it remain.

MR. JOSEPH: Let me get my exception on the record.

THE COURT: It will be a matter for cross-examination for you. He has sufficiently qualified.

MR. WEXERRY JOSEPH: Not qualified as an expert.

MR. JOSEPH: Now, I take the exception.

THE WITNESS: I heard the prices for the material and saw the purchases made.

- Q And have you examined fabrics from time to time? A Yes sir.
- Q And woolens? A Yes sir.

MR. JOSEPH: I renew my objection.

THE COURT: Overruled.

MR. JOSEPH: Exception.

- Q Have you made xx examinations for the Fire Department as an appraiser from time to time? A Yes sir.

- Q Where do you live? A 243 East 78th Street.
- Q Goodmark talk up loud so that everybody in the place can hear you. A 1 will.

 better. How old are you, Goodmark? A Thirty-three.
- Q And how long have you been in this country?

 A Ten years.
 - Q Are you a married man? A Yes, sir.
 - Q Have you any children? A Four children.
 - Q And do you live with your wife and children? A Yes.
- Q Now Goodmark, how long have you been in your present place of business? A Nine years.
 - Q ... Where you are at present? A I was down at--
- Q I am asking you as to 74th -- 75th Street, how long have you been there? A 75th Street.
 - Q That store? A Four years.
 - Q Four years past, that you have been there?

A Yes, sir.

- Q And where were you in business before? A 144
 East 77th Street.
- Q How long were you in business there? A Four years, about.

- Q And before that? A On 77th Street.
- Q Yes. A No, that was the first place 77th Street.
- Q Now, Goodmark have you ever been arrested in your life? A Never in my life.
- Q Have you ever been convicted of any crime?

 A Never.
 - Q Never have? A No, sir.
- Q Now Goodmark, let me bring you down to the 5th of July. A Yes, sir.
- Q What time of the morning did you get to that store?

 A Quarter to eight.
- Q. When you got there was Goldner there yet?

 A. No, sir.
- A Well on the 5th of July, Monday morning it was a quarter to eight when I left my house, my wife told me, so I bring up a pound a tea. I said I will go to the store first and after I will bring up the tea. When I came down in the store I found many calls, so I called for the clothes.
- A Well, there was a couple of addresses, people throwed down by the door, there is a door. They throw down many people's addresses, so I come down to take care of them, and after they put what time they wanted, and I did my duty at the time just when I found out. I was down in the store, I could not go

at eight o'clock, people were asleep, it was a holiday, and after that it was about half past eight and a man brings in, you know, just not one man, a couple of men, bring in some clothes; I didn't notice it, the people with a store.

- Q They brought in some clothes? A Yes, sir, to press them, and about half past eight I closed up the store for a couple of minutes; I went up to 78th Street at the corner of Second Avenue. There is a tea and coffee place and I bought a pound of tea and I delivered it to my house and after that I left the tea and I went back to my store. About half past nine my wife came down in the store for the newspapers -- I am getting every day two newspapers -- one morning Journal and one Vorwarts.
- Q A Jewish newspaper? A And she came down for these papers. I asked my wife, "will you so kind as to sit here, I have got some places to go, to get orders for clothes. She said I will. I have got there mens clothes to press and clean, one ladies suit to press, and one which was on the second floor by the name of Mars, I brought another order.
 - Q. You went and got some orders? A Yes, sir.
 - Q And you brought them back to your store? A Yes str.
- Q What time did you get back to your store? A Near ten o'clock.
 - Q And what did you do from then on? A After that my wife left the store, I did that work; I had a little repair first; after that I cleaned out clothes and hung up, got dry,

and after I pressed them up --

285

- Q Did you clean those clothes with benzene? A Yes sir.
- Q Now, Mr. Goodmark, just describe your store, your store is about sixteen feet deep and about thirteen feet wide?

 A Yes, sir.
- Q And the store, the front part of the store is divided with a partition? A Yes, sir.
 - Q A glass partition? A Yes, sir.
- Q And you have got a glass partition in the show window?

 A Yes, sir.
 - Q And you have got a sign?

MR. WELLER: I object to that as leading.

THE COURT: It is leading.

MR. WELLER: You ask him to describe the premises and you proceed to describe them yourself.

MR. JOSEPH: You don't like this leading when it is against you.

THE COURT: Will you ask him another question?
BY MR. JOSEPH:

- Q Describe this sign in that window? A Yes sir.
- Q Where it says, "price list", is that the sign?

 A Yes. Right in the window just as you go up. Third Avenue;

 it is right in the side; it is so big and so high (indicating)

 right from the partition of the window.
 - Q Then on the wall nearest Lexington Avenue, describe what you had there? A What do you mean?

2

- Q Tell us what that wall was like? A A dead wall, what do you mean.
- Q What did you have on the wall? A On the wall, that is in the side I had two big lines, wooden poles, they are fixed up as long as I was in the store and those lines go down, I can use nearly two hundred suits, hang them out on them.
- Q Now Mr. Goodmark, this show case, these fixtures, you described them, how long have they been in your store?

 A These fixtures?
- Q Yes. A Well, in the beginning when I opened that store there was a store, no tailor in that store.
- Q I said how long have they been there? A Just when I opened that store, only a pressing machine, I bought, that is just one year.
- Q But these fixtures as you have described have been there about four years? A Yes, sir, four years.
- Q Now your wife went away about ten in the morning?

 A Ten in the morning.
- Q And what did you do after that? A Well, I was working; I had my work; what I have to deliver to the customers.
 - Q And did you do some work? A Certainly.
 - Q Cleaning and repairing? A Yes, sir.
- A Harry Goldner, it was half past eleven. There was a man by the name of Levy, he came down and he asked me for a couple.

of samples, so I gave it to him. I answered that man, I was very busy, because my man don't show up to work just at the time I was talking to Mr. Levy the man came down and Sam Levy left the store and said he would be down a little later.

- Q Now how long did Harry Goldner remain there?

 A About half an hour.
 - Q And did he do any work? A No, sir.
- Q Did you have some words with Harry Goldner?

 A Well I did the work -- if I work for myself I can do
 the work in two hours, but it would take him two or three
 hours to do; I have to show him everything.
- Q Did you have a quarrel with Harry Goldner for not coming in on time? A Certainly I told him, "what for he don't come down in the morning?"
- Q Now you owed Harry Goldner some wages, salary, how much did you owe him? A \$3.75.
- Did you tell him, Harry Goldner, why you could not pay him, on the Monday? A I generally pay him Sunday evening before he leaves to go home on that day he disappointed me and I told him to come down to work; he disappointed me and I should write him to come down the other morning; I told him I could not pay. Now I told him I would pay him the other morning.
- Q You wan ted him to come to work shrely on Tuesday so you held his salary up? A Yes, sir.

Q Did you say anything about going to Asbury Park?

A Yes, sir. I told him I have to leave at eight o'clock from my store.

- Q What trainwere you going to take? A Courtland Street, the nine o'clock train.
- Q And you told him to be there what time? A Seven in the morning, I have to show him what to do.
 - Q Then Harry Goldner went away? A Yes, sir.
- Q Did you give Harry Goldner anything to get fixed for you? A Yes, sir, to have my scissors sharpened, to bring them back, I need those scissors.
 - Q Then Harry Goldner went out of the store? A Yes sir.
- Q And how long were you in that store that day?

 A When Harry Goldner left that was half past one.

 BY MR. WELLER:
- Q What time did he leave? A Half past one.
 BY MR. JOSEPH:
 - Q. You went to lunch and went home? A Yes, sir,
- Q And then you came back what time? A I could not state exactly, I took thirty or twenty-five minutes; I was busy doing work.
- Q You came back about two o'clock? A About that time.

BY MR. WELLER:

Q What time? A I took twenty-five or thirty minutes.

- You came back around two o'clock? A yes sir.
- Q Did your wife come with you? A My wife came back at half past two, she brought back my boy's clothes, so I fixed them up before I left for Asbury Park, so I attended to that work, tod ress up the children so the clothes would not be spoiled.
- Q So you fixed up the children's clothes? A I had work-- pardon me -- for customers, after four o'clock I fixed many clothes and my children's clothes.
- Q What time did your wife go away? A She leaves four o'clock.
- Q Your childrens suits was still in the place?

 A Yes, sir.
- Q And your childrens suits were part of the clothes which were burned? A Yes, sir.
- Q. And when you said boys' pants those were your own childrens' clothes which were burned in the fire? A. Yes, sir, mine own children.
- Q Now did you see Mr. Meany that afternoon?

 A Meany was down in the same time my wife was.
- Q What happened while Mr. Meany was there? A While Meany was there the boys bothered me, and took some fire crackers put a match to them and threw them in my place and nearly burned his eye.

Q They were playing with fire crackers?that day?

A Yes, sir.

Q What did Meany do? A Meany, it struck in his hand.

He said, "come out and help me". I go and catch some boys

and get them arrested. I said, "I have not time to bother

with the boys, I have to attend to my work".

- Q Well, you attended to your work and then Meany went away? A Yes, sir.
 - Q You were in the store alone? A Yes, sir.
- Q Did your sister come to see you that day?

 A Yes, sir.
- Q What time? A I cannot say, about fifteen minutes to six.
- Q Now before that was there a colored man to see you about a suit, that afternoon? A Yes, sir, there was a colored man; I don't remember his name just so exactly.
- Q He will be in court here? A Yes, sir, he came down and he had a suit of clothes bought of f me for seven dollars, He paid \$4.50, he had to pay \$2.50 more, and he says he will be down about six or half past six, so I wait for him. He wants to take his suit of clothes before I leave for Asbury Park. I said I will wait for you so you show up.
- Q You sister came at a quarter to six, and how long did she remain? A She was down there fifteen or twenty minutes.
 - What did you do with your sister? A closed up my

place and took my sister out, she says she don't know what car to take her home, she lived in Ninth Street. I showed her the car to go to Broadway so as to change at Tenth Street car to go up the East side; she lives at 626 East Ninth Street.

- Q You put her on the car, did you? A Yes, sir.
- Q At that time did you have any bundle with you?

 A No, sir.
- Q Where was the bundle? A The bundle was right on the front table.
 - Q All packed up? A Yes, sir.
 - Q Already to go to Asbury Park the next day? A Yes sir.
- Now what happened next? A I was standing on the corner, I could not say exactly how many times they took, I seen Mrs. Blank, she was running; she seen me coming behind, my back. She said, "Mr. Goodmark, run quick there is a fire in the house; I am going down in the basement, you go to the store, you will see what place the fire is coming from". I ran up to my place; I opened my place and seen a fire in my place, smoke in the place; I ran right in; I was trying to stop that smoking; I seen it impossible to stop that smoke and I grabbed that bundle and I went out. When I went out a bundle of boys fell down on me; they grabbed me. They said, "Here, you did that fire".
- Q After you grabbed your bundle out, where did you go?

 A I went out just in the street.
 - Q Where did you take that bundle? A I took that

bundle right up to the saloon.

- Q . That was after the fire had already taken place and you had opened thedoor that the boys were yelling "chase him boys"? A The boys started to hold me up on the neck.
- And that is where they started in to chase you? Yes, sir.
- After you put the bundle in the liquor store, what did you do? A I told the man, "mind my bundle". He said he could not be responsible, that is a liquor store, maybe some one come around and take it away. I was studying, maybe. about a plan and the firemen came and they jumped in and chased everybody away; there was many police, I could not do anything; I went out to the liquor store and took that bundle; I was trying to go home, telling my wife sometime I was thinking over why should I go and tell my wife for she will get very excited.
- Now take your time? A (Continued) And I went out to Mr. Gordon's. I told Mr. Gordon, "will you be so kind to take care of my bundle". He had a couple of customers in the store; he could not talk to me. He said, "All right, leave it". I went back to the store. The crowd was very big; and Iwas standing there, I could not come out; Iwas standing there fifteen minutes; I went back to Mr. Gordon; I told Mr. Gordon shall he give me, or what shall I do; He told me, "leave that bindle; don't go home and tell your wife;

to watch your own property. And after the firemen get through you will watch it. I listened to the man and I went up to the store and was standing down near a stoop. After that the fire marshal came out and said Goodnark, here. That took me about half an hour. I said, "Come right in". When I went in a couple of boys started to go in, they was asked me, what do you know about it -- what do I know about it.

- Now then you were taken to fire headquarters, that night? A After they took me down in the store and they just held me for half a minutes, for a few minutes. They said, "Here, you Goodmark, "they said, come to fire headquarters."
 - Q. You went to fire headquarters? A Yes, sir.
 - Q Did you see Detective McCafferty there? A Yes sir.
- Q Did you tell McCafferty you owed any money for gas?

 A I didn't tell him; I owed for gas; he didn't ask me that question at the same time.
- Q You afterwards told him about the gas. What did
 McCafferty say to you? A McCafferty took me; he held of mine
 hands, he stepped on my leg. He said, "You son-of-a-bitch,
 why don't you tell the truth now?" He gave me a smash in my
 face, he gave me a smash on my hat; he didn't give me a chance.

 I want to lay down my hands just on the ground and he didn't
 give me a chance; he held up my hands.

THE COURT: We will take a recess now. Gentlemen

of the Jury you are admonished not to converse among yourselves on any subject connected with this trial nor form or express any opinion thereon until the case is finally submitted to you.

The Court will take arecess until half past one.

Whereupon at one o'clock an adjournment was taken
until 1:30 P. M.

Q Now, Mr. Goodmark, the stock of goods both of yours and customers varies at different times of the year? A Yes, sir.

Q Sometimes you have more goods and sometimes less goods; that is right, isn't it? A Yes, sir.

Q That is sometimes when you were/busy in the Winter time the customers had more goods there than they do around the Summer time? A Yes, sir.

Q Now, Mr. Goodmark, when did you buy benzine for the last time before the fire? A Well, there was Tuesday afternoon.

Q On Tuesda afternoon? A Tuesday afternoon.

Q And what did you do? A On Tuesday afternoon I was a little busy; I have to attend to customers; he give me some work for a certain man; I promised him to deliver it.

- Q What did you do? A I had a colored man working for me.
- Q What is his name? A John Harris. I was very busy and I told that man would he so kindly bring me in a frw half a gallon of benzine. He says: "All right; I will do that."

Q Now, when you bought that benzine, Goldner was also in the store? A Yes, sir.

Q And you got the benzine? A Yes, sir.

Q He got it from the paint store? A Yes, sir, I always buy it in the paint store.

Q Now, will you just explain to the jury how you clean

clothes with benzine? A Well, in the time a man brings in his suit of clothes and it is a little spotted; it is not necessary to have them dry-cleaned; people don't want to spend so much; so they say: "Take out my spots from the clothes, and there is many spots on the pants. I take it just; I clean it; I have a little plate and I have a brush, and I clean with that brush, put a little benzine in that plate, and after taking that brush clean it out. If the cloth is very soft or thin I could not use any brush to that. I take a rag and put on the benzine and clean it out.

- Q And you rub the spot out with the benzine? A Yes, sir.
- Q Now, you say you pour it in a little saucer? A No, a little plate, a tin plate as high, like that, always generally have a covering to that, too.
- Q Now, what do you do with the benzine after you use it?

 A Well, if it is used out for that clothes, that is dark

 clothes and we take the dead ones in and put it in another

 bottle.
- Q What other bottle? A Them bottles I always used them (indicating some milk bottles); I take a little benzine for light clothes; I see the benzine is clean enough so I shall clean it for light clothes.
- Q What do you mean you pour benzine in the bottle? A I put a little benzine in the bottle; if the benzine is not clean it stops up the dirt on the bottom.

- Q Then you pour off the clean benzine and use it? A Yes.
- Q And that is what you used in these bottles? A Yes, sir.
- Q Did you use this bottle for benzine? A Yes, sir.
- Q These two bottles you used for benzine? A Yes, sir.
- Q This bottle you used for what? A I have no water closet to my store. I have a little boy nearly seven years old. He comes down in the store and I don't want him to go down in the street to make water I don't want my little children in the street to do that and that boy comes down in the store and he takes the bottle out and makes water in it instead of in the street, and after he does that we wash it out.
 - Q And this is what this particular bottle was used for?
 - A Yes, sir.
 - Q And that bottle never was used for benzine at all? A No.
 - Q And that accounts for the odor in this particular bottle, the smell of that bottle?

MR. WELLER: I object to that.

THE COURT: Objection sustained.

Q Now, what do you do with all the clippings of cloth that
you get? A Them clippings of cloth I am always saving up
from one year to the other and after that it comes January and a
man comes down and I sell them smooth clippings; I turn from
the samples many times I do.

And them boxes lie down
near the end of the cutting table and I push them little clippings

into the boxes and it fills up them boxes. I save up thirty sometimes thirty-five that brings me in six dollars a year; the bigger clippings I sell to cap-makers, the smallerclippings go to be worked into wool again.

Q That is, you sell out to people who buy woolen clippings or rags? A Yes, sir.

Q And that is, you get a certain amount of money for them?

A If they are clean enough I get fifteen cents a pound and the bigger clippings I get twenty-five cents a pound.

Q. That is the reason you save them for the purpose of putting them away? A Yes, sir.

Q Now, Mr. Goodmark, that wooden box, how long have you had that wooden box? A I can say nearly about three and a half years.

Q And that other box, that gray box? A That gray box comes with the samples of the company that sends me them down. I always save that box to keep them clippings in.

Q How long have you had that gray box? A That gray box is marked inside from what year I had it; it is inside the box what year that come.

- Q This is from the fall season of 1913 and 1914? A Yes, sir.
- Q Then you hadit about a year? A Yes, sir; I sewed it up in the sides to keep those clippings especially.
- Q You sewed that on this side (indicating)? A No; on the corners.

- Q You sewed it up yourself to put those clippings in it? A Yes, sir.
 - Q And you had this box since the fall of 1913? A Yes, sir.
 - Q Close on two years? A Yes.sir.
- Q How long did you have this box? A I don't remember; I think last season (referring to pasteboard box) just what they send me.
 - Q That is Spring samples on the side? A Yes, sir.
- Q Mr. Goodmark, how long did you keep it in the corner just as it is now? A How long I am around in that store; I always keep a box and I always keep them boxes like that.
- Q Now, Mr. Goodmark, the arrangements where these boxes are fixed there, was that done a short time before the fire? A No, sir.
- Q How long has it been laying just that way? A It always stands just like that.
- Q You don't know how long it stayed like that? A No; I could not say.
- Q You say your children's clothing wasin the store that was burned? A Yes, sir.
- Q And this skirt, whose skirt is that? A That is my wife's skirt.
- Q And also your wife's skirt in the place? A That was dry-cleaned - there was a mark there that comes back from the dry-cleaner's, 17203.

Q That had just come back from the dry-cleaner's where you had that cleaned just prior to your going away? A Yes, sir.

Q And she had never worn it since it was dry cleaned? A It was still in the store.

Q Now, when you left the store how did you fix the windows in the back of the store? A The windows closed up.

Q And the transom was closed also? A I cannot remember that; I generally lift up the transom every night; I don't remember whether it was closed or not.

Q You closed the windows in the rear? A I closed the windows in the back. The cats sometimes come in and I don't want them to make dirt and for that I closed them.

Q Now, Mr. Goodmark, you say you had made arrangements to go to Asbury Park on that Tuesday? A Yes, sir.

Q And did you tell John Harris, the colored man to meet you there on Tuesday? A Yes, sir.

Q Now, this policy insurance on your house - A Yes, sir.

Q That was found in the brown suit. Did you know that was in the pocket at the time? A No, I did not know it. I didn't have that suit from March up.

Q And you didn't know it was in the pocket or not - you didn't know it was in the pocket or not? A No, sir.

Q Did you purposely put it in the pocket to take it out? A No. Just when the man who delivered methe insurance policy he bring it in and just as I was in a hurry to go away I paid him for the policy and I put it in my pocket and I wanted to

wait on a customer and that man brings me policies for the last nine years.

Q And you put it in that coat and when you took it out and picked that coat out - A No, I didn't notice it - what for shall I notice? I have no one who will steal that from my pocket.

Q Now, Mr. Goodmark, after you locked the door did you see Joseph Connolly? A No.

Q Did Joseph Connolly follow you when you went away from the store and say, "Come back, your store is on fire "M A No.

Q Did Joseph Connolly grab you by the shoulder at or about the Seventy-fifth street and Lexington avenue and force you back? A No, sir.

Q Did you speak to Joseph Connolly that day? A No, I did not speak to anybody.

Q Did you speak to Joseph Connolly on that day? A No, sir.

Q These boys have been troubling you off and on? A No; I went out to get a telephone to the corner of Third avenue and they followed me, they stand by the blacksmith and they followed up, a bunch, just about fifteen, they started to throw stones, they broke my own hat.

Q That was April Fool's Day, the first of April.

MR. WELLER: I object to what happened on the first of April. I suppose we all have tricks played on us on that day.

THE COURT: Sustained.

THE COURT: Never mind that. We have got that.

- Q Now, Goodmark, I want you to be careful with this answer: Did you at any time, directly or indirectly do anything towards making a fire in that store? A No.sir, never had this in my mind to burn things.
 - Q Did you do anything towards making that fire? A No, sir.
 - Q Do you know how that fire occurred? A What do you say?
- Q Do you know how that fire occurred? A I don't know myself how it came. I am not a man who do that. I always attend my business; everybody knows - I have four children and I am strictly living in a house three and a half years; I paid my rent and I can prove it by my landlord where I live, all places; where I lived no one can say a word about me; I don't touch even a cat in the street; you can go around Seventy-eighth street to Seventy-fourth street and everybody knows me and see there what kind of a man I am.

CROSS-EXAMINATION BY MR. WELLER:

- Q Well, Goodmark, you have not been doing very much business in Seventy-fifth street? A I always did business in Seventy-fifth street.
- Q. Your business was not very good in the month of June? No, I didn't have bad business.
 - Q Good business in the month of June? A Always good

business.

- Q In themanth of June you did a good business? A Yes, sir.
- Q Well, you went down and borrowed \$125. on your life insurance policy in the month of June, the 22nd of June you borrowed \$125. on your life insurance policy? A Yes, I borrowed that.
- Q And you did that to help to start to work down in Asbury Park, didn't you? A Yes, sir.
- Q In spite of the business being good you went and drew on your life insurance, did you, yes or no? A Well, my business -
- Q You drew on your life insurance? A I drew on my life insurance but my business was not bad, business always good.
- Q On the day that the fire happened you sent Harry Goldner away becausebusiness was bad? A No, sir, I didn't send him away against that.
- Q Did you send him home about two o'clock because there was nothing to do, yes or no? A No, sir, I had a lot of work to do, he could not do any pressing.
- Q Didn't you tell him there was nothing more to do and he could go home and come back tomorow morning? A I didn't tell him for that to go away. I told him I wish he would come down in the morning at seven o'clock.

THE COURT: You have answered the question.

- A (Continued) I made an appointment with him; I have to go away.
- Q Keep quiet? A I have to go away.

Q You are not in the habit of closing your store at two o'd ock in the afternoon? A I had a lot of work to do.

Q You opened your shop at a quarter to seven or a quarter to eight in the morning? A Yes, sir.

- Q And what time do you close at night? A generally I close at nine.
- Q Nine, ten or eleven? A Never eleven o'clock at night except if I am too busy I work all night.
 - Q You paid a man nine dollars a week? A I keep two men.
- Q Who is the other man that was working for you during the month of June? A John Harris.
- Q was Harris working for you in the month of June? A Yes, sir, always come down in the afternoon and do pressings.
 - Q What? A Hand-pressings.
 - Q By piece work or by the week? A He used to work by the week.
 - Q How much did you give him a week? A He used to get nine dollars.
 - Q Harry Goldner who worked from Quarter to eight in the morning until ten o'clock at night he worked all day along from seven in the morning? A He only got -
 - Q Nine dollars a week? A He is not working; he never did my work.
 - Q Did he get nine dollars a week? A Yes, sir.
 - Q And he is atailor, is he not? A He is not -

- Q Is he a tailor, yes or no? A He is only a helper.
- 305
- Q Did not you do the pressing and he do the tailoring? A I do the -
- Q Did not you do the pressing and he do the tailoring?

 Yes or no?

 Answer the question: I don't want a speech every time I ask a question.

 A At the time when the other man -
- Q yes or no. Don't go into any other subject didn't he do the tailoring and you do the pressing? A You see you have to give me a chance to talk too.
- Q Is not that true? A Give me a chance and I will talk to everybody.
 - Q Answer the question, sir? A I cannot answer the question
- Q Didn't Harry Goldner do the tailoring and you do the pressing? A I would like to answer -

MR. WELLER: I ask your Honor to direct the witness to answer the question.

THE COURT: If you are able to answer the question answer it.

THE WITNESS: I am able to answer the question.

am doing ressing many times myself and many times that man
is working for me, John Harris, for I can say how long he
works in that store.

MR. WELLER: I move to strike out the answer as not responsive.

(Question read by stenographer).

THE WITNESS: I am not a general presser I am doing cutting and generally I am making a coat myself, too.

- Q Is not Harry Goldner your tailor, yes or no? A He is not a full tailor; he is only a helper.
- Q Does not he do your tailer work and you do the pressing work on the machine? A $_{\rm He}$ is not a full tailor.

MR. JOSEPH: He said he is a helper.

BY THE COURT:

- Q Mr. Goodmark, do you do any tailoring yourself, that is the cutting out of garments, do you do that yourself? A Yes.
 - Q Do you? A Yes, sir.
 - Q You do sewing on garments yourself? A Yes, sir.
- Q What kind of work did the other man do? A If I cut out the garment he takes and makes me the basting. After that I am taking it and I just straighten it out I baste it on the top; he sews up the top of the garment; I am pressing it after I sew it up he basts it I give it to him so he bastes it out again, and if the garment is nearly finished, he sews up the lining; he makes a pair of sleeves, he sews up the collar, and makes the button holes.

- Q Well, isn't he a tailor? A He is not a full tailor.
- Q Now, you say that you did some cleaning in the place? A Yes sir.
- . Q You took a rag and benzene and cleaned up the clothes? A Yes sir.
- Q And do you always use the same rag, or do you use different rags? A One rag when it gets missing I take another rag.
- @ How many rags did you have on the 5th of July which you used with benzene on? A I could not tell you; I never noticed it.
- Q Did you have one; two or a dozen? A I could not say how many.
- Q A hundred, a thousand, how many? A Well, I could not say how many. If one rap is missing, I take another; if the other is missing I take another rag.
- Q Did you throw the rags with gasolene on them in that wooden box here? A Yes sir.
 - Q You threw the gasolene rags in that wooden box?
- A It is not gasolene; it is cleaned out, the rags is dry.
- Q What is that? A I threw it away.
- Q And these rags you usedfor xxxxxxxxx cleaning? A These are: rags from the dirt.
 - Q Yes or no. A Rixx Yes sir.
- Q And a piece of rag like this you put benzene on for the purpose of cleaning? A Yes sir, not for the purpose of cleaninglet me applement.

Q For what purpose? A At the time I have a pair of pants to clean and the pants is spotted down here (indicating). I don't want the spot to so over on the other side; I am taking that rag pushed in, and cleaning out, and after I take out the rag and put it away --

- Q So all these rags you have had benzene on? A Yes sir.
- Q And then you put all these rags in that box? A Yes sir, I always threw them in that box.
- Q And if those rags were all wet with benzene on the evening of your fire, or the morning after your fire, that was
 because you had usedthose rags to clean clothes, wasn't it?

MR. JOSEPH: I object. It assumes a state of facts not in evidence.

MR. WELLER: Pardon me, "saturated with benzene" are the words.

THE COURT: Read the question.

(Question read by stenographer).

THE WITNESS: Yes sir.

- Q This white skirt was in this box, the box was in like this, the white skirt in the box, did you put any gasolene or benzene on that white skirt? A No sir.
- Q Now, the rags that were in this box here, did you put any gasolene or benzene on those rags? A Well, I didn't put it on; I am taking out some rags, have to use it for cleaning.
- Q Now, pick out the rags that you put gasolene on. A Pardon me, I don't know; I could not tell, I could not remember so many

Q Well, you say that every rag that has been in this box here is a ray on which you have put either gasolene or benzene? A Not every rag, just generally; I am taking different rags and using, and put them in a box.

Q Don't you usually use some white linen when you are cleaning? A That is not linen, that is silk.

Q Don't you use a white cloth to clean them? A Just according to what kind of cleaing, if I got dry rags -

Q Don't you usually use a piece of rag which is half way clean, at least a white rag, without color in it? A I cannot use white rags on things like that except if I got white clothes.

Q You use the white rags to clean clothes 8 A If I have white rags -

Q Do you use dirty rags to do cleaning with? A I am generally using rags -

Q Do you use dirty rags for cleaning? A I cannot use dirty rags. If the rags were dirty I never use them for cleaning.

Q Now, on the 5th day of July how many suits of men's clothing did you have in your tailor store? A Well, I could not say; I never counted them over.

Q Do you keep any books? A I am keeping -

o Do you keep any books? A I keep a book not with my clothes.

Q Do you keep any books that shows any suits of clothes that you got or number of suits that you clean and press? A

No, I don't.

Q Do you keep any books showing how much stock you have on hand in your premises from time to time? A No, sir; I never keep books on that; I am not got the time.

Q Now, you want me to understand and the jury to understand that every rag that is that box, wooden box and every rag that is in that other tall box was a rag used by you for cleaning?

MR. JOSEPH: I object to that; he never so testified.

Q Well, you understand that - I will amend that question:

Do you want us to understand that those rags were used by you

for cleaning? A Many used and many not.

Q Now, how many suits of clothes did you clean on the morning of July 5th? A Well, I cannot say - you know I got about six or eight.

- Q Six or eight? A Yes, sir.
- Q Now who were the people, give me the names of people to whom these six or eight suits belonged? A Two suits I had from 103 East Seventy-fifth street.
- Q 103 East Seventy-fifth street, that is next door to where you live? A No, sir, that is an apartment near Park avenue.
 - Q What is the name? A Muhrs.
- Q That is two suits? A And I had another suit No. 40 East Eightieth street by the name of Smith.
 - Q What floor? A Well, that is a private building, they

lived by themselves.

Q What is that? A It is a building where they lived by themselves.

- Q They live in the whole house? A Yes, sir.
- Q Now, you have given us the names of the owners of three of the suits? A Yes, sir.
- Q Now, what other suits did you have there that day? A There was a couple of suits came in the street people I could not notice them; they come in, bring them in; I didn't notice the names.
- Q How many suits of clothes all told did you have in that day, the day of the fire? A Eight suits from customers.
- Q Now, how many women's suits if any? A The number of suits in that day are taken in all together?
- Q How many suits did you have in that day? On the day of the fire how many suits did you have in that store? A Of my own?

BY THE COURT:

- Q At the time the fire began to burn how many men's suits were there inside of your shop? A I had a lot of stock; I had a big stock -
- BY MR. WELLER:
 Q How many suits did you have? A Well, I didn't count them
 over; I had suits that belonged to many people; I had my own
 stock I generally general
 - Q How many suits did you have in that day? A Two ladies!

suits.

Q And six or seven men's suits; that is right; what you said before.

MR. JOSEPH: You didn't ask him, Mr. Weller.

MR. WELLER: I object, if your Honor please, to interruptions. I cannot get this witness to answer my questions

- Q Now, how many men's suits did you have in those premises
- that day? A What? Of mine own? or customers?
- Q How many of your customers' suits did you have that day? A Well, customers I would say over 8 or about 6.
 - Q How many? A About eight.
- Q Now, how many of your own? A I had a big stock of clothes which was hanging on the line.
 - Q How many suits did you have in those premises that day?

 THE COURT: Of your own?

THE WITNESS: I could not say, over a hundred.

- Q A hundred suits of clothes? A Yes,sir.
- Q Where did you get those hundred suits of clothes? A I generally buy them in auction.
- Q What auction did you buy in clothes in the month of June have you any bills? A I have.
 - Q Have you any bills? A No, sir.
- Q Have you anything in writing to show you had a hundred suits of clothes? A The man that worked for me -
- Q Have you anything in writing to show that you got one hundred suits of clothes at that time?

- A I didn't save the bills.
- Q. Any bills of any kind, any book? A I have got a book I took orders from customers.
- Q Does the book show you got a hundred suits of clothes of the day of the fire? A The man that works for me he knows.
 - Q Does the book show? A No.
 - Q Where is the book? A The Marshal took it away, the book.
- Q Describe the book; what does it look like? A The book as large as this style (indicating).
- Q About 10 inches long and 8 inches wide? A I could not say how many.
 - Q You say the Fire Marshal got the book? A Yes, sir.
 - Q Where did they take it to from? A Out of the store.
 - Q Where? A I do not know.
- Q That book does not show the purchase of a hundred suits by you? A No; in that book I never put them down. I carry new clothes for sale and I carry clothes slightly used for sabe.
- Q Where did you get those hundred suits? A A lot of clothes was hanging on the line and a lot on the shairs.
- Q You take this photograph of this room and show me where the hundred suits of clothes hung in that room; where did you hang them, on the easterly wall? A On the side where the fire was.
 - Q On the westerly wall? A Yes, sir.

 MR. JOSEPH: I must object. The wall is photographed

and there is a picture of it. There is only one-third of the wall shown on the photograph.

MR. WELLER:

Your Honor, interruptions of this

kind are not only highly unprofessional and they deserve to the condemnation

1-receive x severe xanaxistian of the Court.

THE COURT: Now, except you take objection -.

- Q Do I understand you to say, sir, that you had one hundred suits of clothes on the westerly wall, a part of which is indicated by People's Exhibit 9, that photograph? A I could not understand much of that photograph; I know on the westerly walls I had two big lines, a lot of clothes and a lot laid down on the chairs.
- Q Now, I want to show you People's Exhibit 6, the easterly wall and I ask you if you have not got a number of clippings on those tables look at it? Are there not clippings all over that tables and shelves? A Well, there was clippings laid down on the shelf.
- Q Now, the clippings you put on the shelf you didn't put in the book? A Well, a lot of clippings I have to use; generally I need them for patching; I have them down on the shelf.
- Q Did you put gasoline on those clippings which you left around in the shelves? A No gasoline on them.
- Q The only ones that has gasoline on were the ones in the box
 A I used them for cleaning.
 - Q They were the onlyones that had gasoline on? A Yes.

Q Now, the clippings you have on the shelf here, all these rags and clippings, did any of those have gasoline on? A No, sir.

Q Did you use any of those in cleaning? A Sometimes I took off a piece to clean with.

Q Now, Mr. Goodmark, as a matter of fact, is it not a fact that you had a table there in which there was a drawer? A Yes.

Q And that you kept your clean rags in that table? A No, I never kept them there.

- Q Didn't you keep clean rags in the drawer of that table?
- A No, sir.
- Q You are sure? A Yes, sir.
- Q Were they not the only rags that you used with benzine and gasoline? A What?
- Q The ones in the drawers of the table? A No, sir; I have clippings laid down all over.
 - Q Isn't that the table where you kept your clean rags?
 - A Well, that is the table. You know I have -
- Q Didn't you keep your clean rags in that drawer as a matter of fact? A No, never.
 - Q What did you use that for? A To cover canvas.
 - Q Did you ever use that as a cleaning rag? A No, sir.
- Q How came that to have gasoline on the day of the fire (referring to cheesecloth)? A Well, I do not know.
 - Q. Now, this man Harris is a colored man? A Yes, sir.
 - Q And he used to work for you? A Yes, sir.
 - Q And he is apresser? A Yes, sir.

Q Belonging to the Pressers' Union? A No, he don't belong to no union.

MR. JOSEPH: I object to that.

- Q And what hours did he used to come to work? A Generally about half past one, one o'clock, and he used to work until six.
- Q And you paid him nine dollars a week for that? A He generally got nine dollars a week and if he worked only half a day he got paid for only a half a day.
- Q I thought you said he got only nine dollars a week? A Yes, when he works half a week he gets paid for half a week.
 - Q Did you pay him nine dollars a week?

(At this point Mr. Joseph interrupted, the stenographer not being able to hear what he said.)

MR. WELLER: If your Honor please, we are going to carry on this case in an orderly fashion. I object to this counsel in his objection stated to this witness evidence which will give him a cue to fit the question. He has done it more than once.

MR. JOSEPH: I object on the ground already gone over; this counsel has asked a question, how do you pay and the witness answered the counsel nine dollars a week. If he will only give the man a square chance and do his duty as a district attorney and present nothing but the evidence before the Court -

THE COURT: Proceed. Yes or no to that question.

THE WITNESS: Well, I paid him nine dollars a week. If he works a half a day he gets half a day's pay. If he works a full day he gets a full day's pay.

Q Can you give this jury the beginning of one week commencing Monday, or Tuesday or Wednesday or Thursday or Friday or Saturday? A Sometimes he makes three days, some

times four days and sometimes he makes a full week. In the same week he was working a full week he left Saturday night, too, but he called to get his pay.

- Q Did you ever pay him nine dollars a week? A I paid him more than nine dollars a week.
- Q Did you ever pay him more than nine dollars a week in your life? A Many times more.
 - Q Washe working on the day this fire occurred? A No.
- Q You didn't have any work that day? A That day he did not work. I worked myself all the time; I am a presser.
 - Q Did he work that week before the fire? A Yes, sir.
 - Q Every day? A I could not say.
- Q Does your book you talk about show how much you paid your help? A What do you say?
- Q Have you got any book which shows how much you pay your help? A I neverput that down in the book.
 - Q You never put that down in the book? A No, sir.
- Q_Well, now, you say that your wife was at your store that afternoon? A Yes, sir.
 - Q That is right, isn't it? A Yes, sir.

- Q She left about what time? A About four o'clock.
- Q And then you were for a while in the store, were you not? A Yes, sir.
 - Q And you claim your sister was at the store? A Yes, sir.
- Q Was your sister known to any of the neighbors of that neighborhood? A No, sir.
- Q Is she in the habit of coming to your store, your sister?

 A She was down twice.
- Q Only twice she has been there? A She came down many times to me.
- Q What did you state "twice before"? A She came down many times.
- Q What did you say twice for a moment ago? A A long time I was in that store she was twice; I am four years in that store; she was twice already.
- Q You were not busy that afternoon, you could sit and talk to your sister? A When my sister come down I was through with my work.
 - Q Your sister left about five o'clock? A She left after six.
 - Q After six? A Yes, sir.
 - Q Now, you remember being before the Fire Marshal? A What?
- Q Now, you remember being before the Fire Marshal, don't you? A Before the Fire Marshal?
 - Q Yes. A What do you mean by that?
 - Q You remember you were taken to the Fire Marshal's office?

MR. JOSEPH: I object to any testimony taken before the Fire Marshal.

THE COURT: He is only being asked if he was taken to the Fire Marshal's office. You asked him the same question.

Q And the next morning there was an examination before the Fire Marshal? A What?

Q The next morning was not there an examination before the Fire Marshal? A Well, they got an examination all night.

Q Of July 6th. A They got an examination all night, they bothered me.

MR. JOSEPH: Your Honor, I wish to state this witness directly or indirectly waives none of his rights -

THE COURT: I am not going to hear from the mouth of this witness what he said to the Fire Marshal at the time when this witness was under oath.

MR. WELLER: Your Honor, the statute specifically sets forth that if there is any question of perjury on a material point and I seek to contradict this witness by his own testimony under oath before the Fire Marshal, it never was the intention of the statute to make the testimony before the Fire Marshal a cleak for perjury and certainly under the statute if this witness testified under oath on this trial and it varies with his testimony before the Fire Marshal on a material fact certainly he can be contradicted and held for that testimony. That might be

held in another proceeding or another tribunal. He has made a contradictory statement under oath and can be interrogated about it.

MR. JOSEPH: I object to it.

MR. WELLER: I say it is not. I don't seek to predicate an affirmative case on the testimony before the Fire Marshal. Their investigation is in itself not secret, once he having testified in open court at variance with his testimony given before the Fire Marshal then I say that the law does not clothe him with a secrecy so that that testimony may be shut up and kept from the jury and the outside world. He has taken the stand and he vouches for his credibility. He has vouched that he has told you and the jury the truth. Now, it appears, and I want to show by him that he has made a contradictory statement -

THE COURT: I am not at all sure mf your position
is entirely correct. I shall want to look up the law before
I rule upon the matter and that I will do between this and
the session tomorrow.

MR. JOSEPH: The object Mr. Weller states is not so.

The Legislature has realized for many years and I know this for a fact and there has been many attempts to make the law stronger that they know when a man is taken before a fire marshal that unfair methods are used -

THE COURT: I will look up the question.

MR. JOSEPH: And because it is not fit testimony

that can be brought out at the trial, a little suspicious of fire marshals as we are.

THE COURT: I will look up the law on that subject. I.

am not prepared to make a ruling one way or another at

present. If you have any authorities you may submit them at the same time, Mr. Joseph.

MR. JOSEPH: I think the law is very plain, particularly Judge Benedict's decision.

BY MR. WELLER:

Q Now, Goodmark, when you left the premises you wanted to go home? A No, I didn't; I was waiting for a man to take a suit out from the store; I was waiting on the corner.

- Q When you left the premises, didn't you want to go home?

 A No, sir.
- Q You remember Detective McCaffrey seeing you the next day?

 A What day?
- Q The day after your fire; didn't the detective come to see you the day after the fire? A After the fire?
 - Q Yes. A He seen me down in the headquarters.
- Q Well, he saw you the night of the fire? A Yes, sir;
 I saw him in the morning. They held me all night there.
- Q Didn't you tell Detective McCaffrey you were in headquarters all night? A Yes, sir.
- Q Didn't'you tell Detective McCaffrey/on your way home with a that that bundle of clothes at the time the fire broke out? A No.

- Q That you knew nothing about it? A No, sir.
- Q Didn't Detective McCaffrey come to your home and bring your wife down and didn't your wife say you hadn't been home?

MR. JOSEPH: I object to that. There is no such testimony on the part of McCafrey. As a matter of fact he said he didn't go to his house. If you want to read the testimony -

MR. WELLER: I cannot sit here and have the testimony challenged by somebody who really has no recollection of what the testimony is. Detective McCaffrey did go to this man's home and he was not permitted to testify as to what his wife said because of the objection by this defendant.

THE COURT: I will allow him to answer.

- Q Didn't the detective tell you your wife said you hadn't been home? A I didn't see my wife that night.
- Q Did you tell the Fire Marshal and the detective that you had gone to your home and knew nothing about this fire? "Yes", or "no", sir. A (No answer).
- Q "Yes", or "no", didn't you tell the detectives and the fire marshal that you had gone to your home and knew nothing about this fire? A I was thinking to go home and I didn't want to go home.
 - Q You were what? A Yes, that is what I told them.
 - Q Didn't you tell the detective that you had taken some

Refore the boys, before the witnesses were brought to headquarters, didn't you say that you had taken these clothes home to your wife? A No, sir.

Q And then didn't the detectives ay he had just been up to your wife's house and your wife said you hadn't been home? A I seen only the detective, he was coming down and he was there bothering me.

- Q Didn't he tell you where he had been to your wife's house? A No, sir.
- Q And your wife said you hadn't been home since that morning? A I do not know what my wife said.
- Q Didn't McCaffrey tell you /this was, what your wife said? A He told me that.
- Q And then you said, "I went up to Goldner's and I left the clothes with Harry Gordon, the man who was here yesterday?

 A Gordon?
 - Q So you lied to the detective? A I didn't lie at all.

 MR. JOSEPH: I object to that.

THE COURT: He has answered.

- Q You deliberately told him something that was not true, didn't you? A I told him the truth give me a chance. I will tell you.
 - Q You told the detective you wish had been to your home?

 MR. JOSEPH: Your Honor, the District Attorney is

 not conducting -

MR. WELLER: I submit I am conducting the case.

MR. JOSEPH: You are not used to have anybody stop you, but you are going to be stopped today.

MR. WELLER: I am used to being treated courtesly and not treated like you are treating me -

THE COURT: Let us proceed courtesly on both sides.
BY MR. WELLER:

- Q Now, as a matter of fact, you claim that Detective Mc-Caffrey beat you up and hurt you? A Certainly.
 - Q You claim he hit you on the head? A Yes, sir.
- Q And where else did he hit you? A He took me down by my hands and two sides he held me so strong -
- Q Where did he hit you? A He stepped on my leg; he gave me a smash in my face.
 - Q Did the blood come out? A No blood came out.
- Q Did the blood come on your face, yes or no? A No, no blood was coming out; I was Beeling very bad; I left a receipt there for threeemonths in the Detective Bureau. They let me down in the basement so I go to a watercloset; I was feeling so badly I could not stand on my legs.
- Q Was there any mark on your face or body that you claim Detective McCaffrey made, "Yes", or "no". A At the time Ke didn't blood me.
- Q Was there any mark at the time on your foot? A He stepped on my leg, marked I have a pair of shoes he put the tops on the front.

- Q Was there any mark on your body where he hit you? A He didn't kill me; I could not say he killed me.
- Q Was any marks on your body? A He smashed me in the face and gave me a lick on my head.
- Q You were taken to the police court next morning, were you not? A Not police court, they took me up to the Marshal's office, City Hall.
- Q You were later taken before the Judge, the Magistrate's court, taken before the Magistrate, were you not? A That was Friday.
- Q Answer my question, sir? A You don't ask me to the point. Pardon me. You don't ask me to the point the time when they took me up in the headquarters of the Fire Department.

MR. JOSEPH: Wait a moment.

- Q You were taken before the Judge sitting on the bench, the Magistrate's court? A Yes, sir.
- Q Did you make any complaint to the Judge that Detective McCaffrey who arrested you and assaulted you? A They didn't give me a chance.
 - Q Did you say anything to anybody about it? A No, sir.
- Q Did you go to a hospital or have a doctor? A I didn't have a doctor.
 - Q Well, now, your wife was brought to Headquarters, was she not? A I do not know; they put me in the closet twice.
 - Q Did you see your wife? A No, sir.
 - Q Listen; dich't you see your wife in Fire Headquarters?

- A No, sir.
- Q In the Fire Marshal's office? A No, sir.
- Q Didn't you see your wife A No, they put me in a closet; I do not know what they did there.
- Q You did go to the watercloset while you were there, yes or no, you went to the watercloset? A I was down once in a basement.
- Q And you took some matches out of your pocket and threw them down the trap? A Yes, I had some matches; I was very excited.
- Q And you threw the matches down the watercloset? A I was very excited and I had the matches and I tore the pieces off them.
- Q And the Fire Marshal went down there and dug them out with his hands? A I do not know.
- Q He showed them to you? A I throwed them around on the floor.
 - Q You say you threw them on the floor? A Yes, sir.
- Q Didn't you throw them down the toilet? 'A I didn't throw them in the watercloset; I threw them in all the places.
 - Q Then you pulled the chain? A I didn't pull no chain. boys
- Q Now, the pixexx when you left your place that night told you that your place was on fire? A I didn't see any boys, no boys told me.
- Q Didn't the boys call to you that your place was on fire and call to you to come back? A No, sir.

Q Didn't the boys grab you by the arm and bring you back there? A They grabbed me by the arms, when I opened the store and when I ran out from the store when the fire was there already.

Q The boys grabbed you? A I do not know what boys grabbed me; they were on me like flies.

(Last four questions and answers read by the stenographer, at the direction of the Court.)

MR. JOSEPH: That was after the fire.

MR. WELLER: I must object to the manner of comment.

It is not only improper but untrue.

THE COURT: We will have no comment. Mr

MR. JOSEPH: I am willing to stake my reputation for telling the truth against Mr. Weller's and I feel sure I would not come out very much the worse.

THE COURT: Proceed, gentlemen.

- Q Now, these clothes are yours, aren't they? A Yes, sir.
- Q And all these three suits, the brown suit, the blue suit now, are these new suits? A No.sir.
- Q Well, they are good suits? A Well, they are not so good, they are all faur years already.
 - Q Are these the suits you wore? A That is suits
 - Q That is, they fit you? A Why certainly.
- Q Did you have any other suits of yours there in the place?

 A There were two other suits.
 - Q That you left in the place? A Yes, sir.

-

- Q Were they as good as these or better? A Much better.
- Q So you left only good clothes in there and came out A (Interrupting) I didn't know there was going to be a fire;
 there was a black suit which I could not wear and I had one
 light suit on me.
- Q Now, you say there were firecrackers being shot off?

 A Yes, sir.
- Q You don't know that firecrackers could not be bought in the city that day? A I don't know where they got them; I know they took firecrackers and put matches to them and threw them in the store.
- Q How many did you see thrown in the store? A I could not remember how many.
- Q Were you not afraid knak the firecrackers when they came in your store? A I chased them away a couple of times.
 - Q Did you have them arrested? A I could not.
- Q Tell any police officer on the block? A I didn't have the time to look for an officer.
- Q How many boys did you chase away? A I could not remember how many. There was many of them.
 - Q How many? A I could not say how many.
- Q How many times did you chase them away? A About three times.
- Q What did the boys do with the firecrackers you say they lit a match like that? A Yes, sir.
 - Q Took a firecracker and threw it in your place? A Yes.

- Q Where did the firecrackers fall in your place? A I don't know; there was a man by the name of Meany there.
 - Q Where did the firecrackers fall down? A I didn't look.
- Q What did you do when you saw the firecrackers come sizzling in your place? A After I heard them explode -
- Q How many times did they explode in your place? A I could not say.
- Q Did they make any fire? A Once you know they stopped on a rack.
- Q What rack? A A rack which was laid on the floor and I saw that and I stopped that off from the rack.
 - Q Was Meany there at that time? A Yes, sir.
- Q He saw the firecracker explode on the rack? A Yes they caught on his eye, too he didn't see that time.
- Q How many firec ackers came inside of the door? A I do not know; I didn't count them over.
 - Q One? A I could not tell you.
 - Q Two? A I didn't count them over.
 - Q A dozen? A I didn't count them over.
- Q It didn't make such an impression on you you don't even remember? A I had my work to do. After I chased them away I went to my work.
- Q You claim this fire was caused by firecrackers? A I don't know what it was caused by.
 - Q Did anyone of the three ar faux firecrackers before

you went home? A Wany.

Q Did anyone throw a firecracker in your store before you went home? A Well, they chased down many before I left the store, the time I closed up. When they saw me outside they ran away.

- Q Did anybody throw any in just as you went out of the door? A There was a couple of them.
- Q Did you put them out? A I didn't see what place they were thrown in.
- Q How do you know if you didn't see them thrown in? A After I ran right for them.
- Q What time did you leave to go home? A Maybe five minutes after six or maybe ten minutes after six.
 - Q. Did you say you left at five o'clock? A No, sir.
- Q Did you say before the Fire Marshal you left before five o'clock?

MR. JOSEPH: I object to that.

THE COURT: Sustained.

- Q Didn't you have a clock right on your table on your shelves? A Yes, sir.
- Q What time did that clock say you went home? A About five minutes after six that I left the store to close it.
- A About twenty minutes, maybe about twentt or twenty-five. I could not say exactly.
- Q You were waiting on the cornertwenty or twenty-five

- Q You say you saw some boys throw firecrackers in your place before you went out? A Yes, sir.
- Q Did you go back there and put the firecrackers out? A I didn't see at this time any fire.
- Q Did you take any precaution to put out the firecrackers?

 A I didn't see any fire.
- Q Did you look to see if there was any fire about? A I looked; I didn't see anything.
 - Q Did you see any fire? A No, sir.
 - Q. Did you go back to see any part of the partition? A I didn't go back; my sister has to go home.
- Q It was more important to see your sister home than to find out there was a fire in the back part of the partition? A Something fell down and there just comes a fire.
 - Q Where did the firecrackers fall? A I could not say.
- Q Didn't you look when you heard the sizzling of the fireracker, didn't you go and look? A I could not look in that time.
- Q You had to take your sister home, is that the idea? A I took my sister home, I had to take my sister home; I see there is nothing something extra damaged; I closed the door and I went away.
- Q And you went home and stood on the corner for twenty or twenty-five minutes? A Yes, sir.
- Q Well, then, you saw the fire engines come? A I didn't see any fire engines.

-

Q Where were you going at this time? A I was down in the corner when I seen Mrs. Blank running. She said Mr. Goodmark, run quick there is a fire in the house. I listened to that lady.

- Q My question was where were you going; what were you standing on the corner for so long? A I was waiting for a customer.
- Q Why didn't you wait in the store? A I had closed the store.
- Q You were not afraid the boys would throw firecrackers in there while you were gone? A I was not afraid of that.
- Q Now, did you lock the transom before you went home?

 A I don't remember that.
- Q You don't know when the boys were throwing firecrackers whether or not you locked the transom? A I don't remember I generally leave it open.
- Q Don't you know that when the firemen came this transom was locked and the windows were all locked? A I don't remember that.
- Q When you went back there to open up the door for the boys did you see the transom was open or closed? A I didn't notice it; I was very much excited when I opened the door. Just as I seen it I wastrying my best to stop the fire.
- Q You knew where the fire-engine house was, down the street? A Yes, sir.
 - Q You knew the fire engine house was between Third and

Second avenue? A Yes, sir.

- Q Just one block away from you? A That is all, yes, a block and a half.
- Q It is just the other side of Third avenue? A The middle of Second avenue.
 - Q Call it a block and a half? A Call it as you wish.
- Q The fire engines were not there when you were at the fire, when you left the store? A When I opened the store I didn't see the fire engines.
- Q When you left the store you went around by Lexington avenue? A No, I was waiting just when the firemen came.
- Q. You waited for the fire engines to come? A. When they came they chased away everybody.
- Q Didn't you go in the saloon and leave a package? In when the firemen were coming I left that package in the saloon.
- Q Didn't you leave a package there before the fire engines came? A No, sir.
 - Q Didn't you go back and get the package? A No, sir.
- Q You waked up Lexington avenue to Gordon's place?

 A When the fire was through, the crowd was very big, I could not come up to that store any more.
- Q Did you stay there or go to Gordon's? A I stayed there for fifteen minutes after I went down in thesaloon I took that package, I was thinking to go home, I went down tonGordon's; I told Gordon shall he mind that package and I went to the store again.

- Q Did you inform any police officer, or fire marshal that you were the proprietor of that store, did you? A No, sir.
 - Q Then you stayed after fifteen minutes? A Yes, sir.
- Q The fire didn't last fifteen minutes, did it? The fire only lasted five minutes? A I don't know how long it took.
- Q So then after you waited there fifteen minutes you went up to Harry Gordon's place? A Yes, sir.
 - Q You walked up Lexington avenue? A Yes, sir
- Q Where does he live? A I don't know where he lives. He has a store at Seventy-seventh street.

MR. WELLER: If your Honor please, the question is

how long did the fire last.

Until

MR. JOSEPH: Sinky the fire was out. See page 55 of the minutes.

THE COURT: Proceed.

BY MR. WELLER:

- Q Now, you went up to Gordon's place? A Yes, sir.
- Q Where is Gordon's store? A Seventy-seventh street, corner of Lexington avenue.
- Q Then from Gordon's place you went back to the fire? A Yes, sir.
 - Q Then you gave yourself up to the fire marshal? A No.
 - Q Didn't you? A No.
 - Q Didn't you walk into the store and tell the fire marshal

you were the boss? A I was standing down by the stoop; there was a man by the name of Rosengarten, one by the name of Kline.

- Q Didn't you walk in and give yourself up? A I didn't have a chance. The crowd was very big.
- Q Didn't you go in and tell the fire marshal you were the boss of that premises?

MR. JOSEPH: I object to the form of the question.

THE COURT: The question pending is one the witness can answer.

THE WITNESS: No, sir.

- Q Did you tell them you were the proprietor or owner of the premises and this was your store? A No, sir, I could not come in after the fire marshal came out and said: "Goldmark" "Here, here, I said, "here, I am here. He said, "Come right in".
- Q The fire marshal invited you into your own store; is that right? A He called me in, and I went in; in the store he said is you Jacob Goodmark? I said yes.
- Q You saw Connolly? A Just as I walked in the boys started to walk in, too.
 - Q You heard what Connolly said? A He asked the boys -
- Q You heard what Connolly said, didn't you? A I heard the boys. He asked the boys, do you know anything about that fire? they said, yes, I knew it. They asked them the names and they took me right up in the automobile, come on Goodmark, sit down and come right up into the marshal's office. That was in Sixty-sixth street, the Headquarters.

Q You heard the fire marshal ask them if they knew anything about it and they said they did? A Yes, sir.

Q They said they did?

MR. JOSEPH: I object to this entire line of cross examination which is highly unfair. He will say to this man, "Didn't he do so and so", something not in the testimony and this man who is not an intelligent man, he leads him on into positions he knows does not exist.

THE COURT: Objection overruled.

Exception.

Q And didn't you hear the young man calmly say that he had seen you leave the premises while the fire was burning? A I didn't hear that question.

Q And then you were all taken up in the automobile to Fire Headquarters? A Yes, sir, Fire Headquarters.

Q Now as a matter of fact that not Mrs. Blank that first calledyour attention to the fire in your place; it was the boys, wasn't it? Mrs. Blank called your attention to it after the boys had spoken to you? A Mrs Blank she was the first, she told me of the fire in the house.

Q When the boys called your attention to it? A When I opened the store and went out the boys fell down on me.

MR. WELLER: That is all.

MR. JOSEPH: That is all.

THE WITNESS: I want one question.

MR. WELLER: I have no objection to his making any

WILLIAM DWYER, called as a witness on behalf of the defendant, first being duly sworn, testified as follows:

(I reside at 1225 Madison Avenue).

DIRECT EXAMINATION BY MR. JOSEPH:

- Q Mr. Dwyer, do you know the defendant Goodmark? A Yes sir.
- Q How long have you known him? A Since Pebruary, 1912, about three years and seven months.
- Q. You are in charge of the building in which he lives? A I am, sir.
- Q And do you know people that know him around the neighborhood?

 A Yes sir.
- Q Do you knew own the building? A Mrs. nwyer, my wife owns it.

- MR. WELLER: I make no question about his having paid his rent. There is no question. He could not have stayed there if he did not pay his rent.
 - Q What was the rent, Mr. nwyer? A \$17 for his room.
- MRS. ANNA M: DWYER, called as a witness on behalf of the defendant, first being duly sworn, testified as follows:

DIRECT EXAMINATION BY MR. JOSEPH:

Q How long have you known him? A Since February, 1912, a little over two and a half years ago:

. Q Do you know his general reputation for honesty /truth telling in the community in which he lives? A I do.

Q What is it? A I found him to be a most industrious, hard working man, thoroughly conscientious and above all very honest. and I have heard him spoken of by others with whom he has dealt for the three years anyway.

The store windows, there is a railing where the people lives upstairs in an apartment; he climbed on that railing and put it right into the little hole.

BY THE COURT:

- Q In other words, there is a step to the house? A Yes sir.
- Q Leading up to he front door and that front door is alongside of Goodmark's store, and they went up on the railing of
 that stoop and put the firecracker in a hole in the sash, in
 the plate glass window in front of Goodmark's store; is that
 what you mean? A That is correct, your Honor.

 BY MR. JOSEPH:
- Q Now, Mr. Weany, did you so out and chase the boys away?

 A I went out to advise them to go away and they paid no attention to me. He also went out and they treated him as a joke.

 BY MR. WELLER:
- Q Treated who as a joke? A Mr. Goodmark.

 - Q Speak up. We have all to hear you. This is important.

- Q Live on your children? A I do not; I have money in the bank, sir. I don't have to live with my children they don't want me to work either.
- Q. Now Your have you known Goodmark? A I have said eight months, or thereabouts.
 - Q A good friend of yours' A Not necessarily good friends.
- Q How came you to so around there to visit on the 5th of July? A The reason is I was looking around to see if I could locate myself in the store -- that was my object.
- Q You wanted to take part of the store? A No, I only went to see if it was a desirable place.
 - Q Siro A I was looking for a desirable place.
- Q And you thought Goodmark's was a desirable place? A Not . exactly, I didn't.

Q How is that A I didn't mean that his place was desirable -- no sir.

- Q You say you saw firecrackers thrown into the workmen's room about 2:30? A Somewhere in that neighborhood; I was having dinner and I took a walk out.
- . Q What part of the workmen's room did it land in? A Right in opposite the door. When I saw it come so near the lady I walked out and wanted them to go away.
- Q Did it go over the partition? A In through the doorway because there is no door in the place, I presume it was open between the shop and the work room.
 - Q Did it go off and make a noise' A I do not know, to tell

FRANCIS COOKE, called in rebuttal by the People, first being duly sworn, testified as follows:

(I reside at 155 Bast 75th Street).

BY MR. WELLER:

- Q Do you live in the same house where this tailor's shop is?

 A Y's sir.
- Q Do you remember the day of the fire on July 5th of this year, about what xime did the fire break out, do you remember, about half past eix in the evening? A I don't remember.

 .MR. JOSEPH: I object. That is very important.
- **Q** About what time, what is your best recollection? A Just about that time.
 - Q But you could not be positive? A No.

Q The point is this, at the time the fire broke out, where were you? A Upstairs.

MR. JOSEPH: I object.

BY THE COURT:

Q At the time she became aware there was a fire, where were you? A Upstairs.

MR. JOSEPH: I object on the ground as not competent rebuttal; should have been on the direct case.

THE COURT: I will receive it.

- Q Where were you at the time you knew there was a fire in the building? A In my apartment.
 - Q In what floor? A Second floor.
 - Q Two flights up? A Yes sir, in the front.

BY MR. WELLER:

- Q Front or rear? A F ont.
- Q You live with your family there? A Y's sir.
- Q And you have rooms there? A Y's sir.
- Q Sleep there? A Yes'sir.
- Q Cook and eat there? A Yes sir.

BY MR. JOSEPH:

- Q You knew Goldmark, didn't you? A Yes sr.
- Q He has a pretty good reputation in the neighborhood? A I don't know anything about it. I know he is a neighbor, but no more than that I know nothing about it.

MR. JOSEPH: I move to strike out the testimony. I don't

THE COURT: I will let it stay in. It has not done you any harm.

. MR. JOSEPH: Exception.

MR. WELLER: Your Honor, there is another witness I would like to have.

THE COURT: The probability is this case can go to the jury at an early hour tomorrow.

(Counsel held a consultation with the Court).

THE COURT: You are admonished not to converse amongst yourselves on any subject connected with this trial, form or express no opinion thereon until the same is submitted to you.

The formal notice in the Law Journal will possibly be for half-past ten tomorrow. I will ask you to be in your seats at a quarter past ten.

(Whereupon at 3:55 P.W., an adjournment was taken until A.M.
10:15/September 28, 1915)

Court met pursuant to adjournment.

Appearances same as before.

JOHN M EAN Y (recalled).

MR. WELLER: Bring in those boys.

(Joseph Connolly, Thomas Conlon and Thomas McCarthy were brought into the court room).

BY MR. WELLER:

- Q You said yesterday that you saw one of the boys? A Two.
- Q That testified here throwing fire crackers? A I have not said that I saw them throwing fire crackers, but they were in the crowd.
- Q I cannot hear you. A I did not say that I saw them throwing fire crackers. I said they were in the crowd.

MR. JOSEPH: I object to having these boys present while the witness is giving his testimony.

THE COURT: Now, they are here in the court room.

- Q Which boy did you see in the crowd that were throwing fire crackers? A Both of them.
- Q Which of them? Come down here and show us, which of the three of them? A Not the tall boy (John Connolly). I have not seen him.
- Q The large one, Joseph Connolly, you never saw him? A I never saw him.

MR. WELLER: Just step outside Connolly.

(Connolly did so).

- Q Now those two boys (indicating Conlon and McCarthy)
 Did you see them throw any fire crackers? A I had my back
 turned when that fire cracker was thrown in.
- Q Do you know their names? A I do not, sir. They were in the crowd; I did identify them.
 - Q Did you ever see these boys before? A Not until then.

 MR. WELLER: Step aside -- referring to Conlon and

 McCarthy).

BY THE COURT:

Q That is to say, you saw them for the first time when you say you saw them in a crowd, some of whom were throwing fire crackers? A Yes, sir.

BY MR. WELLER:

- Q Now, after the fifth of July when was the next time you saw them? A I never saw them until I saw them here after that.
- Q Who pointed them out to you? A It was not necessary to point them out to me. I knew them by sight, and I advised them to go away, those two boys, and they kept laughing at me.
- Q Well, you say that one of either of those boys had a lighted fire cracker? A I have not said that.
- Q Will you say they had a lighted fire cracker in their hads? A No, I would not.

MR. WELLER: That is all.

B Y MR. JOSEPH:

- Q They were in the crowd of boys? A Yes, sir.
- Q How many were in this crowd? A I could not tell you;

there was quite a bunch there.

MR. JOSEPH: That is all.

THE COURT: Now, that is the case on both sides?

MR. JOSEPH: There is a Mr. Gitterman, the butcher.

MR. WELLER: Your Honor, I am not through yet.

THE COURT: I beg your pardon.

MR. JOSEPH: May, it please the Court, if Mr.Gitterman comes a little later, I suggest that he can be put on after Mr. Weller is through. If Mr. Gitterman is not here then, of course, I will have to do without him.

MR. WHILER: You rest?

MR. JOSEPH: Yes.

JOSEPH CONNOLLY (called in rebuttal), having previously beer sworn, testifies as follows:

BY MR. WELLER:

- Q Connolly, did you have any fire crackers in your hand that day? A No, sir.
- Q You live at 75th Street and Third Avenue, you testified?

 A 74th Street and 75th Street and Third Avenue.
- Q And Mr. Gitterman, the butcher, you worked for him for how long? A About two years and nine months.
- Q And do you live there in the same place still? A Right overhead.
 - Q Right over the butcher's store? A Yes, sir.
- Q You see Mr. Gitterman every day? A See him every day now, yes, sir.

-

BY MR. JOSEPH: Q Now, Thomas -- Joe -- do you still swear that you delivered eggs to Israelson every day? A No, not every day. If I did not deliver them there, I delivered orders to other places up there.

Q How often did you deliver eggs to Israelson? A A couple of times a week.

Q Now, is it not a fact, that it was only one day a week, you did that? A Not all the time.

Q Well, usually once a week? A Sometimes.

Q And it was not every day in the week that you went to Israelson's on 95th Street? A No, sir.

Q Only about one day a week and sometimes twice a week?

A Yes, sir.

BY MR. WELLER:

Q Did you have an egg route to deliver eggs for anybody else besides Israelson? A We did not have egg routes; we had routes for turkeys each night different. If a telephone call somes in to bring a package, a hurry call, I would be sent up with it.

THE COURT: That is all.

THOMAS McCARTHY, (called in rebuttal), having previously been sworn, testifies as follows:

BY MR. WELLER:

Q How long were you playing that afternoon in 75th Street, Thomas? A About two hours.

- Q Did you have any fire crackers that day? A No, sir.
- Q Any time during the day did you have fire crackers?ANo.

Q It was pretty hard to get fire crackers in New York that day?

MR. JOSEPH: Objected to.

THE COURT: Sustained.

Q Did you know of any place that you could buy fire crackers in that neighborhood?

MR. WELLER: I object.

THE COURT: I will allow it.

BY MR. JOSEPH:

Q Did you know of a boy whose father went to a picnic the day before? A No, sir.

Q You don't know who the boy was who went to a picnic the day before? A No, sir.

Q And whose father brought home some Japanese crackers?

A No. sir.

- Q You don't know that boy? A No, sir.
- Q You are sure of that? A Yes, sir.
- Q You did not talk to anybody about this case since yesterday? A No, sir.

THOMAS CONLON (called in rebuttal) having previously been sworn, testifies as follows:

BY MR. WELLER:

Q Sit down, Thomas. That day you had a headache you testified? A yes, sir.

Q And how long were you sitting on that stoop opposite Goodmark's place? A An hour and a half.

- Q Did you have any fire crackers that day? A No, sir.
- Q Did you see any boys there have any fire crackers? A No, sir.
 - Q Was there any fire crackers in the street? A. No, sir.

BY MR. JOSEPH:

- Q Do you get headaches very often? A Sometimes.
- Q Very often? A No, sir, not very often.
- Q When you get headaches you get very bad headaches?

 A Sometimes.
- How often do you get these very bad headaches? A Once every two or three months.
- Q Is there any particular time when you get your headaches? A No, sir.
 - Q Do you know what causes those headaches? A No.

 THE COURT: That is enough on that.
- H ARRY GOLDNER, (called in rebuttal), having previously been sworn, testifies as follows:

BY MR. WELLER:

- Q Goldner, you left the store about what time on the after noon of the fifth of July? A Two o'clock.
- Q Up to that time did you hear of any fire crackers been shot off in the street? A No, sir.
- Q Did any boys throw any fire crackers in the store? A No, sir.
- Q Now, in using benzene to clean coats, what did Goodmark use? A A piece of goods

- Q Did he have one clean rag or more than one? A One.
- Q And where was that rag kept? A On the table.
- Q Did he use rags and throw them in that box (indicating) with gasoline on when you were there? A No, sir.

 BY MR. JOSEPH:
 - Q He always used one rag -
 MR. WELLER: Just a moment.

BY MR. WELLER:

- Q Do you know a tailor on that block, named Sam Levy, Solomon Levy? A Yes, sir.
- Q And had you known him before the Fifth of July? A Yes, sir.
- Q Now, on the fifth of July he came in the store that day while you were there? A No, sir.
 - Q Sir? A No, sir.
- Q Did you have any conversation with him that day? A No, sir.
- Q Did you at any time say to him that it was a holiday, and you did not want to work that day? A No, sir.

 BY MR. JOSEPH:
- Q Did he use one rag all the time for the whole three months you were there? A Not all the time. He used one rag; if that got lost he took another one.
- Q That is, if he used a dark suit, use dark rags? A Yes,

Q And if he used light clothes, he would use a light rag? A Yes, sir.

Q Because when you use a cloth with benzene the stain comes on the cloth, and that cloth is dirty? A Yes, sir.

Q And when you get another suit you get another piece of cloth? A Yes, sir.

Q That is, you only use one piece of cloth for one suit?

A Yes, sir.

Q You use a different piece of cloth for every suit?

A Yes, sir.

MR. WELLER: Do you understand?

MR. JOSEPH: You can come right at him when I am through.

MR. WELLER: All right.

MR. JOSEPH: I have never seen this witness. He has been in the House of Detention.

Q Now, you know Sam Levy, the old man, the tailor on the block? A Yes, sir, Solomon Levy.

Now, do you remember him ever having come in for a sample of goods, he had a suit to make for an undertaker, a piece of black goods that he wanted to get; you remember that?

A Yes, sir.

- Q Now, wasn't that on the fifth of July? A No, sir.
- Q When was that? A Another day; I don't remember what day.
- Q But you do remember him coming in for a piece of goods?

 A Yes, sir.
- Q Do you remember leaving the store on the fifth of July? Yes, sir.

- Q Which way did you go? A At two o'clock.
- Q which way did you go home, towards Lexington Avenue or ThirdAvenue? A Toward Third Avenue.
- Q You are sure you walked towards Third Avenue? A Yes, sir.
 - Q And Levy's store is towards Third Avenue? A Yes, sir.
- Q And didn't you see Levy on the street when you went out? A Yes, sir.
 - Q You did see Levy on the street? A Yes, sir.
- Q What did Levy say to you on the street? A He asked me if I got work.
 - Q But you had met him? A Yes, sir.
 - Q But you didn't see him in the store? A No, sir.
- Q How did he come to ask you if you had no work? A Because he seen me going home. He asked me, "No work for you?" I said, "No."
 - Q Now, you are a tailor's helper, aren't you? A Yes, sir
- Q And what you do is, if there is a button off, or a rip in the trousers, you attend to that? A I am a bushelman.
 - Q And you repair clothes? A Yes, sir.
- Q And after you do the repairing, Goodmark finishes the work? A Yes, sir.
- Q That is, he presses it and helps to take out the stains if he notices anythat you didn't take out? A Yes, sir.
 - Q That is his own job? A Yes, sir.
 - Q Your work comes first? A Yes, sir.
 - Q And then you turn it over to him? A Yes, sir.

Q And before he can do any work on any garment, you must do the work first? A Yes, sir.

Q Now, how long had you beer working for him, three months

- Q Pretty steady for those three months? A Yes, sir.
- Q You hadn't been laid off any to speak of durring those three months? A No, sir.
- Q And he kept you right up to the fifth day of July, and you were still working? A Yes, sir.

BY MR. WELLER:

Q Goldner, you have answered "Yes, sir," thirty-four times in one minute. Will you plese say what you do in the business. Just tell us what you did in the business. Then after that tell us what Goodmark did? No, go ahead. A I was the bushelman. In the tailoring --

Q Tell us what a bushelman is? I don't know at least.

A I fix old clothes, the lining I got to fix, the overcoat I fix it, and after I get through and give it to Goodmark to be pressed up, to the presser.

Q Well, you were the tailor, were you not? A Yes, sir.

MR. JOSEPH: I object. He said he was the bushelman.

There is a big difference between a bushelman and a tailor .

BY THE COURT:

Q Tell us in your own words what exactly you did? A I fix the suits.

Q A man comes to the store, and he has in his hand a suit of clothes, that is already made. Now, what do you do? A Nothing.

- Q You don't do anything? A Only if he wants them pressed out, Goodmark presses them.
 - Q You don't do any pressing? A No, sir.
- Q What kind of work do you do? Just tell me; we don't know? A Only fixing.
 - Q What kind of fixing? A Suits.
 - Q How do you fix them? What do you do? A I put in -MR. WELLER: Speak in Yiddish, if you don't understand clearly.

A (Through Mr. Fischer, one of the official interpreters). I piece the suit; I fix the lining.

MR. JOSEPH: I think it is called "patching."

A (continued) Making the pants shorter, and sometimes a coat,
making it shorter.

MR. WELLER: That is all.

BY MR. JOSEPH:

- Q What does Goodmark do? A He is a presser.
- Q And a cleaner? A Yes, sir. BY MR. WELLER:
- Q Now, Goldner, you testified -- put this to him in Yid-dish, Mr. Fischer, today you have testified, you said "yes, sir" in answer to Counsel when he asked you if for every suit Good-mark cleaned he used a separate rag; is that so or is it not so? A Yes, that is so. If it is a black suit, he has a black piece; if it is a light suit, he has a light piece of cloth.

BY THE COURT:

Q Pardon me a moment. Suppose a man comes in and has a suit cleaned, and Goodmark uses a piece of goods in cleaning that suit, and then the next day another man comes in to have another suit cleaned, and both suits are light suits, would Goodmark use the same piece in cleaning the second suit, or would he use a different piece? A If it is a different suit between the one and the other, he uses a second piece.

Q In other words, you mean to say that one piece of goods is used for one suit, is that so, and another piece for another suit? A No.

Q What do you mean? A If he cleans a black suit, he uses a black piece of cloth, and he puts that piece away on the place, on the table.

Q Now, suppose he is after cleaning a black suit, and he has another black suit to clean, will he use the piece that he used before, or will he use a different piece? A If he has the same he uses the same, and if he has not got it, he uses the the second piece.

- Q In other words, you mean that this piece -- withdrawn.
- Q About how many pieces if you know were in use in that shop, not at one time but during the time you were there? A I cannot say; I did not count them.
- Q Well, do you mean one or two, or more than that? A Three or four or five.
- Q You mean that three or four or five pieces were used during the entire time that you were there? A I told you if

it is a different suit, he uses another piece of goods.

Q You mean to say that for every suit brought in he would take a different piece from the one that he had used before?

A No, he used the same.

BY MR. WELLER:

Q Did you ever see him throw the rags that he used for cleaning purposes in that box (indicating) A (In English).

No, sir.

MR. WELLER: That is all.

BY MR. JOSEPH: .

Q What rags were put in that box? A (Through Interpreter) The same rags which were in that box, when I came to him the first time were in the box all the time.

- Q Did he ever put any other rags in there? A No.
- Q You were not very careful about those cleaning rags, to to keep them together carefully, you let them lay all over, don't you? A Yes, sir.

THE COURT: That is all.

MR. WELLER: The People rest.

THE COURT: Is that the case on both sides?

MR. WELLER: Both sides. May it please, uyour

Honor, I renew all motions made.

THE COURT: I will make the same ruling. You have an exception.

MR. WELLER: Now, I make a further motion on all of the grounds --
